



Menomonee Falls Police Department Notable Incidents for the Month of January 2022

22-000179 01-02-2022 Threats N80 W14350 Titan Dr.

A student from the Menomonee Falls High School made threats of violence via social media. The school was put on a brief lock-down until the suspect was located and arrested at his residence. A request for felony charges were forwarded to the district attorney's office.

22-000419 01-05-2022 DV Disorderly Conduct W136 N7000 Block Claas Rd.

Officers responded to a domestic violence incident in which the male suspect, who was intoxicated, grabbed and pushed the female victim causing her pain and to fear for her safety. The male suspect was arrested and booked on disorderly conduct charges.

22-000515 01-06-2022 Fleeing/Eluding 124th St and Bradley Rd.

An officer stopped a vehicle that was not displaying any registration plates. As the officer approached the vehicle it sped away. A short pursuit was initiated, but terminated after .8 miles due to the heavy traffic and the recklessness of the suspect driver. The driver was not identified and the vehicle was not located. This case remains inactive.

22-00618 01-07-2022 Retail Theft N94 W18375 Thunder Ridge Rd.

Officers were sent to investigate a retail theft from the Home Depot. The investigation revealed that the suspect, while using a fake ID, would remove tools from the sales floor and then attempt to return the items for cash. After a thorough investigation, multiple incidents were tied to this same suspect. The suspect was positively identified and a warrant request for multiple charges was forwarded to the district attorney's office for review.

22-000651/654 01-07-2022 DV/DC, Bail Jumping N88 W15000 Block Menomonee Ave.

Officers responded to a domestic violence incident where it was learned the female suspect struck the male victim in the face causing him pain. The female was arrested for disorderly conduct-domestic violence related. The male subject was found to be intoxicated in violation of his current bail conditions requiring absolute sobriety for a pending felony drug case. The male subject was arrested for felony bail jumping. The female suspect was booked, posted bond and released. The male suspect was turned over to the county jail.

22-000659/661 01-07-2022 DV Battery N88 W16697 Appleton Ave.

Officers responded to a domestic violence incident at Sal's Pub and Grill where witnesses reported that a male suspect grabbed his girlfriend off a bar stool and then slapped her in the face. The male suspect was escorted out of the bar by staff/patrons and gestured he had a gun to try to intimidate those who were escorting him out. He left prior to the arrival of police and could not be located. The female victim had a visible injury, but the victim did not want to provide information. The officers were able to substantiate a crime and identify the male suspect so charges for DV battery were forwarded to the district attorney's office for review. Due to the threat of implying he had a gun; the male suspect was also issued a municipal citation for disorderly conduct.



22-000676 01-08-2022 DC, Resisting N79 W14753 Appleton Ave.

Officers responded to Nail & Spa for a disorderly customer who was yelling, swearing, knocking things over and throwing customers property around. The female suspect was located driving away from the scene and was stopped by the officers. The suspect became belligerent and did not follow the officer's commands. She had to be physically restrained and was arrested for disorderly conduct and resisting. She was booked, issued two municipal citations and given a courtesy ride back to her vehicle.

22-000739 01-09-2022 Vehicle Theft N54 W15300 Block Beaver Dr.

An officer was called to investigate a vehicle theft. The victim advised that his Hyundai vehicle had been taken without his consent between Saturday afternoon and Sunday morning. The vehicle was taken without keys. No suspects have been identified. The vehicle was recovered abandoned on February 10th in Milwaukee.

22-000811/812/813 01-10-2022 Vehicle Theft, Pursuit Forest Dr. & Woodlawn Dr.

At around 7:00am officers responded to a report of a stolen Honda vehicle from a residence that was unlocked and running. Responding officers located the stolen auto and initiated a pursuit. The pursuit was later terminated due to safety reasons. In that same vicinity officers took an additional vehicle theft report where a running Toyota vehicle was stolen from the victim's driveway. Both vehicles were later recovered in Milwaukee. The vehicles were processed for evidence. These cases are actively under investigation.

22-000814 01-20-2022 Vehicle Theft N62 W13500 Block Sunburst Dr.

An officer responded to investigate a vehicle theft. The victim reported that their vehicle was unlocked, running in the driveway for about fifteen minutes when an unknown suspect stole the vehicle. Investigation revealed that the suspect vehicle may have also been a stolen vehicle. No suspects were located. The victim's vehicle was recovered in Milwaukee and was processed for evidence. This case is inactive.

22-001272 01-14-2022 Possession of Marijuana Appleton Ave./Lilly Rd.

An officer stopped a vehicle for expired registration. Upon contacting the driver, the officer noticed the strong odor of marijuana. A probable cause search revealed a glass jar containing suspected marijuana. The marijuana later tested positive for THC. The driver was arrested, booked and issued a citation for possession of marijuana. The suspect was released.

22-001446 01-15-2022 OWI 1st N56 W15500 Block Silver Spring Dr.

Officers responded to a citizen's report of a possible drunk driver. The responding officer located the suspect vehicle driving westbound in the eastbound lanes of Silver Spring Dr. The vehicle was stopped and the driver was contacted. The driver showed various signs of impairment as was asked to perform field sobriety tests. The driver was arrested and booked for OWI first offenses. The driver was later released to a responsible/sober adult.



22-001472 01-16-2022 OWI 8th Offense Townline Rd./Mill Rd.

Officers responded to a report of a driver unconscious in a vehicle, partially in traffic and partially in a snow bank. EMS also responded to the scene. The investigation determined that the suspect driver was operating while under the influence of suspected drugs and he was asked to perform sobriety tests. He was taken to the hospital for medical clearance and then brought back to the station to be booked on charges of OWI 8th offense.

22-001814 01-19-2022 Vehicle Theft W178 N8700 Block Queensway St.

Officers responded to a report of a vehicle theft. The victim reported that their Jeep, with the key fob inside the vehicle, was stolen sometime overnight. The vehicle was later recovered in Milwaukee. There are no suspects at this time and the case is actively under investigation.

22-001929 01-20-2022 OWI 1st, Hit and Run Hwy 41/Main St.

Officers responded to a crash investigation where the driver crashed his vehicle while exiting onto Main St. and rolled his vehicle off the roadway. The driver failed to call the police and walked to a nearby hospital. Officers located the suspect driver who showed signs of impairment. He was asked to perform field sobriety tests and was eventually arrested for OWI. He was booked and released to a responsible/sober adult. The vehicle had to be towed from the scene.

22-002358 01-24-2022 Retail Theft N95 W18000 Appleton Ave.

Officers responded to a report of a retail theft in progress at Kohls Department Store. Upon arrival the female suspect was contacted and it was learned that she removed approximately \$800.00 worth of merchandise. It was also determined that she had previously stolen merchandise three days earlier at the same store. The suspect was arrested and taken to the police department for booking. During the fingerprint process it was confirmed she had lied about her name and had four outstanding felony warrants for other felony crimes committed in Milwaukee. The subject was turned over to the county jail.

22-002601 01-26-2022 Substantial Battery N81 W15094 Appleton Ave.

Officers responded to DJ's Goalpost for a report of a fight. Investigation revealed two subjects were involved in a physical fight. One of the subjects sustained a serious injury. After interviewing several witnesses, it was determined that the suspect causing the injury as well as causing a disturbance in the bar would be arrested. The suspect was booked on state charges of substantial battery and disorderly conduct.

22-003050/3069 01-30-2022 Burglary N92 W15800 Megal Dr.

Officers responded to a report of a burglary at Store Space Self Storage. It was determined that over a period of two days a self-storage unit had been forcible entered and several valuables were stolen. A detective and field evidence technician responded to investigate and process the scene for evidence. This case is actively under investigation.
