



Menomonee Falls Police Department Notable Incidents for the Month of March 2022

22-006079 03-02-2022 Identity Theft N94 W16855 Falls Pkwy.

A detective received a phone call from Wauwatosa PD regarding a suspect they had in custody on fraud charges and who may have committed a similar crime at the Best Buy in our jurisdiction. The investigation revealed that the suspect used the victim's name by presenting a fake identification card to open a credit card account at Best Buy. The suspect then made fraudulent purchases at several area stores. The identified victim resides in Texas. Charges were referred to the district attorney's office.

22-006230 03-03-2022 Felon in Poss. of a Firearm N84 W17800 Block Menomonee Ave.

Officers responded to the area for a report of shots fired. Upon arrival shell casing were located near an occupied vehicle. The occupant was contacted and was determined to be the suspect who fired the shots. He was a convicted felon and was found to be in possession of marijuana and drug paraphernalia. He was arrested, booked and turned over to the county jail on several charges including carrying a concealed weapon, felon in possession of a firearm, possession of drug paraphernalia and possession of marijuana.

22-006279 03-04-2022 Possession of Drugs W124 N8145 Hwy 145

Police and EMS responded to the report of an overdose in the parking lot of Woodman's. Upon arrival officers located an unresponsive subject administered Naloxone. The suspect was on probation and was found to be in possession of Fentanyl. After medical clearance the suspect was booked and turned over to the county jail on drug charges and a probation hold.

22-006294/6295 03-04-2022 Vehicle Theft N83 W12529 Old Orchard Rd.

Officers responded to the Briggs and Stratton building where it was reported by two different victims' that their vehicles (both Hyundai) were stolen without keys sometime during the day. Both vehicles were recovered a day later in Milwaukee. The investigation is on-going to identify suspect(s).

22-006594 03-07-2022 Vehicle Theft W124 N8145 Hwy 145

Officers responded to Woodman's to investigate a vehicle theft. The victim reported their Hyundai vehicle was forcible entered and stolen. The investigation revealed the suspect's arrived in another stolen Hyundai that was reported in Milwaukee. Officers discovered another vehicle window that had been broken, however the vehicle owner did not want police to investigate or officially report it. The stolen vehicle was recovered in Milwaukee after being involved in an accident, no suspects were arrested. The case remains inactive at this time.

20-006609 03-07-2022 Theft from Vehicles (guns) N96 W14849 County Line Rd.

Officers responded to the parking lot of FedEx where a victim employee advised their vehicle was broken into. The suspects removed three handguns and ammunition and fled the area. This case is currently under investigation in an attempt to identify any suspects.



22-007047 03-12-2022 D.V. Strangulation N90 W16000 Block Roosevelt Dr.

Officers responded to an address to check on the welfare of a subject. Investigation revealed this subject was a suspect in a domestic violence incident in which he battered, strangled and prevented the victim from leaving the residence. The suspect was arrested, booked and eventually turned over to the county jail on numerous charges.

22-007301 03-15-2022 Recklessly Endangering Safety US 41/County Line Rd.

Officers responded to assist Germantown Police Department to look for spent shell casings near the US 41 southbound on-ramp at County Line Rd. The investigation determined that two co-workers from a business in Germantown stopped next to each other on the on-ramp and exchanged gunfire. One of those subjects contacted police to report the incident. Several officers and Detectives responded to investigate. Both vehicles were seized as evidence each with numerous bullet holes. One of the suspects was arrested and booked on felony charges of recklessly endangering safety and felon in possession of a firearm. The investigation is still on-going.

22-07555 03-17-2022 OWI 3rd Offense N56 W13100 Block Silver Spring Dr.

Officers responded to a one vehicle accident. Upon arrival officers observed a lone driver in a vehicle that had run up over a curb and was about fifty feet off the roadway and had deployed airbags. Officers contacted the driver who showed signs of intoxication. The driver was put through field sobriety tests and was eventually arrested for OWI 3rd offense. The suspect was taken to the hospital for a blood draw and was released to a responsible adult.

22-007594 03-18-2022 OWI 1st Offense Pilgrim Rd./Mill Rd.

At about 2:30 a.m. an officer observed a vehicle traveling northbound on Pilgrim Rd. in the southbound lanes. The vehicle was stopped and the driver was contacted. The driver showed signs of impairment and field sobriety tests were given. The driver was eventually arrested for OWI 1st offense. The driver was booked and released to a responsible adult.

22-007762 03-20-2022 Stolen Vehicle, CCW W124 N8145 Hwy 145

Officers responded to a report of a stolen vehicle in the Woodman's parking lot. The vehicle was reported stolen out of Chicago. Officers stopped the vehicle and contacted the driver who advised she was not aware of the vehicle was stolen. A search of the vehicle revealed a loaded handgun in the driver's purse and she did not have a valid CCW permit. The driver was arrested on the carrying a concealed weapon charge. Chicago PD was notified of the recovered stolen auto.

22-007926 03-22-2022 Theft from Vehicles N92 W15000 Anthony Ave.

Officers responded to Wacker Neuson for several vehicles that had been entered and had property removed. Investigation revealed that a total of seven vehicles were entered; three of which were unlocked and four had the window smashed. The suspect vehicle, a silver Dodge Charger with four occupants, that was in the lot for about ten minutes and then fled the scene. There was a similar incident reported at a nearby business. Due to a lack of suspect information the case remains inactive.



22-008162 03-24-2022 Theft N89 W16899 Appleton Ave.

An officer responded to Planet Fitness for a report of several lockers that were forcibly entered and property was stolen. Some of the property included stolen credit cards that were later used at a business to make fraudulent purchases. It appears the suspect(s) used a bolt cutter to cut the locks. The investigation involved other jurisdictions with similar offenses during which a suspect was identified. Several charges for the theft and fraudulent use of a credit card were referred to the district attorney's office.

22-008362 03-26-2022 Lewd and Lascivious N88 W16521 Main St.

Officers responded to Wisconsin on Tap bar for a suspect who staff refused to serve due to his intoxicated state. The suspect began to argue with other patrons and at some point, exposed his genitals to the patrons he was arguing with. The suspect was located and admitted to the offense. He was arrested on a misdemeanor charge of lewd and lascivious behavior, posted bond and was released.

22-008353 03-27-2022 Battery to an Officer, Resisting Arrest Shady Ln./Roger Ave.

Officers had been to a residence numerous times regarding a noise complaint where he refused to speak with officers. The suspect, who had a warrant and a revoked driver's license was later seen driving in the area. The suspect refused to stop and pulled into his driveway. The suspect continued to ignore officers and was forcibly removed from his vehicle. Once he was removed he resisted the officers attempts to take him into custody. He placed one of the officers in a head lock causing the officer non-life-threatening injuries. The suspect was arrested, turned over to the county jail with several charges sent to the district attorney's office.

22-008733 03-31-2022 Vehicle Theft N88 W15700 Block Park Blvd.

Officer responded to a vehicle theft where the victim reported their Kia was stolen. The victim reported that the vehicle may have had the key fob inside the vehicle at the time. The victim was able to geo-locate their vehicle and provide the address to officers. The officers located the stolen vehicle in a vacant garage in Milwaukee. The vehicle was processed for evidence and returned to the owner. This case is inactive at this time.
