



## Menomonee Falls Police Department Notable Incidents for the Month of May 2022

### **22-011512 05-01-2022 OWI 1<sup>st</sup>, Possession of drug paraphernalia US 41/124<sup>th</sup> St.**

Officers responded to the report of an intoxicated driver. The vehicle was observed leaving a parking lot and was stopped for erratic driving. The driver was contacted and showed signs of intoxication. The driver performed field sobriety tests and was arrested for OWI 1<sup>st</sup>. After being arrested a marijuana pipe was located in the suspect's purse. The suspect was booked and released to a responsible adult.

### **22-011542 05-01-2022 Carrying Concealed Weapon Appleton Ave./County Line Rd.**

An officer stopped a vehicle for not displaying registration plates. Upon contacting the driver, the officer smelled the marijuana and observed a handgun on the front passenger seat. The suspect driver did not have a CCW permit and was arrested for carrying a concealed weapon. The officer did not locate any drugs in the vehicle during the search. The suspect was booked on a state charge of CCW and issued traffic citations and released. The handgun was placed on property inventory.

### **22-011669 05-02-2022 Fleeing/Eluding Silver Spring Dr./Campbell Dr.**

An officer conducted a traffic stop for a vehicle traveling 68-mph in a 45-mph zone. The vehicle stopped and as the officer approached on foot the vehicle sped off. Due to the speed of the fleeing vehicle a pursuit was not initiated. The vehicle's registration was used to obtain the owner's address in Milwaukee. The officer contacted the owner's mother who was able to contact the vehicle owner by phone while the officer was at the residence. The owner was uncooperative, refused to meet with the officer and hung up on the officer. The officer eventually issued a traffic citation to the suspect owner for Vehicle Owner's Liability for Fleeing a traffic officer.

### **22-011861, 012189, 012593 05-04-2022 Stolen Auto/Pursuit Appleton Ave./Ruby Rd.**

An officer located a stolen blue Honda Ridgeline reported out of Milwaukee. The officer attempted to stop the vehicle which fled. The officer initiated a pursuit that led into Milwaukee. Due to increase of traffic and the suspect's speed, the officer terminated the pursuit. The suspect vehicle had been pursued on two other occasions by MFPD.

### **22-011896 05-05-2022 Theft from Vehicle W179 N8500 Block Village Ct.**

Officers responded to a theft from vehicle report. Upon arrival the victim advised they had several expensive items to include computers and a handgun stolen from their unlocked vehicle. A report was taken and the property was documented. The next day MFPD was contacted by Brookfield PD who had arrested two suspects involved in thefts from vehicles. The suspects were in possession of this victim's property to include the handgun. Charges will be referred out to the district attorney's office.

### **22-012092 05-07-2022 OWI 1<sup>st</sup>, Hit and Run, Fleeing Main St./Patton Dr.**

An officer attempted to stop a vehicle at 12:44 a.m. that did not have the headlights on. The vehicle fled and a short pursuit was initiated. The fleeing suspect struck a parked car and eventually stopped. The suspect driver showed signs of impairment and was put field sobriety tests and was eventually arrested for OWI. He was booked and issued several citations including fleeing, hit and run and OWI.



**22-012222, 012224 05-08-2022 Vehicle Theft, Pursuit N91 W1600 Block Junction Way**

Officers responded to a report of a vehicle theft in progress. The victim reported that their Hyundai vehicle had a window broken and was being stolen by unknown suspects. While enroute another officer in the area observed the stolen vehicle and attempted to stop it. The vehicle fled and the officer pursued it into Milwaukee. The pursuit was terminated due to the suspect's speed and reckless driving. The vehicle was recovered a few days later in Milwaukee.

**22-012223 05-08-2022 Vehicle Theft N91 W15848 Falls Pkwy.**

Officers responded to the Olive Garden for a report of a stolen vehicle. The victim advised that their Kia vehicle was stolen. There was no suspect information available, however it is believed to be related to the previously listed theft and some other thefts from vehicles in the area occurring around the same time. This vehicle was later recovered in Milwaukee. No suspects have been identified in any of these offenses.

**22-012582 05-12-2022 OWI 3<sup>rd</sup> N83 W15515 Appleton Ave.**

Officers responded to the drive-thru at the McDonalds at about 6:30 am, where it was reported that a driver was possibly passed out. The suspect driver was contacted and showed signs of impairment. The driver was placed through field sobriety tests and was arrested. He refused to provide a preliminary breath test or a breath or blood sample. A warrant was obtained and the suspect was taken to the hospital for a forced blood draw. The suspect also failed to comply with our booking procedures so he was transported out to the county jail. He was issued citations for OWI, open intoxicants, non-registration of auto, operating while revoked and operate without insurance.

**22-012869 05-14-2022 Felon in Possession of a Firearm, CCW Appleton Ave./Ridge Rd.**

An officer stopped a vehicle for expired registration. Contact was made with the driver when the officer observed a baggy of suspected marijuana in plain view on the center console. The driver was removed from the vehicle and arrested for possession of marijuana. A search of the vehicle revealed a loaded handgun in the glove compartment. The suspect driver was also a convicted felon in which he was prohibited from possessing a firearm. The suspect was arrested and booked on charges of possession of marijuana, carrying concealed weapon and felon in possession of a firearm. He was transported out to the county jail.

**22-012952 05-15-2022 Battery W156 N8480 Pilgrim Rd.**

Officers responded to the front parking lot of village hall for a report of a battery. Investigation determined that there was a planned child custody exchange in the parking lot. During that exchange two adults were involved in an altercation where an adult suspect struck another adult victim causing pain. The suspect was arrested and issued a municipal citation for battery and was released.



**22-012958 05-15-2022 OWI 1<sup>st</sup>, Possession of Drugs N88 W15167 Main St.**

Officers responded to the report of a citizen nodding off in their vehicle at the BP gas station pumps. Upon arrival the suspect driver started to drive away. The vehicle was stopped and the driver was contacted and showed signs of impairment. She was unable to keep her eyes open and had difficulty staying alert. She was placed through field sobriety tests and eventually arrested for OWI. A search of the vehicle revealed cotton balls a used syringe that tested positive for Fentanyl. The driver was booked on charges of OWI, possession of drugs and possession of drug paraphernalia. She was transported out to the county jail.

**22-013111 05-17-2022 Felon in Possession of a Firearm, Resisting, Possession of Drugs, Operate Vehicle w/o Owner's Consent W124 N8145 Hwy 145**

Officers responded to the Woodman's parking lot for a citizen reporting the theft of their vehicle. The victim advised he rents his vehicle through a rental company in Milwaukee where his vehicle was stolen. The victim tracked the suspect to the Woodman's lot where the stolen Tesla was plugged into a charging station. Officers approached and contacted the suspect who at one point tried to put the vehicle in reverse, but the vehicle had been placed in valet mode and would not go into drive. The suspect provided his driver's license, but then fled on foot. The suspect was quickly apprehended and arrested. Investigation revealed that the suspect had marijuana and a loaded handgun in the stolen vehicle and was a convicted felon. The suspect was arrested and booked on charges of operating vehicle without owner's consent, possession of marijuana, resisting/obstructing an officer, carrying a concealed weapon and felon in possession of a firearm. The suspect was transported out to the county jail.

**22-013156 05-18-2022 Fraud/Theft N78 W17300 Block Wildwood Dr.**

An officer was dispatched to a residence to investigate a fraud/theft complaint. Investigation revealed the victim was contacted via phone by an unknown suspect purporting to be a police officer who had arrested the victim's daughter. The suspect convinced the victim to send \$9,000.00 to an address in Massachusetts to pay for their daughter's bond. The victim sent the money then contacted the police after realizing this may be fraud. An officer was able to contact the delivery service and the money was intercepted and returned to the victim. No suspect information could be developed and this case is inactive.

**22-013402 05-20-2022 Theft N88 W16801 Main St.**

Officers responded to a theft in progress at North Middle School. Several witnesses reported two suspects removed several items from lockers. The total value of items taken was approximately \$4,300. The suspects were confronted by an adult and claimed they were there to meet a student. The suspects then fled on foot as some adults and students ran after them. One of the suspects yelled that he had a gun, but none was observed by witnesses. A vehicle was reported by witnesses fleeing the area. A plate was provided and the vehicle was tracked down to a business in Milwaukee. A detective assigned to the case, that same evening was able to identify, locate and arrest one of the suspects. Most of the property including cell phones and a laptop was recovered. The second suspect has yet to be identified.



**22-013704 05-24-2022 Reckless Injury, Hit & Run Causing Injury N84 W15300 Block Menomonee Ave.**

Officers responded to investigate an assault. Upon arrival they spoke with the victim who advised she was assaulted by her boyfriend. Investigation determined that the suspect boyfriend was involved in an argument in the parking lot. During that argument the victim exited the vehicle where the suspect quickly backed up striking the victim and causing significant injuries. The suspect was later located and arrested and booked on charges of first-degree reckless injury, negligent operation of a motor vehicle and hit and run-causing great bodily harm. The suspect was transported out to the county jail.

**22-013927 05-26-2022 Vehicle Theft N94 W18375 Thunder Ridge Dr.**

Officers responded to a report of a vehicle theft at the Home Depot. Upon arrival the victim advised that unknown suspects stole her Hyundai vehicle. Investigation revealed that the suspects arrived in a stolen vehicle reported out of Milwaukee. The victim's vehicle was later recovered in Milwaukee. No suspects have been identified and the case is inactive.

**22-014065 05-28-2022 Stolen Auto/Pursuit Falls Pkwy/Pilgrim Rd.**

Officers located a stolen Kia vehicle reported out of Milwaukee. Officers attempted to stop it, but the vehicle fled from officers and a pursuit was initiated. Due to the speed and reckless nature of the fleeing vehicle, the pursuit was terminated. No suspects have been identified and the case is inactive.
