



Menomonee Falls Police Department Notable Incidents for the Month of June 2022

22-014630 06-02-2022 Theft, Forgery N90 W17400 Block St. Francis Dr.

The victim contacted the police to report that an unknown suspect purchased their vehicle using cash. After the suspect left the scene with the vehicle, it was discovered that the cash was not real and described as prop money that is often used in movies. The vehicle was entered as stolen and was recovered in Milwaukee on June 30, 2022. The vehicle was returned to the owner. The investigation is still on-going in an attempt to identify and arrest the suspect.

22-014684 06-03-2022 Sexual Assault, False Imprisonment, Resisting/Obstructing, Possession of Marijuana and Drug Paraphernalia N92 W17700 Block White Oak Cir.

The victim contacted police to report that they were sexually assaulted by a known suspect on two different occasions. During the investigation, information was received that the suspect may also be involved in drug dealing. The suspect was located and arrested. Evidence was seized including a safe which contained a large quantity of marijuana and drug paraphernalia. The suspect was booked and transported out to the county jail on several charges.

22-014744 06-03-2022 Retail Theft, Obstructing W124 N8145 Hwy 145

Officers were dispatched to investigate a retail theft at Woodman's. Upon arrival they spoke with the female suspect who intentionally failed to scan all of her grocery items. During the investigation the suspect provided false identification. The suspect was arrested for retail theft and obstructing. While in custody she claimed to have ingested narcotics. She continued to resist and became uncooperative. The suspect was medically cleared and eventually turned over to the county jail.

22-014839 06-05-2022 Battery-Domestic Violence N51 W15700 Block Fair Oak Pkwy.

Officers responded to a battery complaint between two subjects. The victim who was married to the suspect, reported that they were arguing when the suspect threw her onto the bed and then onto the floor. This caused the victim to strike her face on the bedframe causing a laceration to her forehead and lip. The suspect was arrested on charges of battery, booked, bond was posted and he was released from custody.

22-015074 06-07-2022 Theft W124 N8145 Hwy 145

Officers responded to Woodman's to investigate a theft of a purse. The victim reported that her purse was stolen out of her cart after she had forgotten to remove it when she returned her cart. She did not see who took the purse. The investigating officer was able to contact security and watch the surveillance video. The officer was able to identify the suspect and the suspect's vehicle. The suspect was contacted at their residence in Milwaukee and admitted to the theft and returned the purse and all of the contents. The suspect was issued a citation for theft. All of the property was returned to the victim.



22-015081 06-07-2022 Damage to Property W185 N7400 Block Narrow Ln.

Officers responded to a report of damage to property in progress. The caller advised they observed multiple juveniles on top of a storage container at a nearby business, striking it with an axe or sledge hammer. Prior to the officer's arrival the juveniles fled the area. It was determined that there was approximately \$5,000.00 worth of damage that resulted from the suspects' actions. The juveniles were located a short time later and ran when the officers tried to call them over. The officers chased the suspects. A short time later a Lannon PD officer spotted two juveniles matching the description in the area on the bug line. Contact was made by our officers and the suspects admitted to doing the damage and provided the additional suspect's names. All four juveniles were booked on state damage to property charges that will be referred to juvenile court and issued municipal citations for resisting/obstructing for running from the police. Parental notifications were made.

22-015433 06-11-2022 Burglary (vehicle taken) W149 N7400 Block Hidden Meadow Dr.

Officers responded to a residence where a vehicle had been taken. Officer interviewed the victim who stated that while inside the residence their vehicle was parked running in the garage. An unknown suspect entered the garage and stole the victim's vehicle. The area was checked and the vehicle could not be located. The vehicle was entered as stolen. On July 12th the vehicle was recovered in Milwaukee. No suspects have been identified and the case remains inactive.

22-015809 06-15-2022 Carry Concealed Weapon (CCW), Possession of Marijuana Main St. & Pilgrim Rd.

Officers responded to a road rage incident where the victim reported that the suspect pointed a handgun at them. The suspect vehicle was eventually located at a gas station where contact was made with the two occupants. The male suspect driver admitted that there was a gun in the car and that he simply held it up, but did not point the handgun. The suspect driver and passenger were detained and the vehicle was searched. A loaded handgun was located on the rear passenger seat. Another loaded handgun was located on the front console. Additionally, a large drum magazine and an extended magazine were also located in the vehicle. During the search there was a strong odor of marijuana and a bag of suspected marijuana was seized from the vehicle. The investigation determined the pointing and aiming incident occurred in Milwaukee and they responded to the scene. The suspect driver admitted ownership of the handguns and marijuana and was subsequently arrested and booked on CCW and possession charges, posted bond and was released.

22-015956 06-16-2022 Eluding Main St. & Pilgrim Rd.

An officer located a stolen Kia vehicle reported out of Milwaukee. The officer attempted to stop the vehicle and the vehicle fled. The stolen vehicle was pursued into Milwaukee. Due to the fleeing vehicle's speed and recklessness the officer terminated the pursuit. The vehicle nor suspect were located. This case is inactive pending new information.



22-016066 06-17-2022 OWI 4th Offense US 41 at Main St.

An officer stopped a vehicle for displaying unauthorized license plates. The driver was contacted and showed signs of impairment. Based on the officer's observations the driver was asked to perform field sobriety tests. The driver was eventually arrested for OWI and was found to have three prior convictions. The driver refused to provide a blood sample so a warrant was obtained and the driver was brought to the hospital for a forced blood draw. The driver was booked on charges for OWI 4th offenses, operating after revocation and was turned over to the county jail.

22-016185 06-19-2022 Carrying Concealed Weapon, possession of Drugs and Paraphernalia, Bail Jumping Main St. at Executive Parkway

An officer stopped a vehicle for traveling 53 mph in a 35-mph zone. The officer approached the vehicle and contacted the driver. The officer noticed a clear plastic baggie on the passenger seat that appeared to contain suspected marijuana along with a small scale next to it. The driver was arrested for possession of marijuana and paraphernalia and was found to have additional marijuana in his pant pockets. He was found to have a suspended driver's license as well as pending criminal cases in which he was violating bail conditions. A search incident to arrest of the vehicle revealed a loaded 9mm handgun underneath the driver's seat. The suspect was booked on several charges and turned over to the county jail.

22-016269 06-20-2022 Child Abuse W124 N8145 Hwy 145

Officers responded to a fight in progress at Woodman's. Upon arrival, the officers contacted the juvenile victim who had visible injuries and advised her cousin was the suspect. She explained there was a dispute over a cell phone and the suspect tracked the victim down at the store and struck her several times causing injuries to her face. Officers obtained video surveillance, witness statements and notified the parents/guardians of the incident. The suspect had fled the scene, but came to the police department the following day. At one point during the interview inside the police department, the suspect tried to run out of the building. She was stopped, arrested and booked on a charge of child abuse and turned over to the county jail.

22-016409 06-21-2022 Theft and Eluding N91 W16100 Block Falls Pkwy.

Officers responded to a theft of a catalytic converter in progress that was occurring in a shopping mall parking lot. The reporting person was able to provide a suspect vehicle description and as officers responded the suspect vehicle was located and a traffic stop was attempted. The vehicle then fled and was pursued. Due to high speeds and the reckless nature of the suspect driver the pursuit was terminated. The suspect nor vehicle was ever located and the case is inactive pending new information.



22-016723 06-24-2022 Felon in Possession of a Firearm, Reckless Driving, Fleeing/Eluding Main St. at Sheridan Dr.

Officer stopped a vehicle for displaying no registration plate and excessive window tint. The vehicle was stopped and the suspect driver was contacted. The driver provided his driver's license and registration information. During this contact the officer noted the strong odor of marijuana. During the stop another vehicle pulled on scene and identified herself as the suspect driver's mother. She was advised to pull ahead and wait. A second officer arrived on scene and they re-approached the vehicle to issue citations and conduct a search of the vehicle. The suspect driver refused to exit and rolled up the windows and fled. Officers pursued and at one point the suspect driver was observed throwing a handgun out of the window. Two witnesses had also observed the handgun being thrown and had called 911. Based on the known identity of the suspect driver and the speed and recklessness, the pursuit was terminated. Investigation revealed the suspect was a convicted felon and cannot legally possess a firearm. Several attempts were made to try to locate the suspect, but were unsuccessful. The police report along with a request for charges for felon in possession of a firearm, reckless driving and fleeing/eluding were sent to Waukesha District Attorney's Office.

22-16757 06-25-2022 Carrying Concealed Weapon Appleton Ave at Pilgrim Rd.

An officer stopped a vehicle that was not displaying registration plates. The driver was contacted and advised he had a handgun in the glove compartment. A search revealed a loaded 9mm handgun and the driver did not have a valid CCW permit. He was arrested for carrying a concealed weapon. He was booked, posted bond and released.

22-016850 06-26-2022 OWI 1st, Possession of Drugs and Paraphernalia

US 41 at Main St.

Officers responded to the report of a vehicle crash on the highway where it was reported one of the drivers may be intoxicated. Officers contacted one of the drivers who showed signs of impairment and was asked to perform field sobriety tests. During these tests a police canine alerted on the vehicle resulting in locating marijuana. The driver was arrested for OWI 1st and possession of marijuana. In addition, after being arrested he was found to be hiding additional drugs in his underwear. The driver was booked on several charges and was turned over to the county jail.
