



Menomonee Falls Police Department Notable Incidents for the Month of July 2022

22-017351 07-01-2022 Resisting/Obstructing Main St./Mill St.

Information was provided to officers at roll call regarding a suspect wanted on several felony sexual assault charges through Washington County. An on-duty officer observed the suspect and attempted to contact the suspect who fled on foot. Several officers responded to the foot chase and were able to locate and arrest the suspect. The suspect was booked on resisting/obstructing charges and was turned over to the Waukesha County jail.

22-017446 07-02-2022 Vehicle Theft N91 W16100 Block Junction Way

Officers responded to the report of a vehicle theft where the victim reported that their Mazda vehicle was stolen with keys. The victim believed he left the key in the vehicle's cup holder. There was no suspect information that could be provided. The vehicle was recovered a week later in Milwaukee by the owner. This case is inactive due to the lack of suspect information.

22-017602 07-03-2022 Fatal Vehicle Crash N77 W14435 Appleton Ave.

A vehicle driving in the Pick N Save Parking lot lost control and struck two pedestrians. One of the pedestrians was critically injured the other passed away from their injuries. The striking driver remained on scene and cooperated with the investigation. The Wisconsin State Patrol assisted with the crash reconstruction. The completed investigation was submitted to the Waukesha County District's Office for review.

22-017948 07-08-2022 Eluding/Fleeing 16300 Block of Appleton Ave.

An officer attempted to stop a vehicle that was not displaying any registration plates. The officer initiated a vehicle stop and the vehicle drove into a gas station and stopped momentarily. The vehicle then fled. The officer initiated a pursuit as the vehicle fled eastbound. Due to the fleeing driver's reckless speed, the pursuit was terminated. This case is inactive as no suspect or further vehicle owner information was obtained.

22-018072 07-09-2022 Child Abuse, Underage Drinking N87 W17000 Block Schneider Dr.

Officers responded to a fight in progress. Upon arrival it was determined that an adult battered their juvenile sibling and was arrested and booked and turned over to the county jail on charges of child abuse and a probation violation. The fight stemmed from an underage drinking party the previous evening. During the investigation it was determined that several other juveniles on-scene had been drinking the night before and underage drinking citations were issued and parental notifications were made. The homeowner, who was not home during the party, later reported that property was stolen from their house.

22-018216 07-10-2022 Theft N89 W16889 Appleton Ave.

An officer responded to Planet Fitness for the report of several lockers that had been entered. Some of the victims reported credit and/or debit cards that were stolen from the lockers had been used at area stores. Investigation is on-going to identify the suspect(s) involved.



22-018296 07-11-2022 Battery N88 W16495 Main St.

Officers responded to AJ O'Bradys for two patrons that were eating at the outdoor patio area that were struck by unknown projectiles by two suspects driving by in a vehicle. The victim's reported pain and redness and thought it may have been a BB or pellet gun. The suspect vehicle was described along with the suspects, but no plate was given. Through further investigation the vehicle and owner were identified and two suspects were also identified. It was determined a toy gun used to shoot plastic projectiles was used by the one of the suspects, while the other was driving. The suspect identified as shooting the toy gun was arrested booked for misdemeanor battery. The other suspect had battery charges referred out to the Waukesha County District Attorney's office for review.

22-018933 07-12-2022 Fraud/Theft W220 N8000 Block Town Line Rd.

Officer responded to a residence where the victim advised that they were swindled out of several thousands of dollars. The victim was attempting to make an out of state purchase that included a third-party fraudulent delivery service. The victim wired money and suddenly was no longer able to contact the shipping agency or the original lister. The investigation is still on-going.

22-018667 07-15-2022 Carrying Concealed Weapon Appleton Ave/Northfield Dr.

An officer stopped a vehicle for having expired registration. Contact was made with the driver and a wanted check showed the driver had three valid warrants. The driver was arrested and a consent search revealed a loaded handgun in the glove compartment box. The suspect driver did not have a valid CCW permit and as booked on a misdemeanor charge of CCW and turned over to the Waukesha County jail.

22-018818 07-15-2022 Vehicle Theft W163 N8300 Block Arthur Ave.

An officer responded to the victim's residence where they reported their Acura vehicle had been stolen from their driveway. The victim reported that their vehicle was unlocked and the keys were inside. The vehicle was recovered in Milwaukee after it had been involved in a head-on crash. The vehicle was processed for evidence and the investigation is still open.

22-018971 07-19-2022 Eluding/Fleeing Falls Pkwy/Pilgrim Rd.

An officer located a Lexus vehicle displaying the plates of a Dodge vehicle stolen out of Illinois. The officer attempted to stop the vehicle and it fled. The pursuit was terminated after the suspect vehicle's speed was too reckless to continue. No suspect information was developed and the case is inactive.

22-018985 07-19-2022 Operate Vehicle without Owner's Consent W124 N8145 Hwy 145

Officers located a stolen Cadillac vehicle reported out of Milwaukee in the Woodman's parking lot. The vehicle was stopped and the driver was taken into custody. The vehicle's status was confirmed with Milwaukee PD. The suspect was booked on charges of Operating Vehicle without Owner's Consent and turned over to the Waukesha County jail. The suspect driver was also on probation.



22-019319 07-23-2022 Eluding/Fleeing 12400 Block Fond Du Lac Ave.

Officers located a stolen Dodge reported out of Mequon. They attempted to stop the vehicle and the vehicle fled. A pursuit was initiated and headed east into Milwaukee. The pursuit was terminated when the pursuing officers lost sight of the fleeing vehicle. This case is inactive.

22-019336 07-23-2022 OWI 3rd, Possession of Fentanyl and Drug Paraphernalia Lisbon Rd./Townline Rd.

Officers were sent to the area for the report of a drunk driver. The caller advised the suspect driver was swerving in and out of his lane and almost struck a pedestrian. Officers located and stopped the vehicle. The driver was contacted and showed signs of impairment. Sobriety tests were conducted and the driver was eventually arrested for OWI. He was found to have two prior convictions. A search incident to arrest revealed the suspect was in possession of Fentanyl and other drug paraphernalia. The driver was taken to the hospital for a blood draw then to the police department to be booked on charges of OWI 3rd, possession of fentanyl and possession of drug paraphernalia. He was then turned over to the Waukesha County jail.

22-019740 07-27-2022 Robbery-Use of Force W124 N8145 Hwy 145

Officers responded to Woodman's for a retail theft that was occurring. Upon arrival it was determined that a known suspect removed \$600 worth of merchandise and exited the store. As he left the store employees followed him to his car. The suspect entered his car and struck one of the employees with his car as he was leaving. Several attempts were made to locate the suspect, but he could not be located. A request for charges was sent to the Waukesha County District Attorney's Office.

22-019900 07-29-2022 Eluding/Fleeing Appleton Ave./Good Hope Rd.

Officer located a stolen vehicle reported out of Delafield. The officer attempted to stop the vehicle and the vehicle fled the area. The officer initiated a pursuit and continued to pursue the vehicle into Milwaukee where the suspect driver's reckless speed and increased traffic caused the officer to terminate the pursuit.
