



Menomonee Falls Police Department Notable Incidents for the Month of August 2022

22-020294 08-02-2022 Felony drug possession, warrant, probation violation

W180 N9469 Premier Ln.

An officer conducted a traffic stop for numerous traffic violations. A check with WI DOT showed the listed owner as having a suspended license and a valid warrant through Hartland PD. The driver was contacted and was found to be the listed owner. Upon contact, the officer noted the smell of burnt marijuana. A search of the vehicle revealed suspected marijuana and the driver was arrested. The driver was booked on charges for a probation violation, possession of marijuana (2nd offense), and the Hartland PD warrant. The suspect was transported to the Waukesha County Jail.

22-020379 08-03-2022 Felon in possession of a firearm, possession of drugs and paraphernalia W124 N8145 Hwy 145

Officers responded to the area of Woodman's after a female subject reported her boyfriend assaulted her and was in possession of rifle. While searching the area the caller advised the suspect was now standing in front of Woodman's. Officers located and detained the suspect and he was found to have a valid felony warrant. During the investigation a backpack the suspect had was searched and found to contain a loaded handgun, fentanyl, marijuana and other drug paraphernalia. The suspect was booked on numerous charges and turned over to the Waukesha County Jail.

22-020435 08-04-2022 Hit and Run, Obstructing Appleton Ave./Saint Francis Dr.

Officers were dispatched to a hit and run crash where one of the drivers fled the scene. The fleeing vehicle was located later at a residence where the driver was interviewed. The driver initially provided a false name when questioned by the officers. He was properly identified and found to have a felony theft warrant out of Michigan. The suspect was arrested, issued numerous citations, booked and turned over to the Waukesha County Jail.

22-020460, 020462, 020465 08-05-2022 Pursuit, Vehicle Theft N91 W16000 Block Junction Way

Officers responded to the area for the report of a stolen Kia vehicle reported out of Milwaukee. Upon arrival the stolen vehicle was located along with a second black Kia that was later to be determined stolen from a residence in Menomonee Falls. The officer attempted to stop both vehicles and they sped through a red light and a pursuit was initiated. Due to the excessive speed the pursuit was canceled on Hwy 145 near 91st St. in Milwaukee. Other squads searching the initial area located a Hyundai vehicle running with a broken window and damaged steering column that had been driven onto the grass which was recently stolen. Other vehicles had also been entered and damaged in the parking lot. No suspects have been identified in this case. The second vehicle that had fled was recovered in Milwaukee.

22-020548 08-06-2022 Pursuit Roosevelt Dr./Appleton Ave.

An officer stopped a vehicle displaying a stolen Illinois license plate. As the officer approached the vehicle on foot, the suspect drove away. Officers pursued the vehicle into Milwaukee, however was terminated due to the suspect's excessive speed. No suspects have been identified in this case.



22-020676 08-07-2022 Pursuit W124 N8145 Hwy 145

Officers responded to the Woodman's lot for the report of a stolen vehicle reported out of Milwaukee that was taken during an armed robbery. The suspect vehicle was located and officers attempted to stop the vehicle which fled. The vehicle was pursued into Milwaukee until the officer terminated the pursuit after losing sight of the suspect vehicle. No suspects have been identified in this case.

22-020730 08-08-2022 Pursuit Appleton Ave./Good Hope Rd.

Officers responded to the area for a report of a vehicle with stolen plates reported out of Cudahy. The vehicle was located and officers attempted to stop it. The driver fled and the vehicle was pursued into Milwaukee. The pursuit was terminated due to the suspect's excessive speed. No suspects have been identified in this case.

22-020784 08-08-2022 OWI 3rd, Revoked License Mill Rd./Lilly Rd.

An officer responded to a disabled vehicle in traffic. While responding, the dispatcher advised that the driver may be intoxicated and there was an adult female walking away from the vehicle with a young child. The officer arrived and contacted the driver who showed signs of intoxication. Investigation revealed the subjects walking away were from the car after it ran out of gas and stopped in traffic. The child who had been in the car was only three years old. The driver was put through field sobriety tests and was arrested for OWI 3rd offenses. She was operating on a revoked driver's license and had failed to install an ignition interlock device. The driver refused to provide a blood sample so a warrant was obtained for a forced blood draw. The driver was issued several citations and transported to the Waukesha County Jail.

22-020870 08-09-2022 Operate Vehicle without Owner's Consent, possession of drugs, resisting/obstructing, probation violation W124 N8145 Hwy 145

Officers responded to Woodman's for a report of a stolen Dodge reported out of Chicago. Officers contacted the five occupants of the vehicle including the driver. Investigation revealed the vehicle was confirmed to be stolen out of Chicago, Illinois. Marijuana and two loaded handguns were located inside the vehicle. One passenger was found to have in their possession Oxycontin and \$5600.00 cash and was on probation and was subsequently arrested. The driver was arrested for operating the motor vehicle without owner's consent and possession of marijuana. One of the other passengers was arrested on a warrant and posted the bond. Another passenger was arrested and booked on a charge of resisting/obstructing. The last passenger was released with no charges. The vehicle was towed from the scene.

22-021023 08-12-2022 Assist another Agency/Stolen Vehicle Falls Pkwy./Pilgrim Rd.

Officers responded to the area for a reported stolen vehicle taken in Milwaukee. The officers located the stolen vehicle unoccupied and confirmed the stolen status and requested a tow. During the investigation the driver of the vehicle from a nearby apartment inquired as to why officers were by her vehicle. She indicated she borrowed the vehicle from her brother and did not know it was stolen. The resident was identified and released from the scene and all information was provided to Milwaukee Police Department.



22-021196 08-13-2022 Vehicle Theft N91 W16200 Block Junction Way

An officer responded to the victim's residence for the report of a stolen Jeep. The victim advised that some time overnight her vehicle was stolen. The vehicle had been left unlocked and the key fob was in the vehicle. No suspects were identified. On August 23rd the vehicle was recovered in Milwaukee with two suspects in custody. Both suspects denied stealing the vehicle and will be prosecuted in Milwaukee County for operating auto without owner's consent.

22-021426 08-15-2022 Disorderly Conduct, Resisting/Obstructing N86 W17200 Block Hillcrest Dr.

Officers responded to a residence where the homeowner reported that there was an intoxicated male subject walking around yelling and banging on his house. An officer located and attempted to contact this subject who ran away. The subject continued to run from officers until he tried to jump over a fence and became stuck by his belt on the fence. The subject was identified and was found to be intoxicated as well as having open court cases with an absolute sobriety bail restriction. He was arrested and booked on charges of resisting, disorderly conduct and bail jumping.

22-021533 08-17-2022 Recklessly Endangering Safety W164 N9000 Block Water St.

Officers were called to a residence for an accidental stabbing. Upon arrival a male victim suffering from a stab wound was located. The suspect girlfriend was also on scene. Investigation revealed that a domestic argument occurred where the female suspect stabbed the male victim. The victim was transported to the hospital and the female subject was brought into the police department for questioning. The suspect was eventually booked on felony charges and transported to the Waukesha County Jail.

22-021736 08-19-2022 Theft of Gun N87 W15800 Block Bellevue Blvd.

An officer responded to a theft from vehicle complaint. The victim advised that his handgun had been stolen from the center console of his unlocked vehicle. The gun was entered as stolen and no suspects have been identified.

22-021974 08-21-2022 OWI 2nd, Operating after Revocation, Possession of Marijuana Rainbow Dr./Pilgrim Rd.

An officer stopped a vehicle for a failure to yield the right of way violation. A check with WI DOT showed the listed owner as having a revoked driver's license due to previous OWI convictions. The driver was contacted and was identified as the listed owner and was found that she had not installed the court ordered ignition interlock device. The driver showed signs of impairment and was put through field sobriety tests. She was arrested for OWI 2nd and a search of the vehicle revealed marijuana. The driver was booked on charges of OWI and possession of marijuana along with being issued several traffic citations. She was transported to the Waukesha County Jail.



**22-022262 08-25-2022 Felon in Possession of a Firearm, Resisting /Obstructing
N81 W15094 Appleton Ave**

An officer stopped a vehicle for expired registration and speeding. The vehicle pulled into a parking lot and the officer contacted the driver and occupants. The officer noticed the smell of marijuana and had the subjects exit the vehicle to conduct a search. During the investigation the two male occupants were found to be convicted felons with previous firearms violations on their record. Additional officers were called to assist. During a search of the vehicle a loaded handgun with an extended magazine was located. The driver was questioned and eventually detained. It was at this point the other male passenger ran past officers and attempted to get into the driver's seat of the vehicle but was pulled out and arrested. Both were arrested for the felon in possession of the firearm, both had hold placed with Probation and Parole. The subject who ran was booked on an additional charge of resisting/obstructing.
