



Menomonee Falls Police Department Notable Incidents for the Month of September 2022

22-023152 09-03-2022 Possession w/Intent to Deliver Marijuana, Resisting/Obstructing Police Pilgrim Rd./Megal Dr.

Officers responded to a property damage vehicle crash. During the investigation one of the involved drivers provided a false name. He was arrested and searched and was found in possession of marijuana in several baggies as well as a scale. He was issued traffic citations for the crash, booked and turned over to the Waukesha County Jail.

22-023224 09-04-2022 Possession of Marijuana, Carrying Concealed Weapon Pilgrim Rd./Claremore Cir.

An officer stopped a vehicle with suspended registration plates. The driver was contacted and the officer noted the odor of marijuana. The driver was asked about this and he admitted to having a handgun in his waistband. The driver was asked to step out of the vehicle and the handgun was removed. A probable cause search of the vehicle revealed marijuana. The suspect did not have a valid CCW permit. He was arrested and booked on drug and CCW charges. The suspect posted bond and was released from our custody.

22-023312 09-05-2022 Possession of Marijuana, Resisting/Obstructing Police, OWI 1st Appleton Ave./Northpoint Dr.

An officer responded to the area for a report of a possible drunk driver. The vehicle was located on the side of the road and the officer attempted to stop the vehicle. The vehicle pulled back onto the road and continued driving at about 20 mph before finally coming to a stop. The driver was contacted and showed signs of impairment and was asked to perform field sobriety tests. Based on those tests she was arrested for OWI 1st offense. A search of her vehicle revealed an open bottle of brandy and suspected marijuana. The driver also provided a false date of birth and was eventually identified by a mobile fingerprint ID reader. The suspect was booked on multiple charges, issued traffic citations and was released to a responsible adult.

22-023375 09-06-2022 Vehicle Theft W164 N9000 Block Water St.

An officer responded to a residence to investigate a theft of vehicle. The victim advised that he let an acquaintance use his car and that subject had not returned the vehicle and further told him he would never see his car again. The vehicle was entered as stolen and numerous attempts were made to locate the suspect and vehicle. The vehicle was stopped six days later in West Allis and the driver, who was not the victim's acquaintance, was arrested and booked on local charges. The vehicle was returned to the victim.

22-023397 09-06-2022 Fleeing/Eluding Pilgrim Rd./Countryside Dr.

An officer attempted to stop a vehicle for an equipment violation. The vehicle refused to stop and fled at a high rate of speed. A pursuit was initiated and quickly terminated by the officer due to the suspect's excessive and dangerous speed. Follow-up was conducted with the listed owner who did not provide the driver's name of the vehicle and was uncooperative. The listed owner was issued a citation for owner's liability for fleeing/eluding officer. The driver was never identified.



22-023438 09-07-2022 Fleeing/Eluding, Possession of Marijuana, Probation Violation N91 W15700 Falls Pkwy.

An officer attempted to stop a vehicle for speeding. The driver fled and a pursuit was initiated. The driver crashed and fled on foot to a pond area and tried hiding in the tall grass. He was located and arrested. A search of the vehicle revealed handgun ammunition and handgun magazines. Suspected marijuana was also located. The driver was found to have a suspended license and was on probation for previous fleeing/eluding conviction. The suspect driver was booked on multiple charges and issued traffic citations. He was turned over to the Waukesha County Jail.

22-023498 09-07-2022 Felon in Possession of a Firearm, Possession of Marijuana, Probation Violation N84 W15842 Appleton Ave.

An officer stopped a vehicle for a speed violation. The driver was contacted and the officer noted an odor of marijuana coming from the vehicle. The driver was asked to step out of the vehicle and initially refused officers commands. As the suspect driver exited the vehicle a handgun was observed in the driver's side door. A probable cause search of the vehicle revealed the loaded handgun, five cell phones, suspected marijuana, \$1,400 in cash. The driver was a convicted felon and was on parole. The suspect was booked on several state felony charges, issued traffic citations and turned over to the Waukesha County Jail.

22-023737 09-07-2022 Operate Vehicle without Owner's Consent-Carjacking W124 N8145 Hwy 145

Officers responded to a residence where the victim advised that she had met a known suspect in the Woodman's parking lot whom she buys drugs from. She further advised that she owes money to this suspect. During their interaction she had her vehicle taken at gunpoint and was driven home to Germantown and dropped off. Her vehicle had yet to be returned and she wanted to report it stolen. Germantown Police were involved due to where the victim resides. The victim's vehicle was entered stolen and was later located with the suspect inside in Germantown. A firearm was recovered and the suspect was booked on charges and turned over to the Waukesha County Jail. Germantown P.D. will be referring additional charges to the Washington County District Attorney.

22-023510 09-08-2022 Fleeing/Eluding Good Hope Rd./Marcy Rd.

An officer attempted to stop a vehicle for speeding. The vehicle refused to stop and a pursuit was initiated. The pursuit was eventually terminated by the officer due to the increased distance and speed of the fleeing vehicle. The driver has not been identified and no arrests have been made.

22-024008 09-13-2022 Stolen Vehicle, Carrying Concealed Weapon Appleton Ave./Good Hope Rd.

Officers responded and located a stolen vehicle reported out of Cudahy. The vehicle was located and the two occupants were detained. The driver was found to have three valid warrants. The passenger was found to be concealing a loaded handgun in her pants. The passenger did not have a valid CCW permit. Both subjects were arrested and booked on local charges. Cudahy PD was notified of the suspect information and will continue with their investigation.



22-024105 09-14-2022 Carrying Concealed Weapon, Possession of Marijuana McKinley Dr./Fond Du Lac Ave.

An officer stopped a vehicle for having no rear license plate. The vehicle was stopped and the officer contacted the driver. A wanted check revealed the driver had two valid warrants. The driver was arrested and during that time the police canine alerted on the vehicle. A search of the suspect's vehicle revealed a loaded handgun. During a search of the suspect a baggie of marijuana was located in his waistband. The driver was arrested and booked on multiple charges and turned over to the Waukesha County Jail.

22-024128 09-14-2022 Operate Vehicle without Owner's Consent, Resisting/Obstructing, Possession of Drug Paraphernalia, Warrants N94 W18375 Thunder Ridge Dr.

Officers responded to the area for the report of a vehicle displaying a stolen plate out of Illinois. The vehicle was located parked in the Home Depot parking lot. As officers approached the vehicle a subject was detained who was standing next to the vehicle. He advised the other suspect was in the store. As officers searched the store the second suspect ran out of the store and into the woods behind the neighboring business. Additional officer responded to assist. During this time, it was discovered that not only were the plates stolen, but the vehicle was also reported stolen out of Milwaukee. A search of the vehicle revealed drug paraphernalia. The second suspect was located hiding in the woods and was arrested. Both suspects had lengthy criminal histories and both were booked on multiple charges and turned over to the Waukesha County Jail.

22-024156 09-14-2022 Vehicle Theft N88 W16495 Main St.

Officers responded to investigate a vehicle theft. The victim advised that his vehicle was stolen while he was at AJ O'Bradys. The victim recalled setting his keys on the bar and then lost track of his keys. The area was checked and several people were interviewed with no leads developed. The vehicle was located a few days later in Menomonee Falls with the keys inside it. The vehicle was returned to the owner and no suspects have been identified for this offense.

22-024246 09-15-2022 Retail Theft, Eluding/Fleeing N95 W18351 County Line Rd.

Officers responded to Metro Market for a retail theft in progress. The suspect vehicle was located leaving the scene and officers attempted to initiate a traffic stop. The vehicle fled and a pursuit was initiated. Due to the vehicles excessive speed the pursuit was terminated. Follow-up was conducted and one of the suspects was identified. A request for a charge of retail theft of the suspect was sent to the Waukesha County District Attorney's Office.

22-024315 09-16-2022 Possession of Marijuana, Vehicle Seizure for Evidence Pilgrim Rd./ Appleton Ave.

An officer responded to a vehicle crash. Upon arrival, the officer checked the registration of the vehicle. One of the vehicles came back with a special alert. The vehicle was involved in a shooting in Benton Harbor, Michigan and that agency requested the vehicle be seized for evidence. Contact was made with Benton Harbor Police Department to gather additional information. During the investigation one of the passengers became uncooperative and demanded to retrieve a backpack out of the vehicle. The passenger allowed officers to search the backpack and suspected (cont.)



marijuana was found. The driver admitted it was his marijuana and he was arrested for possession of marijuana. A search of the vehicle revealed a loaded handgun and two extra magazines. The driver was found to have a valid CCW permit. The driver was booked on charges of possession of marijuana and released from the police department. The vehicle was towed from the scene and being held for Benton Harbor P.D.

22-024727 09-21-2022 Child Abuse N56 W16325 Silver Spring Dr.

Our agency was contacted by a parent whose child attended Cadence Academy and determined that his son received injuries while under the care of this daycare facility. An investigation was conducted that included a review of video surveillance. The video showed the manner in which the child received those injuries by one of the employees. In addition, a second child victim was identified in the video. Those parents were also contacted and were complainants in this case. The suspect was eventually arrested, interviewed, booked and turned over to the Waukesha County Jail on felony child abuse charges.

22-025194 09-26-2022 Carrying Concealed Weapon, Possession of Drug Paraphernalia, Possession of Marijuana 12400 Block of Main St.

An officer stopped a vehicle for no front registration plate and excessive window tint. The officer completed his traffic stop and then asked for consent to search the vehicle. The driver consented and a search was conducted. Three semi-automatic handguns were located along with numerous magazines, ammunition and drugs. There were additional drugs and paraphernalia located on some of the occupants as well. None of the three occupants of the vehicle had valid CCW permits. The driver was arrested/booked for carrying concealed weapon and possession of drug paraphernalia. One passenger was arrested/booked for carrying concealed weapon, possession of marijuana and drug paraphernalia. The second passenger was arrested/booked for carrying concealed weapon, possession of drug paraphernalia and bail jumping as he had an open circuit court case pending. All three suspects were booked and transported to the Waukesha County Jail.

22-025491 09-29-2022 OWI 5th, Fleeing/Eluding, Operating After Revocation Main St./Shady Ln.

An officer stopped a vehicle for speeding and crossing the center line. The vehicle initially stopped where the driver was contacted and appeared intoxicated. The driver then began to argue with the officer and fled in the vehicle. The officer pursued the vehicle into the Town of Lisbon where the driver finally stopped and was arrested. The driver was uncooperative and found to have four prior OWI convictions. His driver's license was revoked, he had not installed an ignition interlock device and was found to have valid warrants. He refused to conduct field sobriety tests so a search warrant to obtain his blood was obtained. He was booked on multiple charges, issued traffic citations. During the transport to the Waukesha County Jail the subject attempted to kick at the squad windows and had to be restrained.

22-025519 09-29-2022 Fleeing/Eluding Mill Rd./Parkway Dr.

Officers responded to the area for a report of a stolen vehicle. The vehicle was a Honda that had been reported stolen out of Milwaukee. Officers attempted to stop the vehicle and it fled the area and a pursuit was initiated. The pursuit was terminated due to the reckless and excessive speed of the vehicle. No suspects have been identified in this case.
