



Menomonee Falls Police Department Notable Incidents for the Month of October 2022

22-025777 10-02-2022 Fleeing/Eluding Appleton Ave./Menomonee Ave.

Officers responded to the area for a Flock alert for a stolen vehicle plate reported out of Pennsylvania that was displayed on a black BMW. Officers located the vehicle and attempted to conduct a traffic stop. The vehicle fled and was pursued into Milwaukee. The pursuit was terminated due to the suspect driver's speed and recklessness. No suspects have been identified.

22-025814 10-02-2022 Carrying Concealed Weapon Held Dr./Whittaker Way

An officer stopped a vehicle for a speed violation. The officer noted the smell of marijuana when contacting the driver. A probable cause search revealed a loaded handgun in the glove compartment. The suspect driver did not have a valid CCW permit and was arrested and booked on charges of carrying a concealed weapon. No drugs were found during the search. The suspect was unable to post bond and was transported to the Waukesha County jail.

22-025820 10-03-2022 OWI 3rd Park Blvd./Patton Dr.

An officer observed a vehicle driving erratically and noted the vehicle was displaying a 2021 expiration sticker on the rear plate. The vehicle was stopped and the driver was contacted. The driver displayed signs of intoxication and was put through field sobriety tests. The driver was arrested for OWI third offense. The driver was booked, issued citations, posted bond and released to a responsible, sober adult.

22-025853 10-03-2022 Carrying Concealed Weapon, Possession of Marijuana Appleton Ave./Thorndell Dr.

An officer stopped a vehicle for excessive window tint and a defective brake lamp. The officer noted the smell of marijuana when contacting the driver. A probable cause search revealed a loaded handgun in the glove compartment. The driver admitted to the gun and did not have a valid CCW permit. The driver was arrested for that violation and a search of her person revealed a vape pen with suspect THC wax which later tested positive for THC. The suspect driver was booked on one state charge of CCW and issued a municipal citation for the THC possession. She posted bond and was released from custody.

22-025897 10-03-2022 Operate Vehicle without Owner's Consent, Possession of Marijuana, Warrant Arrest

Officers responded to a Flock alert for a stolen Porsche out of Minnesota. The vehicle was located and the occupants were detained. Investigation determined the driver was attempting to sell the vehicle and was arrested for Operating Vehicle without Owner's Consent. The passenger was found to have a valid felony warrant for arson out of Texas and was in possession of marijuana. Both the driver and passenger were booked at the department. The driver was released with charges referred to the Waukesha County District Attorney's Office. The passenger was transported out the Waukesha County jail.



22-025922 10-04-2022 Carrying Concealed Weapon Silver Spring Dr./Lilly Rd.

An officer stopped a vehicle displaying expired registration plates. The officer contacted the driver and noted the smell of marijuana. A probable cause search of the vehicle revealed a loaded handgun underneath the driver's seat. The suspect driver admitted to the ownership of the gun and did not have a valid CCW permit. No marijuana was located and the driver was arrested and booked on the CCW charge and issued traffic citations. The driver posted bond and was released from custody.

22-026045 10-05-2022 Possession of Marijuana Fond Du Lac. Ave/Main St.

Officers responded to a report of a subject passed out in a vehicle that was partially in traffic at around 8:00 a.m. in the morning. Upon arrival the vehicle and driver were located. The driver was found asleep under a blanket. The officer noted the smell of marijuana coming from the vehicle. Based on a consent search of the driver, the officer located marijuana in driver's pants pocket. The driver was arrested on a municipal charge of possession of marijuana and released from custody.

22-02617 10-06-2022 Theft-Swindle W208 N6000 Block Fillmore Dr.

The victim contacted the police to report a loss of \$9300. The victim advised police that an unknown subject purporting to be a friend of the victim's grandson was seeking money to pay for the grandson's bond because of an arrest. The victim mailed cash to an address in Georgia. The victim later realized it was a scam and contacted the police. Investigation revealed the Georgia address was vacant and the phone number could be identified.

22-026267 10-07-2022 Appleton Ave./Parkway Dr. Possession of Drug Paraphernalia, Possession of THC, Possession of Fentanyl with Intent to Deliver, Maintain Drug Trafficking Place, Obstructing

An Officer conducted a traffic stop for excessive window tint. The officer noted the smell of marijuana when contacting the driver. A probable cause search of the vehicle revealed a large amount of cash, six cell phones, a digital scale, suspected marijuana, and suspected fentanyl. The driver initially provided a false name and was arrested on several drug charges including resisting/obstructing for providing a false name. The suspect driver was transported out to the Waukesha County jail.

22-026389 10-08-2022 Possession of THC, Carrying Concealed Weapon US 41/124th St.

Officers responded to meet a Milwaukee County Sheriff's Deputy who started an abandon vehicle report which included an inventory search of the vehicle which revealed suspected marijuana and a loaded handgun. The Deputy realized the vehicle was actually in Menomonee Falls and requested our response. While both agencies were on scene the driver arrived and admitted to the ownership of the gun and did not have a valid CCW permit. He was arrested for CCW and possession of marijuana. He was booked, posted bond and was released from custody.



22-026527 10-10-2022 Carrying Concealed Weapon, Possession of THC and Paraphernalia W124 N8145 Hwy 145

Officers responded to a Flock alert for a reported stolen vehicle reported out of Milwaukee. The vehicle was located in the Woodman's parking lot and the driver was detained. Investigation revealed a loaded handgun, suspected marijuana and drug paraphernalia. The suspect driver was determined to be the vehicle owner, but the stolen vehicle status had not been canceled. The driver did not have a valid CCW permit and was arrested for CCW and the drug charges. The suspect was booked, posted bond and release from custody.

22-026825 10-13-2022 Operate Vehicle without Owner's Consent, Fleeing/Eluding, Resisting/Obstructing, Possession with Intent to Deliver THC, Felony Bail Jumping W124 N8145 Hwy 145

Officers responded to a Flock alert for a stolen vehicle reported out of Chicago. The vehicle was located in the Woodman's parking lot. The suspect driver was located and ran from police. He re-entered the stolen vehicle and was pursued into Milwaukee where the vehicle crashed near 107th and Brown Deer Rd. The suspect fled again on foot, but was apprehended. The suspect was booked on several charges (listed above) and was found to be out on bond on a felony drug case. He was transported out to the Waukesha County jail.

22-026875 10-14-2022 Resisting/Obstructing, Possession with Intent to Deliver-THC Hwy 145/Leon Rd.

An officer stopped a vehicle for having expired registration. Upon approaching the vehicle, the driver placed the vehicle in drive as if to flee. The driver continued to ignore the officer's commands and was eventually physically removed from the vehicle and continued to physically resist arrest. The driver was eventually handcuffed and a search incident to arrest of the vehicle revealed a large quantity of marijuana in several areas of the vehicle, a digital scale and several plastic baggies all of which is utilized to package and sell marijuana. The driver was booked on charges of resisting/obstructing and drug charges. He was transported out to the Waukesha County jail.

22-026914 10-14-2022 Felony Retail Theft, Carrying Concealed Weapon N95 W18000 Appleton Ave.

Officers responded to Kohl's Department store for a report of a retail theft involving two female suspects. Their description and vehicle were provided to responding officers. The vehicle was located on Appleton Ave. and was stopped. The two suspects were contacted and eventually arrested for felony retail theft charges. One of the suspects was in possession of a stun gun which was concealed in her purse. This suspect was also charged with possession of this type of weapon and carrying a concealed weapon. The investigation revealed these suspects were responsible for stealing more than \$4000.00 worth or merchandise from seven different Kohl's stores in the Milwaukee and Waukesha areas. Both suspects were transported out to the Waukesha County jail.



22-027170 10-17-2022 Hit and Run Causing Injury, OWI 2nd Causing Injury, Fleeing/Eluding Pilgrim Rd./Good Hope Rd.

Officers responded to a crash where the striking vehicle fled the scene. The dispatcher provided updates indicating there were injuries to some of the involved occupants and the fleeing vehicle had severe front-end damage and was missing a right rear tire. An officer located the suspect vehicle and attempted to stop it. The suspect continued to drive into a driveway on Mary Hill Dr. Officers contacted the driver and immediately observed the driver to show signs of intoxication along with observing two bottles of vodka located on the vehicle seat. The driver was asked to conduct field sobriety tests and was eventually arrested for OWI 2nd along with several other charges based on the crash, the injuries he caused, fleeing the scene and failing to stop for the officers. The driver was booked, issued several citations and transported out to the Waukesha County jail.

22-027207 10-18-2022 Carrying Concealed Weapon, Possession of THC Main St./124th St.

An officer stopped a vehicle for speeding. A wanted check of the driver revealed that he had a valid warrant. The driver was eventually arrested and found to be in possession of marijuana. A search of the vehicle revealed a handgun magazine, additional marijuana and an open container of liquor. The suspect was booked on multiple charges, issued municipal charges and transported out to the Waukesha County jail.

22-027566 10-18-2022 Theft-Use of Entity ID N95 W17707 Shady Ln.

Officers responded to the Target store to investigate a theft. The investigation revealed that four unknown suspects worked in concert to obtain several thousand dollars' worth of gift cards using fraudulent credentials. The suspects fled prior to police responding. The suspects had been stopped earlier by Wisconsin State Patrol, and the investigation is on-going.

22-027587 10-22-2022 Resting/Obstructing, Warrant N91 W15848 Falls Pkwy.

Officers responded to a Flock alert of a stolen vehicle out of Milwaukee. The stolen vehicle was a Chevrolet Tahoe and the plate was actually being displayed on a Range Rover. The vehicle was located unoccupied in the Olive Garden parking lot. At one point a male subject approached the vehicle and then walked away indicating it was not his vehicle. The investigating officer then ran the VIN and determined the vehicle was not stolen, just the plate affixed to it was. He determined the listed owner was the subject who had initially walked towards him and then turned away and entered Mr. Brews Taphouse. This same subject also had five outstanding warrants. Officers went to locate the vehicle owner who fled out the back door and was located hiding in the grass. The subject then fled on foot onto the shoulder of the highway, but was eventually arrested. He provided a false name during this contact and was later correctly identified and the warrants were confirmed. He was also the reported victim of the stolen vehicle report and did not want to cooperate as to why he put his stolen plate on a different vehicle. Suspect was arrested on the warrants, booked for resisting/obstructing and transported to the Waukesha County jail.
