



## Menomonee Falls Police Department Notable Incidents for the Month of November 2022

### **22-028444 11-01-2022 Robbery, Disorderly Conduct N88 W15200 Block Cleveland Ave.**

Officers responded to a disturbance where a known suspect used a bat to enter the victim's residence by breaking the door, causing a disturbance and damaged a television once inside. The suspect also damaged the victim's vehicle. The suspect was located on-scene, arrested and booked on charges of robbery, damage to property and disorderly conduct. The suspect was transported out to the Waukesha County jail.

### **22-028534 11-01-2022 Resisting/Obstructing, Bail Jumping, Warrants W124 N8145 Hwy 145**

Officers responded to investigate a retail theft at Woodman's. Upon arrival, loss prevention provided a brief description of the suspect and the attempted theft. Officers contacted the suspect who had abandoned her cart before leaving the store. The suspect provided a false name and was eventually identified. She was found to have three valid warrants and open misdemeanor and felony cases. She was arrested and booked on charges of bail jumping, resisting/obstructing and the valid warrants. She was transported out to the Waukesha County jail.

### **22-028562 11-02-2022 Fleeing/Eluding Lilly Rd./Mill Rd.**

An officer observed a vehicle traveling at a high rate of speed. The officer clocked the vehicle's speed at 70 mph in a 40-mph zone. The officer attempted to stop the vehicle which then sped up and attempted to flee. The officer initiated a pursuit and the vehicle continued to flee until it turned its lights off and turned down a residential street. The vehicle was located and the suspect driver was found nearby hiding behind a parked vehicle. The driver was arrested and booked on charges of fleeing/eluding, issued citations and transported out to the Waukesha County jail. The vehicle was towed from the scene.

### **22-028602 11-02-2022 Retail Theft N95 W18000 Appleton Ave.**

Officers responded to Kohl's Department Store for a report of a retail theft in progress. Prior to the officer's arrival the suspects fled in a dark colored vehicle. The area was checked and no suspect or vehicle was located. Loss prevention estimated the loss to be close to \$3000.00. Follow-up with the video surveillance and a crime alert led to the development of suspect information. This case is currently active.

### **22-028639 11-03-2022 OWI 1<sup>st</sup>, Going Armed while Intoxicated Marcy Rd./Silver Spring Dr.**

An officer stopped a vehicle for having expired registration. Upon contacting the driver, the officer noted the smell of marijuana and observed the driver showing signs of impairment. Based on the officer observations the driver was placed through field sobriety tests and eventually arrested for OWI 1<sup>st</sup> violation. A search of the vehicle revealed a loaded handgun in the center console. Although the driver had a valid CCW permit, they were found to be intoxicated. The driver was booked on charges of OWI 1<sup>st</sup> and going armed while intoxicated. The suspect posted bond and was released from custody to a responsible adult.



**22-028689 11-03-2022 Theft/Swindle W136 N8000 Block River Dr.**

The victim called the police to report that they had transferred over \$10,000.00 over time for the purchase of bitcoins through a fraudulent broker. The victim realized this when they went to verify the funds in their on-line account which was locked. The investigation is on-going.

**22-028763 11-04-2022 Theft/Swindle N92 W14300 Block Anthony Ave.**

A business contacted the police department to report that a suspect posing as a customer had fraudulently obtained several thousands of dollars' worth of product without rendering payment. The product was shipped to an address in New Jersey. The company followed up and learned that the customer was not associated with the company he purported to be with. This investigation is on-going.

**22-028791 11-04-2022 Possession of Narcotic Drugs Menomonee Ave./Shady Ln.**

Officers responded to the report of a possible overdose called in by a Lyft driver who noticed his passenger was unresponsive. The passenger was eventually conveyed to the hospital and a search of his bag revealed suspected fentanyl which later tested positive. The suspect passenger was eventually medically cleared and brought to the police department to be booked on charges of possession of narcotic drugs and then transported out to the Waukesha County jail.

**22-029062 11-07-2022 Carrying Concealed Weapon, Possession of Controlled Substance and Paraphernalia**

An officer stopped a vehicle for a defective headlamp. Upon contacting the driver, the officer observed a 9mm handgun on the front passenger seat and noted the odor of marijuana. The driver did not have a valid CCW permit and was arrested for carrying concealed weapon. A search of the vehicle revealed the handgun was loaded. Marijuana and drug paraphernalia were also located during the search. The driver was booked on several charges, posted bond and was released from custody.

**22-029148 11-07-2022 Carrying Concealed Weapon, Possession of Marijuana, Felony Bail Jumping Appleton Ave./Arthur Ave.**

An officer stopped a vehicle for having suspended vehicle registration. The officer contacted the driver and noted the smell of marijuana. The four occupants were asked to get out of the vehicle so a probable cause search could be conducted. Upon initial search, suspected marijuana was found in front of the front passenger seat. That suspect passenger was arrested for possession of drugs and a search of his person revealed more marijuana. A further search of the vehicle revealed a loaded Glock handgun under the front passenger seat. That same suspect was also found to be out on bail on a felony case. That suspect passenger was booked on charges of CCW, possession of marijuana and felony bail jumping. The driver was found to be under the influence of drugs and placed through field sobriety tests and was eventually arrested for operating with a detectable amount of a restricted controlled substance. The driver was released to a responsible adult and the passenger was transported out to the Waukesha County jail.



**22-029270 11-08-2022 Carrying Concealed Weapon, Possession of Electric Weapon  
Good Hope Rd./Lilly Rd.**

An officer stopped a vehicle for a defective tail lamp. Upon contacting the driver, the officer noted the smell of marijuana. The driver and passenger were asked to step out of the vehicle. A probable cause search of the vehicle revealed an electronic weapon “stun gun” and a loaded semi-automatic handgun. The suspect passenger admitted ownership of both weapons and was arrested and eventually booked for carrying concealed weapon. The passenger was transported out to the Waukesha County jail.

**22-029460 11-10-2022 Operating Vehicle without Owner's Consent Hwy 41/Pilgrim Rd.**

Officers responded to the area of a Flock alert indicating a vehicle was pulling a stolen trailer reported out of Milwaukee. The vehicle and trailer were located and stopped. The driver was contacted and stated he received the trailer from an unknown person. The driver was arrested and booked on charges of operating vehicle without owner's consent. He was transported out to the Waukesha County jail.

**22-029518 11-11-2022 Retail Theft, Resisting/Obstructing N94 W16855 Falls Pkwy.**

Officers responded to a retail theft in-progress at the Best Buy store. While enroute the dispatcher advised the suspect fled on foot west into the subdivision with \$1500.00 worth of unpaid merchandise. The suspect was located near the Target store and when officers attempted to make contact the suspect fled on foot. The suspect was chased through numerous yards and was eventually located and arrested. The property was recovered and the suspect was booked on felony retail theft charges, felony bail jumping and resisting/obstructing police. He was transported out to the Waukesha County jail.

**22-029540 11-11-2022 OWI 5<sup>th</sup> Offenses N56 W14108 Silver Spring Dr.**

Officers responded to possible intoxicated driver near Scotty's Beer & Liquor. The first officer arrived and observed an older male inside the vehicle with his pants down around his ankles. The driver appeared intoxicated and slow to respond. The officer attempted to get the suspect to roll down the window which he had difficulty doing. The driver put the car in drive and drove across the lot and was unable to negotiate a turn and hopped the curb and struck a tree. The officer summoned EMS and contacted the driver who showed signs of impairment and intoxication. After being medically cleared the investigating officer had the suspect conduct field sobriety tests which resulted in the arrest and booking of the suspect on OWI 5<sup>th</sup> offense charges. He was transported out to the Waukesha County jail.

**22-029662 OWI 2<sup>nd</sup> Offense, Bail Jumping 16800 Block Menomonee Ave.**

An officer responded to a report of a suspicious vehicle that was parked sideways on the roadway. As the officer arrived, he noticed a female inside the vehicle revving the engine. The officer also noticed the suspect's vehicle had a flat rear tire and the front tire was completely missing. The officer contacted the driver who showed signs of intoxication and had open intoxicants inside the vehicle. The officer had the suspect conduct field sobriety tests and arrested her for OWI 2<sup>nd</sup> offense and bail jumping as she had an open OWI court case. She was transported to the Waukesha County jail.



**22-029720 11-14-2022 Stolen Vehicle, Fleeing/Eluding Mill Rd./Parkway Dr.**

Officers responded to a Flock alert for a stolen Hyundai vehicle reported in Milwaukee. The vehicle was located and an officer attempted to stop the vehicle. The vehicle fled at a high rate of speed and attempted to elude the police. Due to the increased speed and recklessness of the fleeing vehicle the pursuit was terminated. The driver was not able to be identified and there have been no arrests for this incident.

**22-029812 11-15-2022 Stolen Vehicle, Fleeing/Eluding Appleton Ave./Good Hope Rd.**

Officers responded to the area of a Flock alert indicating there was a stolen BMW reported out of Mequon. Officers located the vehicle and attempted to stop it. The vehicle fled and officers pursued it. Due to the reckless speed of the fleeing vehicle the pursuit was terminated. The driver was unable to be identified and there have been no arrests for this incident.

**22-030117 11-18-2022 Vehicle Theft N90 W1700 Block Appleton Ave.**

Officers responded to a vehicle theft complaint. Upon arrival the officer contacted the victim who advised a known acquaintance had stolen his vehicle. Further investigation revealed that the victim identified the suspect as a known prostitute that he picked up in Milwaukee. At some point the suspect grabbed the victim's car keys, fled the residence and stole the victim's vehicle. The victim attempted to chase the suspect down but was unsuccessful. The suspect left picture identification behind and officers attempted to locate the suspect unsuccessfully. The vehicle was entered as stolen and was located approximately a week later in Milwaukee. A request for a charge of motor vehicle theft was forwarded to the Waukesha District Attorney's Office for charging.

**22-030123 11-18-2022 Possession of Cocaine, Methamphetamine, Heroin, and Drug Paraphernalia W124 N8145 Hwy 145**

Officers responded to a Flock alert regarding a vehicle displaying a stolen plate reported out of Washington County that was located in the Woodman's parking lot. The officer approached the vehicle and observed the suspect attempting to snort an unknown white substance he suspected to be drugs. The officer noticed several items that indicated drug use inside the vehicle to include Narcan and used syringes. The suspect was contacted and was detained. Several different types of drugs were located in the vehicle and the stolen license plate was confirmed as stolen. The suspect driver was eventually arrested and booked on several felony drug charges and transported out to the Waukesha County jail. The stolen plates were removed from the vehicle.

**22-030268 11-20-2022 2<sup>nd</sup> Degree Intentional Homicide, Go Armed While Intoxicated, 1<sup>st</sup> Degree Recklessly Endangering Safety, OWI N88 W16697 Appleton Ave.**

Several officers responded to a report of an armed suspect shooting inside Sal's Pub and Grill. Officers arrived on scene where the suspect was being detained by customers. Investigation revealed an intoxicated suspect was harassing customers and was asked to leave. The suspect eventually left and returned with a high-powered rifle and shot one round towards staff and customers. He was arrested, booked, interviewed and transported out to the Waukesha County jail.
