



## **Menomonee Falls Police Department Notable Incidents for the Month of December 2022**

**22-031201 12-01-2022 Carrying Concealed Weapon N92 W15000 Block Anthony Ave.**  
Officers responded to Wacker-Neuson where management reported that an employee was possibly carrying a concealed handgun. The investigation revealed that an employee brought a handgun to work and was showing it off to fellow employees. The employee was contacted and found to have a loaded semi-automatic pistol inside her purse. She did not have a valid CCW permit either. The suspect was arrested, booked, posted bond and was released. The gun was seized as evidence.

**22-031210 12-1-2022 Vehicle Theft N89 W15800 Block Main St.**  
The victim reported that he rented out one of his vehicles through HyreCar. The renter of his car kept the vehicle beyond the terms of the rental agreement and failed to return it or make additional payments. Numerous attempts to contact the suspect renter and locating the vehicle have been unsuccessful. This investigation is still open and active.

**22-031221 12-01-2022 Embezzlement N96 W18515 County Line Rd.**  
Police were called to the JC Penny store to investigate an employee theft. The investigation revealed a suspect employee embezzled \$3400.00 worth of merchandise over a two-week period. Contact was made with the employee who admitted to the theft and was arrested, booked and transported out to the Waukesha County jail.

**22-031649 12-06-2022 Carrying Concealed Weapon, Possession of Marijuana Main St./Polk St.**  
An officer stopped a vehicle for speeding and disregarding a red traffic signal light. The officer contacted the driver and noted the strong smell of marijuana and observed some marijuana on the floor of the vehicle. The driver admitted to the possession of marijuana and a probable cause search was conducted of her vehicle. Suspected marijuana and an electronic stun gun were located. The suspect did not have a valid CCW permit for the stun gun. The suspect was arrested, booked and released from custody.

**22-031768 12-07-2022 Possession of Cocaine, Fentanyl, Marijuana, and Drug Paraphernalia, Bail Jumping N88 W15476 Main St.**  
Officers were investigating a disturbance at the Kwik Trip when they were advised there was an unresponsive subject in a vehicle. The subject was located and given Narcan for a suspected overdose. The subject was eventually transported by EMS. Investigation revealed the subject was in possession several drugs and paraphernalia. Once he was medically cleared he was arrested, booked and transported out to the Waukesha County jail.

**22-031808 12-08-2022 Carrying Concealed Weapon, Possession of Marijuana & Drug Paraphernalia Pilgrim Rd./Ridge Rd.**  
An officer stopped a vehicle for a speed violation and contacted the driver. The officer noted the smell of marijuana and a probable cause search of the vehicle revealed marijuana, paraphernalia and a semi-automatic handgun under the driver's seat. The suspect driver did not have a valid CCW permit. He was arrested booked, posted bond and was released.



**22-031982 12-09-2022 Fleeing/Eluding Good Hope Rd./Appleton Ave.**

Officers responded to a Flock alert for a stolen Hyundai vehicle stolen out of Milwaukee. The vehicle was located and a traffic stop was initiated. The vehicle failed to stop except to briefly allow two occupants to exit and then fled from police. The officer initiated a pursuit of the stolen vehicle which continued to increase speed. Due to the excessive speed and traffic conditions the pursuit was terminated. The two occupants who exited the vehicle prior to the pursuit were located and interviewed and denied knowing the vehicle was stolen. The occupants did provide the suspect driver's information. The investigation is on-going in an attempt to locate and arrest the driver.

**22-032192 12-12-2022 Carrying Concealed Weapon, Warrant Arrest W124 N8145 Hwy 145**

Officers responded to Woodman's for a Flock alert for a stolen Chevrolet reported stolen out of Milwaukee (UW-Milwaukee PD). The vehicle was located unoccupied and officers attempted to locate the driver or any occupants. During the investigation two suspects returned to the vehicle and were detained by the officers. Upon contacting one of the suspects, the officer observed a handgun in her purse. The officer detained the suspect and retrieved a loaded semi-automatic handgun as it was determined she did not have a valid CCW permit. The other suspect was found to have a warrant through Milwaukee County Sheriff's Department, however they requested not to take him into custody. The female was arrested for CCW, booked and transported to the Waukesha County jail. Investigation revealed information that the female suspect did not know the vehicle was stolen and she was not charged with that offense. The vehicle was towed from the scene.

**22-032656 12-17-2022 OWI 3<sup>rd</sup> Offense, OWI Causing Injury 2<sup>nd</sup> Offense, Possession of Heroin Lisbon Rd./Weyer Rd.**

Officers responded to the report of a reckless vehicle on Lisbon Rd. that had crashed head-on into another vehicle. Officers arrived and determined the crash had injured occupants and contact was made with the suspect driver who showed signs of impairment. As EMS was treating the suspect driver the officer observed a small baggy of suspect drugs near the driver's feet. The officer asked the suspect what was in the bag and the suspect replied "heroin". The driver was put through field sobriety tests and eventually arrested for the OWI offenses and the possession of heroin. He was booked and transported out to the Waukesha County jail.

**22-032673 12-17-2022 Robbery-Use of Force N84 W15690 Appleton Ave.**

Officers responded to the Dollar Store where investigation revealed two suspects stole \$30.00 worth of merchandise and when confronted by an employee, one suspect physically grabbed the employee. One of the suspects was subsequently identified as she was wearing a name badge from her employer. The known suspect was located and interviewed and it was determined that she had paid via a cash app and that all items were paid for. She also denied any physical altercation had occurred. The suspect provided an electronic receipt of the transaction and the incident was determined to be unfounded.



**22-032699 12-18-2022 Carrying Concealed Weapon, Possession of Dangerous Weapon Lilly Rd./Lancaster Ave.**

An officer stopped a vehicle for a defective headlamp. The officer contacted the driver and noted the strong odor of marijuana. Due to several occupants, additional officers were requested to respond. All occupants were asked to step out of the vehicle so a probable cause search could be done. A search of the vehicle revealed a semi-automatic handgun, a blank firing facsimile gun and marijuana in different areas of the vehicle. Three of the occupants of the vehicle were arrested. Suspect #1 was arrested for carrying a concealed weapon and possession of a dangerous weapon by a person under 18 and was released after posting bond. Suspect #2 and #3 were arrested and issued municipal citations for possession of marijuana.

**22-033057 12-21-2022 OWI 3<sup>rd</sup> Offenses Hillcrest Dr./Sheridan Dr.**

Officers responded to a one-vehicle crash in which the caller described a vehicle had crashed into a ditch and was now stuck. The caller also noted the vehicle had sustained severe front-end damage and the airbags had deployed. Upon arrival a male suspect was seen walking away and was identified as the listed owner of the damaged vehicle. He admitted to driving and showed signs of impairment. The suspect was asked to perform field sobriety tests and was eventually arrested for OWI 3<sup>rd</sup> offense. The suspect was booked and transported out to the Waukesha County jail.

**22-033243 12-24-2022 Vehicle Theft N78 W17600 Block Willow Pond Dr.**

An officer responded to a residence for the report of a vehicle theft. The victim advised that they were in the process of loading their running vehicle. The victim briefly went into their residence and when he came back out his vehicle was missing. The victim was able to contact a service that disabled and locate his vehicle which was recovered in Milwaukee a short time later. An evidence technician responded to process the vehicle for evidence. There are no suspects identified in this case.

**22-33395 12-26-2022 Possession of Cocaine/Drug Paraphernalia, Resisting/Obstructing an Officer N96 W18515 County Line Rd.**

Officers responded to a Flock alert for a stolen vehicle reported out of Neenah, WI. The vehicle was located in the JC Penny's parking lot occupied by two people and a traffic stop was initiated. The driver was arrested for obstructing (provided a false name) and possession of cocaine and drug paraphernalia. The passenger suspect was arrested for possession of drug paraphernalia, felony and misdemeanor bail jumping and a warrant for violation of probations. Both suspects were booked and transported out to the Waukesha County jail. No charges related to the stolen auto were charged at this time due to the relationship of one of the suspects with the vehicle owner. This information was confirmed with the Neenah Police Department while officers were on scene.



**22-033741/22-033747      12-30-2022      Retail Theft, Fleeing/Eluding, Possession of Drug Paraphernalia      N94 W18375 Thunder Ridge Dr.**

Officers responded to the area of a retail theft at Home Depot. The vehicle description was broadcasted to the responding officers. The suspect vehicle was located and a traffic stop was initiated, but the vehicle fled at a high rate of speed. A pursuit was initiated and then terminated based on the vehicle's excessive speed and recklessness. The information of the fleeing vehicle was broadcasted to area departments and the Milwaukee County Sheriff's Department located the vehicle and detained two suspects. MFPD officers responded to an address in Milwaukee where one of the suspects was confirmed as the fleeing driver and committing the retail theft and the suspect passenger was also confirmed as being involved with the retail theft and found in possession of drug paraphernalia. Both suspects were arrested, booked and transported out to the Waukesha County jail.

**22-033801      12-30-2022      Carrying Concealed Weapon      Appleton Ave./Northpoint Dr.**

An officer stopped a vehicle for failing to have the headlamps illuminated during the hours of darkness and having expired vehicle registration. The vehicle was stopped and the driver was contacted. As the officer was issuing the driver citations he noticed the handle of a handgun between the front seat and center console. The driver said he did not have a CCW license but was "open" carrying the pistol. The occupants were removed from the vehicle and the handgun was recovered. The driver was arrested for carrying a concealed weapon.

**22-033888      12-31-2022      Fleeing/Eluding      Good Hope Rd./Pilgrim Rd.**

An officer stopped a vehicle for having no rear registration plate. The driver initially stopped then fled. The officer initiated a pursuit as the vehicle continued to increase its speed. The officer terminated the pursuit due to the speed and slick road conditions. No driver has been identified in this incident.
