



## Menomonee Falls Police Department Notable Incidents for the Month of January 2023

### **23-000032 01-01-2023 Operate Vehicle without Owner's Consent, Warrants, Operating after Revocation 13900 Block Silver Spring Dr.**

Officers received a FLOCK alert of a stolen Volkswagen reported out of Kenosha. The vehicle was located and stopped. A high-risk traffic stop was conducted and all occupants were detained. Investigation confirmed the stolen status of the vehicle. The driver was arrested for operating the stolen auto, was found to have two valid warrants and a revoked driver's license. The driver was booked and transported out to the Waukesha County jail. The vehicle was towed and the other occupants were released with no charges.

### **23-000142 01-02-2023 Possession of Fentanyl, OWI 1<sup>st</sup> Offense, Probation Violation Shady Ln./Joss Pl.**

Officers responded to a report of a driver passed out in a vehicle in traffic. Upon arrival the driver was observed to be unconscious and officers suspected a possible drug overdose. The driver was administered Narcan and regained consciousness. A wanted check of the suspect driver revealed he was on probation and was not to consume alcohol or drugs. A search of the vehicle revealed suspected fentanyl. The driver was arrested for OWI 1<sup>st</sup> offense, possession of fentanyl and a probation violation. After medical clearance the suspect was booked and transported out to the Waukesha County jail.

### **23-000466 01-06-2023 OWI 3<sup>rd</sup> Offense, OWI Causing Injury Silver Spring Dr./ Pilgrim Rd.**

Officers responded to a report of a multiple vehicle, injury crash. Upon arrival it was determined that a driver failed to stop and rear-ended another vehicle causing injuries. This suspect driver showed signs of intoxication and was asked to perform field sobriety tests. The suspect was eventually arrested for OWI 3<sup>rd</sup> offense and OWI causing injury. The suspect consented to a blood draw and was eventually booked and transported out to the Waukesha County jail.

### **23-000516/541 01-06-2023 Retail Theft, Theft from Vehicle N94W18375 Thunder Ridge Dr.**

An Officer was investigating a theft from vehicle complaint where the victim reported that while parked in the Home Depot parking lot, an unknown suspect removed several thousands of dollars' worth of tools from his work truck. During the initial investigation the officer contacted Home Depot to review surveillance cameras to try to identify any suspects involved in the theft. A review of the surveillance identified the suspect had committed a retail theft from Home Depot just prior to stealing the tools from the victim's work truck. The officer filed both crime reports. However, the suspect has not been identified in these cases.



**23-000580 01-07-2023 Endangering Safety by the Use of a Dangerous Weapon  
N86 W14300 Block Fond Du Lac Ave.**

Officers responded to the call of shots fired at an apartment complex. Upon arrival the caller reported that he heard a loud noise and noticed a hole in his floor which appeared to be a bullet hole. Officers contacted the downstairs tenant who was found to be intoxicated and admitted to inspecting one of his firearms when it accidentally discharged through the ceiling. The firearm was seized and the suspect was arrested. The suspect was booked, posted bond and was released.

**23-000614 01-07-2023 Battery, Possession of Cocaine, Disorderly Conduct, Probation Violation W167 N8600 Block Jacobson Dr.**

Officers responded to a domestic violence incident. Investigation revealed that the victim discovered her live-in boyfriend's crack pipe at which point he assaulted her to get it back. The victim's minor children witnessed the suspect assaulting her. The officers arrested the suspect and during a search incident to the arrest, suspected cocaine was located in his pants pocket. The suspect was also on probation from a previous domestic violence case and a probation hold was placed. The suspect was booked on several charges and transported out the Waukesha County jail.

**23-000863 01-10-2023 Carrying Concealed Weapon, Possession of Marijuana Appleton Ave./Pershing Ave.**

An officer stopped a vehicle for displaying no registration plates. The officer contacted the driver and noted the odor of marijuana. The driver was asked if he had anything illegal in his vehicle and replied that he had a firearm underneath his seat. The driver also stated he did not have a concealed carry permit. The driver was asked to step out of the vehicle and a search of his person revealed hidden marijuana in his pants. The driver was arrested and a search of the vehicle revealed more suspected marijuana and a loaded 9mm semi-automatic pistol underneath the driver's seat. The driver was arrested for carrying a concealed weapon and possession of marijuana. He was booked and transported out to the Waukesha County jail.

**23-000824/865 01-20-2023 Operating Auto without Owner's Consent, Possession of Marijuana, Possession of drug paraphernalia, Felony Bail Jumping W14800 Block County Line Rd.**

Officers responded to a FLOCK alert on a stolen Kia out of Milwaukee. The vehicle was located and a high-risk stop was conducted. The vehicle was confirmed stolen out of Milwaukee and two occupants were inside the vehicle. The driver was arrested and booked for operating the stolen auto and felony bail jumping as she was out on bond on a prior felony offense. She was transported out to the Waukesha County jail. The passenger was found to be in possession of multiple small bags of suspected marijuana and digital scale. The passenger was arrested and booked on charges of possession of marijuana and drug paraphernalia and released.



**23-000949 01-11-2023 Carrying a Concealed Weapon, Probation Violation, Assist Other Agency N88 W147550 Main St.**

Officers responded to the Delta Hotel where they received information that there was a suspect vehicle involved in a homicide in Columbus, Ohio. Officers were able to contact the suspects in the parking lot as they approached the suspect vehicle. Three suspects were detained and Columbus Police Department Detectives responded that same evening to conduct interviews. The vehicle was seized as evidence to be processed. One of the suspects was released without charges. Another suspect was charged with carrying concealed weapon as she was found to have a loaded handgun in her pants pocket. She eventually posted bond and was released. The third suspect was arrested on a probation hold and transported out to the Waukesha County jail. Columbus PD is still actively investigating their homicide case.

**23-001272 01-15-2023 Vehicle Theft W147 N8600 Block McKinley Dr.**

Officers responded to a residence where the victim advised his Chevrolet truck was stolen sometime overnight. The victim was unsure if the vehicle was locked or if there was a spare key left in the vehicle. The victim had no other suspect information and did not suspect anyone of the theft. The vehicle was entered as stolen and neighbor contacts were conducted. The vehicle has yet to be recovered and no suspects have been identified.

**23-001298 01-15-2023 Theft from Motor Vehicle N4900 Block Emerald Hills Dr.**

An officer took a theft from vehicle complaint in which two handguns and a checkbook were stolen. The victim advised he was in the area for work and had left his vehicle parked at a dead end. When he returned he observed that an unknown suspect had rummaged through his vehicle and removed two handguns and a work checkbook. He was unsure if he locked his truck and there were no signs of forced entry. The handguns were entered as stolen and the bank was notified of the stolen checkbook. No suspects have been identified in this case.

**23-001349 01-16-2023 Burglary, Vehicle Theft N84 W18000 Block Imperial Ct.**

MFPD was contacted by Racine County Sheriff's Department to attempt contact with a vehicle owner regarding a pursuit they were just involved in. It was determined that an unknown suspect entered the enclosed porch, removed the victim's keys and stole the vehicle. The vehicle was then driven to the Racine area and involved in a pursuit where the suspect driver was eventually taken into custody. Our officer notified the victim who did not know the suspect and did not give anyone permission to take their vehicle. The officers processed the victim's residence for evidence and coordinated the return of their vehicle.

**23-001446 01-17-2023 Endangering Safety by Use of a Dangerous Weapon N80 W12900 Block Fond Du Lac Ave.**

A citizen called the police to report that while cleaning his shotgun in his apartment, he accidentally discharged it and a shotgun round lodged in the wall. Officers responded and confirmed the information. The suspect was arrested, booked, posted bond and was released. The shotgun and spent round were taken as evidence.



**23-001638 01-19-2023 OWI 1<sup>st</sup>, Go Armed While Intoxicated W124 N8145 Hwy 145**

Officers responded to the Woodman's parking lot for a suspicious vehicle. An employee observed a heavily damaged vehicle park in the lot and observed two suspects walking away from the vehicle. Officers located the suspects and identified the driver who admitted to parking in the lot and walking away. The driver also admitted to having a handgun concealed on him. The suspect driver showed signs of impairment. Investigation revealed the driver struck a concrete barrier somewhere on US 41 near Hampton Ave. and then parked in the Woodman's lot to abandon the vehicle as the driver had been drinking. The driver was asked to perform field sobriety tests and was eventually arrested for OWI 1<sup>st</sup> offenses and going armed while intoxicated. The suspect was booked, posted bond and was released to a responsible adult.

**23-002525 01-29-2023 Fleeing/Eluding Main St./Pilgrim Rd.**

Officers responded to a FLOCK alert for a stolen Jeep reported out of Oak Creek. Officers attempted to stop the vehicle and the vehicle fled. Due to the vehicle's speed and recklessness the pursuit was terminated. No suspects have been identified in this case.

**23-002707 01-31-2023 Carrying Concealed Weapon, Possession of Marijuana and Paraphernalia Main St./Madison Ave.**

An officer stopped a vehicle for a defective headlamp. Upon contacting the driver, the officer noted the odor of marijuana and observed a marijuana pipe near the center console. The driver advised that he had a handgun in a bag that was on his lap and explained that his CCW permit expired last year. A search of the vehicle recovered suspected marijuana, marijuana pipe and a loaded semi-automatic handgun. The driver was arrested, booked, posted bond and released.
