



Menomonee Falls Police Department Notable Incidents for the Month of April 2023

23-007991 04-01-2023 Damage to Property W151 N5476 Badger Dr.

Officers responded to Willowood Park for the report of a reckless vehicle. Officers arrived and determined that two juvenile suspects entered an unlocked village maintenance building and removed a John Deere utility vehicle. The suspects took turns driving the vehicle around damaging the grassy areas by causing ruts. The juveniles were located, admitted to causing the damage and were issued citations. Parental notifications were made.

23-008004 04-01-2023 Battery W180 N9469 Premier Lane

Officers responded to Applebee's to investigate a battery. Upon arrival the officers met with the employee victim who advised she was counseling another employee regarding a performance issue. During this discussion the suspect employee was asked to leave at which time she struck the victim employee and left. The suspect was cited for battery.

23-008161 04-03-2022 Retail Theft N94 W16855 Falls Pkwy. &

23-008323 04-05-2023 Retail Theft N95 W18000 Appleton Ave.

Officers responded to Best Buy on April 4th for a retail theft of approximately \$2000.00 worth of electronics. Video surveillance along with additional investigative efforts determined it was two unknown suspects who fled in a Lincoln. The following day a retail theft from Kohl's Department store was reported involving similar suspects and the same vehicle. In the second incident, the suspects were able to be identified and also positively identified as being the suspects in the Best Buy incident. Several attempts to locate the suspects in Milwaukee were unsuccessful. Because their identities were known, several charges were forwarded to the Waukesha District Attorney's office for review and charging to include felony bail jumping and felony retail theft charges.

23-008320 04-05-2023 Vehicle Theft W137 N5560 Williams Pl.

Officers responded to American Sewer Parts and Cleaning for a report of a stolen vehicle. Upon arrival officers were advised that an employee's Kia vehicle had been stolen and the theft was captured on surveillance. Investigation revealed that several suspects arrived in a Kia that had been reported stolen out of Milwaukee. One of the suspects broke the passenger window of the victim's vehicle and was able to enter and start the vehicle and flee. Both stolen vehicles fled the area. Seven days later the victim's vehicle was stopped by Brown Deer Police who took two suspects into custody. The vehicle was recovered and towed from the scene.

23-008831 04-11-2023 Vehicle Theft N59 W15800 Block Cheryl Dr.

An officer responded to a residence for the report of a vehicle theft. The victim advised that their Honda vehicle had been stolen. They indicated that most likely they left the doors unlocked and the key fob was in the vehicle. Their video surveillance captured a possible suspect vehicle. One of the other vehicles in the driveway had also been rummaged through, but nothing was reported missing. Three days later the vehicle was recovered in Milwaukee. No suspects have been identified in this case.



23-008895 04-11-2023 OWI (7th offense) Appleton Ave./Arthur Ave.

Officer responded to the area of a known suspect who appeared to be driving while intoxicated. The vehicle was located, stopped and the driver was contacted. The driver showed signs of impairment and attempted to consume an intoxicant in front of the officer while in the driver's seat. He was asked to perform field sobriety tests and was eventually arrested for operating while intoxicated 7th offense. It was determined that the suspect was currently on probation for his previous OWI. He was taken to the hospital where a warrant was obtained to get a blood sample. The suspect was eventually booked on OWI charges, probation violation and transported out the Waukesha County jail.

22-009064 04-13-2023 Disorderly Conduct, Strangulation/Suffocation - Domestic Violence N82 W13200 Block Fond Du Lac Ave.

Officers responded to a domestic violence incident where the victim reported that she was involved in a physical altercation when her live-in boyfriend choked her, threw a table then took her cell phones so she could not call 911. The suspect fled in his vehicle prior to police arrival. During the investigation the suspect returned and was arrested, booked and transported out to the Waukesha County jail.

22-009156 04-14-2023 Endangering Safety by Use of a Dangerous Weapon, Kidnapping – Domestic Violence N79 W17700 Block Willow Pond Dr.

Officers responded to a domestic violence related incident where the victim reported her ex-boyfriend pointed a gun at her and forced her into her car and drove into Milwaukee. The suspect threatened to harm the victim and eventually exited her car and fled the area. A temporary felony warrant was entered for the suspect who was eventually arrested, booked and transported out to the Waukesha County jail.

22-009503/22-009517 04-17-2023 Possession of Marijuana, Carry Concealed Weapon (gun) Main St./Pilgrim Rd.

An officer conducted a traffic stop of a vehicle with suspended registration. The officer contacted the driver who advised he did not have a valid license. The officer also noticed the odor of marijuana coming from the vehicle. The officer requested an additional officer to conduct a probable cause search. Investigation revealed the passenger had marijuana in his pants pocket and a loaded handgun was located under the driver's seat. The passenger was arrested and cited for possession of marijuana. The driver who did not have a valid CCW permit was arrested and booked on CCW charges and issued traffic citations for having no valid licenses. Both subjects were released from the department.

22-009835 04-21-2023 Burglary/Vehicle Theft N80 W12540 Leon Rd.

Officers responded to Aldi's for the report of a burglary. It was determined that two unknown suspects broke into the employee breakroom and removed the victim's purse. The suspects then used the victim's key to locate and steal her vehicle. That same day Milwaukee Police Department recovered the victim's vehicle which had been used in the commission of another crime in their jurisdiction. No suspects are in custody for this offense.



23-010192 04-23-2023 Vehicle Theft N90 W17400 Block St. Francis Dr.

An officer was dispatched to meet with the victim who wanted to report that their vehicle was stolen. The victim advised that he had been drinking and consuming drugs somewhere in Milwaukee. He woke up the next morning and did not know where he was. He continued to use drugs and drink and at some point, was dropped off at his residence by two unknown suspects who demanded money for drugs he consumed that day. When the victim went into his residence to get the money the suspects left with his vehicle. The victim did not know the names of the suspects and wanted to report his vehicle as stolen. A week later the victim's vehicle was recovered in Greenfield and three suspects were taken into custody. The vehicle was returned to the owner.

23-010286 04-26-2023 Retail Theft N91 W16121 Falls Pkwy.

While on patrol an officer observed four juveniles acting suspicious by trying to conceal themselves behind a dumpster near a closed business. As the officer approached them he observed one of the juvenile's ditch something under the dumpster. A second officer arrived and it was determined the juveniles had stolen merchandise from Ross Dress For Less and Five Below. All four juveniles had stolen items on them. All four juveniles were arrested, booked, issued municipal citations for retail theft and turned over to their parent/guardian.

22-010401 04-28-2023 Operate Vehicle without Owner's Consent, Possession of Machine Gun, Possession of drugs and drug Paraphernalia N92 W16100 Block Falls Pkwy.

Officers responded to the area for a FLOCK alert on a stolen U-Haul truck reported out of West Allis. The vehicle was located and officers attempted to stop the truck. The truck refused to pull over and a pursuit was initiated. The vehicle continued to flee officers, but stopped abruptly and the female suspect passenger exited and the truck continued fleeing. One officer remained with the female suspect who was found to be in possession of an extended magazine Glock that had been modified to fire in full-auto mode as well as suspected marijuana. The suspect driver continued fleeing in the vehicle until he stopped and fled on foot. This suspect was eventually located and taken into custody. Based on the investigation the driver was charged with multiple felony violations to include fleeing, operating vehicle without owner's consent, possession with intent/marijuana, sale/use/transport machine guns and a misdemeanor charge of possession of drug paraphernalia. He was transported out to the Waukesha County jail. The female suspect passenger was issued a citation for possession of marijuana and released.

22-010435 04-28-2023 Vehicle Theft W133 N4960 Campbell Dr.

An officer responded the Bushman Equipment where an employee was reporting that their Kia vehicle had been stolen by unknown suspect(s). There was broken glass on scene, however there were no witnesses to the incident. The vehicle was entered as stolen. The vehicle was recovered unoccupied a day later in Milwaukee and no suspects have been arrested for this offense.
