



Menomonee Falls Police Department Notable Incidents for the Month of June 2023

23-013647 06-01-2023 Vehicle Theft N86 W12999 Nightingale Way

Officers were dispatched to Froedtert Integrated Services to investigate a vehicle theft. Upon arrival the victim advised they had parked and locked the Kia vehicle and had their keys with them. However, the parking stall where the victim's vehicle was parked had broken glass around it and the vehicle was gone. There was no suspect information provided and the vehicle was entered as stolen. On June 13th the vehicle was involved in a pursuit with the Manitowoc Sheriff's Department where suspects were arrested. The vehicle was recovered and processed for evidence.

23-014260, 23-014263 06-07-2023 Operating While Intoxicated 1st , Possession of Drug Paraphernalia and Marijuana W17200 Block Main St.

An officer stopped a vehicle in which the registration showed the listed owner as having a revoked driver's license. The driver was contacted and showed signs of intoxication. The driver was put through field sobriety tests and was arrested for OWI 1st offense and a valid warrant for possession of cocaine. During the traffic stop the passenger was contacted who admitted to having drug paraphernalia and marijuana on him. The passenger was also arrested. The driver was booked and transported out to the Waukesha County jail. The passenger was booked, posted bond and was released.

23-014547 06-09-2023 Battery, Endangering Safety by Use of a Dangerous Weapon N88 W14800 Block Main St.

Officers were dispatched to a residence for the report of a domestic violence incident. Upon arrival officers spoke with the victim who advised that her live-in boyfriend and her were arguing and a physical altercation occurred. During this altercation the suspect physically hurt the victim by pushing her down and also pointed a handgun at her. The suspect was arrested, booked, posted the required bond and was released. A handgun was recovered and taken as evidence.

23-014594 06-10-2023 Fleeing/Eluding US 41/Main St.

An officer attempted to conduct a traffic stop on a black Chevrolet for having suspended registration. The suspect driver failed to stop and fled at a high rate of speed. The officer pursued the vehicle. The officer eventually terminated the pursuit due to the suspect vehicle's speed and distance. Contact was made with the listed owner who advised she sold the vehicle to an unknown subject. This case is inactive and no suspects have been identified.

23-014649 06-10-2023 Operating While Intoxicated Causing Injury, Fleeing/Eluding, Operating after Revocation Hwy 145/Leon Rd.

An officer attempted to stop a vehicle for unreasonable speed and a red-light violation. The vehicle fled at a high rate of speed. A pursuit was initiated and then terminated due to the suspect's speed. Officers searching the immediate area located the suspect vehicle that had been involved in a crash causing minor injuries to the other occupants on US41 near Florist Ave. The suspect showed signs of impairment and had a revoked driver's license. The driver was put through field sobriety tests and was eventually arrested, booked and transported out the Waukesha County jail.



23-014982 06-14-2023 Assist other Agency Appleton Ave./University Dr.

Officers responded to the area for a FLOCK alert of a stolen plate out of Milwaukee that was being displayed on a BMW. The vehicle was located and stopped. The driver advised that her vehicle had been stolen in Brown Deer and the suspects had placed a different stolen plate on her vehicle. After her vehicle was recovered and returned to her, she was unable to remove the plate and left it on her vehicle. This information was confirmed with the Milwaukee Police Department. The stolen plate was removed from the vehicle and all agencies were notified so the stolen status could be canceled for the license plate. No enforcement action taken.

23-015436 06-18-2023 Disorderly Conduct W178 N9315 Water Tower Pl.

Officers were dispatched to Goodwill to investigate a disorderly conduct incident. The victim was located and advised that an unknown suspect walked behind her, crouched down and lifted her skirt and attempted to look up her skirt. The victim confronted the suspect who fled the store. Video surveillance and photos of the suspect were sent out via a public crime alert to help identify him. The case is still under investigation.

23-015520 06-19-2023 Resisting/Obstructing, Damage to Property W124 N8145 Hwy 145

Officers responded to Woodman's to assist Washington County Sheriff's deputies who were on scene looking for a suspect wanted for making terroristic threats in their jurisdiction. The suspect was located and identified. As the deputies and officers attempted to arrest the suspect he physically resisted. He was eventually handcuffed and placed in the back of the squad where he proceeded to kick the door of the Deputies vehicle causing \$3,000 worth of damage. The deputies eventually conveyed the suspect back to Washington County and our agency filed charges for the suspects actions that occurred at Woodman's.

23-015749 06-21-2023 Vehicle Theft W126 N8585 Westbrook Crossing

Officers responded to Novum Structures where the victim employee reported their Hyundai vehicle had been stolen. The victim advised there was broken glass near where he parked his vehicle. There was no suspect information the victim could provide. The vehicle was entered as stolen. On June 22nd the vehicle was recovered in Milwaukee, parked and unoccupied. Both plates had been removed. The owner was notified and no suspects have been identified in this case.

23-015753 06-21-2023 Attempted Vehicle Theft W130 N8691 Old Orchard Rd.

Officers responded to ER Wagner Co. to investigate an attempted vehicle theft. Upon arrival officers spoke to the victim who advised that after leaving work she discovered her Hyundai vehicle had a broken window and damage to the steering column. She did not see any suspects and based on the damage appeared as if the suspect(s) were trying to steal her car. During the investigation the officer was able to identify a suspect vehicle which was later determined to be another stolen vehicle reported out of Chicago, Illinois. No suspects have been identified in this case.



23-015986, 23-015989 Possession of Marijuana, Fentanyl, Cocaine, and Drug Paraphernalia, Resisting/Obstructing W12400 Block Fond Du Lac Ave.

An officer stopped a vehicle for traveling 46mph in a 30mph zone and improper display of the license plate. The suspect driver was contacted and the officer noted the strong odor of marijuana coming from the vehicle. The suspect admitted to smoking marijuana earlier in the evening and that his driver's license was suspended. The suspect was asked to step from the vehicle and a search of the vehicle revealed a black digital scale suspected to be used to weigh drugs. The second officer on scene who was with the suspect found several different drugs located in his clothing. At this point the suspect's girlfriend pulled up to the scene in a different vehicle. As the suspect was being walked to the squad he pulled away from officers, started to run while attempting to throw additional hidden drugs from his underwear to his girlfriend. The suspect girlfriend then grabbed the suspected drugs and ran from the officers. The officers were able to catch up to her and when she began to refuse commands a taser was utilized to control and take her into custody. She was found to be in possession of marijuana as well as the suspected drugs she grabbed. Both suspects were arrested and booked on several different drug charges as well as resisting and obstructing. The suspect driver was transported out to the Waukesha County jail and the female suspect was released from the police department.

23-015996 06-24-2023 Burglary, Vehicle Theft N88 W14060 Main St.

Officers responded to International Automobiles Incorporated to investigate a burglary where a vehicle had been stolen. Officers determined that an unknown suspect(s) forced entry into the service area and removed a customer's Volkswagen vehicle, striking another vehicle while in the process. Employees were interviewed and the scene was processed for evidence. The stolen vehicle's owner was notified and the vehicle was entered as stolen. On June 26th West Allis PD recovered the stolen vehicle after it was involved in a pursuit and abandoned. The vehicle was processed for evidence, returned to the owner. The case is still under investigation.

23-01600 06-24-2023 Possession of Drugs, Paraphernalia, Probation Violation, Warrants N88 W14750 Main St.

Officers and responded to the Delta Hotel parking lot for the report of medical call where someone was performing CPR on a subject. Upon arrival it was determined that three subjects were in a vehicle when one of the subjects experienced a drug overdose and stopped breathing. The other passengers stopped the car, called 911 and started doing CPR. Arriving officers administered Narcan and the subject became alert and was eventually transported to the hospital and was found to be in possession of fentanyl. A search of the vehicle revealed several items of drug paraphernalia. All three subjects were on probation and probation holds were placed on all subjects who were eventually arrested and transported out to the Waukesha County jail.
