



Menomonee Falls Police Department Notable Incidents for the Month of July 2023

23-016700 07-01-2023 Retail Theft, Obstructing, Warrants W124 N8145 Hwy 145

Officers responded to Woodman's for a suspect who attempted to steal a bottle of liquor. Officers contacted the suspect who provided a false name. The suspect was eventually arrested for retail theft and charged with obstructing for lying about her name. After determining her correct name and information she was found to have valid warrants for retail theft which were confirmed and she was booked on additional bail jumping charges. The suspect was transported out to the Waukesha County jail.

23-017194 07-06-2023 Carrying Concealed Weapon, Possession of Marijuana Appleton Ave./Joper Rd.

An officer stopped a vehicle for an equipment violation. Upon contacting the driver, the officer detected the odor of marijuana from the vehicle. A probable cause search of the vehicle revealed a loaded handgun on the floorboard. The passenger was searched and was found to have marijuana in their pants pocket and admitted to ownership of the handgun. Neither the driver nor the passenger had a CCW permit. The suspect passenger was arrested and booked on drug and CCW charges and the driver was released from the scene. The suspect posted bond and was released from the police department.

23-017308 07-08-2023 OWI 1st offenses, Possession of Marijuana and Drug Paraphernalia Appleton Ave./Main St.

An officer stopped a vehicle for an unlawful U-turn and failing to display registration plates. The officer contacted the driver who showed signs of impairment. The officer conducted field sobriety tests and eventually arrested the driver for OWI 1st offense. A search incident to arrest revealed the driver was in possession of THC cartridges and vape pens. The driver was booked on several charges and transported out to the Waukesha County jail.

23-017352 07-08-2023 Obstructing, Bail Jumping, Warrant W124 N8145 Hwy 145

Officers responded to Woodman's for the report of an intoxicated and disorderly customer. Once officers arrived the employees advised the suspect urinated in an aisle and was refusing to leave. Officers contacted the suspect who provided a false name during their investigation. After her real name was determined it was found that she had a valid felony arrest warrant and had existing felony bail conditions for absolute sobriety. She was arrested, booked on several charges and transported out to the Waukesha County jail.

23-017425 07-09-2023 OWI 1st W/Passenger under 16 N84 W15842 Appleton Ave.

The staff at Su Casa called in regarding a customer who had consumed a large amount of alcohol. Upon officer's arrival the located the customer who was operating a vehicle. The vehicle was stopped and the driver showed signs of impairment and there was also a 7-year old passenger in the vehicle. The driver was asked to perform field sobriety tests and was eventually arrested for OWI 1st offense with a minor passenger. The driver refused consent for a breath/blood test so a warrant was obtained and a force blood draw was conducted (cont.)



After the driver's arrest the remaining adult passenger was also under the influence and was not allowed to drive with the 7-year old. The passenger became aggressive and showed pre-attack posturing to officers and was eventually arrested for disorderly conduct and resisting/obstructing. The passenger was cited and released. A relative was eventually contacted to pick-up the three subjects.

23-017600 07-11-2023 Stolen Vehicle, Stolen Plates, Possession of Drugs, Possession of Stolen Property W180 N9393 Premier Ln.

Officers responded a FLOCK alert regarding a vehicle displaying stolen plates reported out of Milwaukee. The vehicle was located in the parking lot of Marcus Theaters. During the investigation the vehicle displaying the stolen plates was also a reported stolen vehicle out of Chicago. While officers were on-scene the operator and several passengers approached the vehicle and were interviewed. The passengers gave varying accounts and denied being in the stolen vehicle until video surveillance confirmed they arrived in it. Eventually the driver and one of the passengers were arrested for operating the stolen vehicle (driver and passenger), possession of stolen property and possession of drugs (suboxone). The driver was transported out to the Waukesha County jail and the passenger posted bond and was released from the police department.

23-017664 07-12-2023 Operating Auto Without Owners Consent (stolen vehicle) N56 W15654 Silver Spring Dr.

Officers responded to a FLOCK alert for a stolen Kia reported out of Milwaukee. The officers located and stopped the vehicle in Karl's Country Market parking lot. The driver was contacted and arrested for operating vehicle without owner's consent. The passenger was released from the scene. The vehicle had a broken window and the steering column had been damaged. The suspect driver was booked and transported out to the Waukesha County jail.

23-017749 07-13-2023 Carrying Concealed Weapon, Possession of Machine Gun, Operate Vehicle without Owner's Consent, Resisting/Obstructing, Possession of Cocaine and Drug Paraphernalia, Bail Jumping W124 N8145 Hwy 145

Officers responded to FLOCK alert for the report of a stolen license plate taken from Milwaukee. The plate was being displayed on a BMW. Officers located the vehicle in the Woodman's parking lot unoccupied. A check on the VIN number revealed that the vehicle was also stolen out of Milwaukee. This vehicle was reportedly taken in an armed robbery and the suspect was armed with a handgun. Video surveillance was reviewed to identify the driver of the vehicle who was located inside the store. Officers approached the suspect who failed to comply with the officer's commands and a taser was utilized to gain control and handcuff the suspect. Investigation determined the suspect was in possession of a modified handgun making it operate like a machine gun, cocaine, fentanyl, large amount of cash and cell phones. The suspect was also found to have five valid warrants and open cases requiring additional charges for bail jumping to be added. Milwaukee Police responded to process the vehicle for evidence. The suspect was booked on several charges and transported out to the Waukesha County jail.



23-018218 07-19-2023 Possession of Drugs and Paraphernalia, Warrants N88 W14060 Main St.

An officer observed a vehicle at 1:24 a.m. with its lights on at a closed business; International Autos. A record check of the vehicle registration revealed the listed owner had a valid felony drug warrant. The officer contacted the driver who advised he was charging his electric vehicle and refused to provide his name. The officer confirmed the physical descriptors and asked for a back-up officer. They re-approached the driver and advised the driver of the valid warrant at which time he provided his name. The warrant was confirmed and the driver was arrested. In addition, the investigation revealed the driver to be in possession of cocaine, fentanyl and assorted drug paraphernalia. The driver was booked and transported out to the Waukesha County jail.

23-018292 07-19-2023 Resisting/Obstructing, Possession of Drugs 15000 Block of Appleton Ave.

An officer stopped a vehicle for traveling 49 mph in a 30-mph zone. The officer stopped the vehicle and contacted the driver. The officer detected the smell of marijuana coming from the vehicle so he called for additional officers to assist with a probable cause search of the vehicle as there were multiple occupants. Once the back-up officers arrived the occupants were asked to step from the vehicle. The occupants did step from the vehicle and began to argue with the officers on scene. At one point one of the occupants (suspect one) walked back to the vehicle causing officers to physical direct him from the vehicle. Suspect one attempted to pull away and then resisted the officers' attempt to handcuff him. Suspect one was eventually handcuffed for resisting/obstructing. Another occupant (suspect two) admitted ownership to a backpack that was found to have marijuana in it. Suspect two was then arrested for possession of drugs. While suspect two was being arrest the last occupant (suspect three) attempted to interfere and was also arrested. The three suspects were arrested and booked on various charges. All three posted bond and were released from the scene.

23-018381 07-20-2023 Robbery w/Threat of Force W124 N8145 Hwy 145

Officers responded to Woodman's to investigate a retail theft. Investigation revealed that two unknown females suspects removed liquor and exited the store. Employees and security confronted the suspects who threatened and physically pushed the employees away and fled the scene. The suspect vehicle had a paper license plate and no other identifying information was available. This case is still being investigated.

23-018612 07-23-2023 Carrying Concealed Weapon N92 W16135 Falls Pkwy.

Officers responded to Firehouse Subs as an employee found a purse that a customer left behind. The employee went to find a name to determine the owner and observed a handgun in the purse. Officers contacted the customer who came back to the restaurant to claim the purse. The owner admitted ownership of the handgun. She did not have a valid CCW permit and was arrested, booked, posted bond and was released.



23-018807 07-26-2023 Possession of a Firearm by a Felon, Resisting/Obstructing, Possession of Drugs and Paraphernalia, Bail Jumping Fond Du Lac Ave./Danell Dr.

An officer stopped a vehicle for having no license plate and a defective headlamp. Upon contacting the suspect driver, the officer observed a digital scale and noted the odor of marijuana. The suspect driver was removed and was uncooperative and tried to pull away while being handcuffed. During the struggle the passenger fled from the vehicle with two of the backpacks. Officers and a canine tracked the passenger suspect's trail and located two abandoned backpacks containing three handguns, numerous magazines and ammunition, marijuana and assorted drug paraphernalia. The suspect could not be located. The suspect driver was arrested, booked on several charges and transported out to the Waukesha County jail. The suspect passenger was identified and a request for numerous charges was forwarded to the Waukesha County District Attorney's Office.
