



Menomonee Falls Police Department Notable Incidents for the Month of September 2023

23-021898/23-021904 09-01-2023 Retail Theft, Possession of Drugs, Bail Jumping, Warrant Arrest N95 W18000 Appleton Ave.

Officers responded to Kohl's Department store for a retail theft in progress in which approximately \$700.00 worth of merchandise was stolen. Upon arrival the officer located the suspects in a vehicle leaving the scene. The vehicle was stopped and two suspects were identified. The first suspect was arrested for retail theft, bail jumping and a valid warrant. The second suspect was arrested for possession of illegally obtained prescription drugs, bail jumping and valid warrants. Both suspects were booked and transported out to the Waukesha County jail.

23-021993 09-02-2023 Battery DV, Criminal Damage to Property, Resisting/Obstructing, Disorderly Conduct N85 W15900 Appleton Ave.

Officers were dispatched to a fight in progress in front of Classic Lanes. Upon arrival officers learned that the suspect was arguing with his live-in girlfriend and at some point, struck her in the face causing injury. The suspect was intoxicated and physically resisted officers as they tried to arrest him. Once handcuffed, the suspect caused damage to the squad car. The suspect was booked on several charges and transported directly out to the Waukesha County jail.

23-022016 09-03-2023 Battery to Healthcare Worker, Disorderly Conduct, Probation Violation W180 N8085 Townhall Rd.

Officers responded to Froedtert Hospital regarding a disruptive patient. Investigation determined a patient had thrown a chair injuring a nurse. The suspect continued to be disruptive and caused a disturbance in the hospital. A wanted check revealed the suspect was on probation. The suspect was arrested, booked and transported out to the Waukesha County jail.

23-022031 09-03-2023 Operating while Intoxicated 1st Hoyt Dr./Roosevelt Dr.

Officers were dispatched to the area for the report of a female driver slumped over the wheel of a U-Haul truck with the driver's door open. EMS also responded due to the unknown condition of the driver. Once on scene, the officers noted the strong odor of intoxicants on the driver's breath. The suspect admitted to driving and had been drinking earlier in the day. The suspect was placed through field sobriety tests and was eventually arrested for OWI 1st offense. The suspect was booked and released to a responsible adult.

23-022330 09-07-2023 Possession of Cocaine, Bail Jumping, Warrant Arrest N88 W14060 Main St.

An officer observed a suspect charging his vehicle at International Autos at 2:30 a.m. Back in July, while charging his car late at night, this same suspect was arrested for a drug and warrant offenses. The officer noting this prior incident, contacted the suspect who was found to have a valid arrest warrant. The suspect was arrested after which the officer observed suspected drug paraphernalia in plain view in the suspect's vehicle. A search of the vehicle revealed suspected cocaine. The suspect was booked on several charges and transported out to the Waukesha County jail.



23-022424 09-08-2023 Vehicle theft, Fleeing/Eluding N55 W19800 Block Magnolia Ln.

Officers responded to the area for the report of a stolen Acura vehicle from the driveway. Officers located the stolen vehicle along with two other vehicles traveling at a high rate of speed. Based on all three vehicles' similar speed and direction it was clear they were involved in this incident. Officers pursued the stolen vehicle. All three vehicles continued to flee in the same direction while disregarding traffic lights. Due to the reckless driving, the pursuit was terminated. Contact was made with the victim who advised the vehicle was left unlocked and possibly with the spare key left inside of it. Follow-up investigation revealed that at least one of the other three vehicles pursued was stolen that night from Sussex. The victim's Acura was later recovered in Milwaukee along with the stolen vehicle from Sussex. Evidence was collected from the scene and the investigation is on-going.

23-022474 09-08-2023 Operating While Intoxicated 3rd, OWI Causing Injury, Operating after Revocation W13000 Block Fond Du Lac Ave.

Officers were dispatched to a two-car injury crash in front of Sportz Pub and Grill. Upon arrival the officers contacted the suspect driver who showed signs of intoxication. It was determined that the suspect, who had been drinking at the bar, left in his vehicle and struck another vehicle traveling on Fond Du Lac Ave. Occupants of that vehicle advised of minor injuries they sustained and EMS was called to the scene. A record checked showed the suspect's license was revoked and he had two prior OWI convictions. The suspect was placed through field sobriety tests and arrested for OWI and OWI causing injury. He was then taken to the hospital for a blood draw. The suspect was booked, issued several citations and transported out to the Waukesha County jail.

23-023053 09-15-2023 Operate Vehicle without Owner's Consent, Fleeing/Eluding W124 N8145 Hwy 145

An officer attempted to stop a Tesla for driving through an intersection on a red light. As the officer attempted to stop the vehicle it fled at a high rate of speed. The officer lost visual of the vehicle and terminated the pursuit. A short time later the Milwaukee Police Department pursued the same vehicle until it crashed with three juvenile suspects inside. The three suspect juveniles were arrested and identified as the same suspects in this case. Criminal charges were referred to the Waukesha County District Attorney's Office for review.

23-023514 09-21-2023 Burglary, Vehicle Theft W190 N5000 Block Sunset Dr.

An officer was called to investigate a residential burglary. The officer spoke with the victim who advised that an unknown suspect entered their residence through an unlocked door, removed cash and a car key from a purse and stole the victim's vehicle from the garage. The scene was processed for evidence and neighbors were interviewed. A few days later the vehicle was recovered unoccupied in Milwaukee. The vehicle was processed for evidence and returned to the owner; the investigation is on-going.



23-023927 09-26-2023 Vehicle Theft W208 N6800 Block Filmore Dr.

An officer was dispatched to investigate a vehicle theft. The victim advised that while they were out of town an unknown suspect stole their vehicle. The scene was searched for possible evidence and neighbors were contacted. However, no further suspect information was developed. The vehicle was entered as stolen and has not been recovered at the time of this report. This investigation is on-going.

23-023995 09-27-2023 Disorderly Conduct DV, False Imprisonment, Bail Jumping, Warrant arrest N78 W14545 Appleton Ave.

Officers responded to several reports of a male and female fighting outside a vehicle near the US Bank building. Upon arrival it was determined that male suspect choked and injured the victim. The suspect also prevented the victim from leaving the area. Further investigation revealed the suspect had two valid warrants and an open criminal case. The suspect was arrested and booked on several charges and transported out to the Waukesha County jail.

23-024110 09-28-2023 Battery DV, Placing of combustible materials an attempt to create arson W132 N6300 Block Marach Rd.

Several officers were dispatched to a domestic violence incident in-progress. The initial call was received from a concerned family member. Contact was made with the victim who advised her suspect husband had struck her several times causing injuries. As the suspect was being handcuffed, the officers noted the smell of gasoline. The suspect admitted to pouring gasoline around the house with the intent of burning the house down. Evidence on scene confirmed this. The suspect was booked on several charges and transported out to the Waukesha County jail.
