



Menomonee Falls Police Department Notable Incidents for the Month of November 2023

23-026881 11-01-2023 Theft W182 N5800 Block Spruce Ln.

The victim contacted the police to report a theft. The victim advised that they received a warning on their computer. The victim followed the prompts which led to making phone contact with an unknown suspect posing as a fraud investigator. The suspect advised the victim that their bank account was hacked and was able to convince the victim to withdraw a large amount of cash from the bank. The victim was instructed to transfer the cash into a bitcoin wallet. Once the cash was transferred was completed the suspect ceased all communication and the victim realized they had been scammed. Due to these types of transactions there was not enough information to identify a suspect.

23-026867 11-02-2023 Fleeing/Eluding, Possession of Marijuana Ridgewood Dr./Silver Spring Dr.

An officer attempted to stop a vehicle for a speed violation. The vehicle fled at a high rate of speed and the officer pursued it. The vehicle then abruptly stopped where a high-risk traffic stop was conducted. The suspect was arrested and marijuana was found inside the vehicle. The suspect was booked and transported out to the Waukesha County jail.

23-027027 11-04-2023 Operating While Intoxicated, Felony Bail Jumping N88 W15167 Main St.

Officers responded to the BP Gas Station involving an altercation between two people. One of the involved subjects was located driving away and was stopped. This suspect showed signs of intoxication and was on bail for a felony offense (battery to law enforcement officer) with an absolute sobriety condition. He was put through field sobriety tests and arrested for OWI 1st and felony bail jumping. He was booked and transported out to the Waukesha County jail.

23-027093 11-04-2023 Possession of Drugs (multiple), Probation Violation Pilgrim Rd./ Cleveland Ave.

An officer stopped a vehicle for a registration violation. Upon contacting the driver, the officer noted the smell of marijuana. A search of the vehicle revealed a small bag of marijuana, and a pill containing MDMA and fentanyl. The suspect was found to be on probation and a probation hold was requested. The suspect was arrested, booked and transported out to the Waukesha County jail.

23-027159 11-05-2023 Operating While Intoxicated 1st, Go Armed While Intoxicated Lisbon Rd./Greenview Ave.

An officer stopped a vehicle for a speed violation. The officer contacted the driver who showed signs of impairment. The driver was put through filed sobriety tests along with a PBT result of .122. The driver was arrested for OWI 1st offense. A search incident to arrest revealed a loaded handgun in the center console. Although the driver did have a CCW permit they were intoxicated and in violation of the law. The suspect was booked, posted bond and released to a responsible adult.



23-027497 11-09-2023 Vehicle Theft N92 W14701 Anthony Ave.

The victim called police to report their Honda vehicle was stolen from the parking lot while they were at work. There was no immediate suspect information to follow-up on. On 11-11-2023 Mequon PD located, stopped and detained the driver that was in the stolen vehicle. The driver was found not be responsible for the theft or aware of the stolen vehicle. The owner was contacted and recovered their vehicle. During the initial investigation at the business, a stolen vehicle previously reported out of Milwaukee was also located. That vehicle was released to the owner.

23-027662 11-12-2023 Disorderly Conduct, Resisting/Obstructing N68 W13900 Block Oakwood Dr.

At 4:55 a.m. officers were called to a residence where the victim reported a known and intoxicated suspect was outside their door causing a disturbance. Officers arrived and contacted the suspect who appeared intoxicated and smelled of marijuana. The suspect was observed on camera acting erratic and damaging property outside the house. The suspect was arrested, but continued to resist and once inside the squad attempted to kick the windows and spit over the backseat. The suspect was transported out to the Waukesha County jail where he continued to resist officers and jail staff.

23-027663 11-12-2023 Theft of Mail, Possession of Drugs and Paraphernalia, Warrant Arrest Pilgrim Rd./Glory Haven Ln.

Police responded to the report of an impaired suspect who was also witnessed stealing mail. Officers stopped the suspect who was found to have a valid arrest warrant through the Racine County Sheriff's Department. A search incident to arrest revealed cocaine, prescription drugs and drug paraphernalia. The suspect was arrested, booked on several charges and transported out to the Waukesha County jail.

23-027953 11-15-2023 Felon in Possession of a Firearm, Carrying Concealed Weapon, Possession of Drugs and Paraphernalia Good Hope Rd./Pilgrim Rd.

An officer stopped a vehicle for inattentive driving. The officer contacted the driver and noted the smell of marijuana coming from the vehicle. A search of the vehicle located a loaded handgun under the driver's seat and marijuana. The suspect was a convicted felon and prohibited from owning/carrying a firearm. The suspect also had prior convictions for possession of marijuana. The driver was arrested, booked on several charges and transported out to the Waukesha County jail.

23-028291/23-028296 11-19-2023 Battery to Police Officer, Resisting/Obstructing, Damage to Property, Disorderly Conduct W169 N8700 Block Sheridan Dr.

Officers responded to domestic violence incident where the known suspect arrived intoxicated and caused a disturbance while damaging exterior Christmas decorations. This caused the victim to fear for their safety. Officers spoke with the suspect and advised they were under arrest. The suspect resisted, flailed their arms and attempted to pull away from the officers. The suspect was



eventually handcuffed and attempted numerous times to kick the officers. While being placed in the vehicle the suspect was able to kick an officer in the abdomen causing the officer pain. Due to the continued resistance and assaultive behavior, the suspect was transported directly out to the Waukesha County jail.

23-029012 11-29-2023 Carrying Concealed Weapon Madison Ave./Main St.

An officer stopped a vehicle for a defective stop lamp. Upon contacting the driver, the officer noted the smell of marijuana. The suspect driver was advised of the probable cause search that was going to be conducted when they admitted to having a loaded handgun in their purse. The suspect did not have a valid CCW permit and was arrested for that violation. The suspect was booked and was transported out to the Waukesha County jail.

23-029098 11-30-2023 Possession of Marijuana with Intent to Distribute-While Armed US 41/Main St.

An officer stopped a vehicle for suspended registration. The officer contacted the driver and noted the smell of marijuana. A probable cause search revealed a loaded handgun, a large amount of marijuana, a scale, multiple cell phones and cash. The suspect was arrested on a charge of possession with intent to sell/distribute with a firearm enhancer. The suspect was booked and transported to the Waukesha County jail.
