



Menomonee Falls Police Department Notable Incidents for the Month of February 2024

24-3130 02-06-2024 Burglary N72 W13500 Block Lund Ln.

An officer responded to a burglary complaint from a resident of the apartment complex. The victim advised their storage locker had been forcibly entered and items were removed. During the investigation it was determined this same suspect may be responsible for other similar incidents reported over the last few months. Evidence to include video surveillance was obtained. All related cases are still under investigation.

24-3293 02-08-2024 Fleeing/Eluding Appleton Ave./Homestead Dr.

An officer attempted to stop a vehicle for traveling 60 mph in a 30-mph zone. The driver failed to pull over and fled at a high rate of speed. The officer initiated a pursuit in attempt to stop the vehicle. Due to the reckless speed and driving of the fleeing vehicle, the officer terminated the pursuit. The officer was not able to obtain a plate and no suspects have been identified in this incident.

24-3491 02-10-2024 Fleeing/Eluding Lilly Rd./Good Hope Rd.

An officer attempted to stop a vehicle for a speed and a lane deviation violation. The vehicle failed to stop and fled at a high rate of speed. The officer pursued the vehicle until it came to a stop just into Milwaukee. The suspect driver was arrested, booked and transported out to the Waukesha County jail on a felony fleeing charge.

24-3526 02-11-2024 Operating While Intoxicated 1st, Resisting/Obstructing Flint Dr./Good Hope Rd.

At about 5:15 a.m. Officers were dispatched to investigate a suspicious vehicle that was off the roadway. Upon arrival officers observed a vehicle in the ditch with substantial front-end damage as it appeared to have struck several small trees before coming to a stop. The officers contacted the driver who appeared to be sleeping. The driver also showed signs of impairment and was asked to perform field sobriety tests. The driver was arrested and while being placed in the back of the squad the suspect physically resisted. The suspect eventually complied, was booked, cited and released to a responsible adult.

24-3883 02-15-2024 Retail Theft N94 W16855 Falls Pkwy.

Officers responded to Best Buy to investigate a retail theft. Upon arrival officers learned that four suspects working together stole approximately \$3000 worth of merchandise and fled the scene. The suspects had removed anti-theft devices and hid the merchandise prior to exiting the store. Surveillance evidence was obtained and a public crime alert was sent out to help identify the suspects. No suspects have been identified in this incident.

24-3958 02-16-2024 Theft N88 W14750 Main St.

Officers responded to the Delta Hotel for a report of an employee theft. The officer spoke with the reporting person who advised that a former employee made several fraudulent credit card returns amounting to several thousands of dollars. It was discovered due to the large dollar amounts. The suspect used a card they had previously used, utilized a computer with their logon credentials and it was also captured on video surveillance. This case is active pending location, arrest and interview of the suspect.



24-4007 02-17-2024 Operating While Intoxicated 1st Menomonee Ave./Shady Ln.

At 1:00 a.m. officers were dispatched to a vehicle in the ditch as the caller observed the vehicle's lights were still on. The officer noted the vehicle appeared to have driven straight south on Shady Ln. through the T-intersection and continued straight across Menomonee Ave. into the ditch as there was no roadway to continue south onto. The officer observed a lone occupant in the rear of the vehicle talking on a cellphone. The officers observed signs of impairment and had the driver perform field sobriety tests. The driver was eventually arrested and submitted to a breath test. The driver was booked, cited and released to a responsible adult.

24-4116 02-18-2024 Operating While Intoxicated 4th, Bail Jumping, Operating after Revocation

An officer stopped a vehicle for an equipment violation. Upon contacting the driver, the officer noted signs of impairment and asked the driver to perform field sobriety tests. Based on those tests the driver was arrested for OWI and was determined to have three prior convictions. The driver also had an open felony case in Milwaukee County. The driver's license status was revoked and the driver had also failed to install an ignition interlock device. The driver was arrested and a search warrant was obtained for a forced blood draw. After the blood draw was completed the suspect was booked on several charges, issued citations and transported out to the Waukesha County jail.

24-4142 02-19-2024 Retail Theft, Warrant Arrest N83 W15701 Appleton Ave.

Officers responded to a retail theft in progress at Walgreens. The reporting person advised the suspect was leaving in a vehicle and provided a description of the suspect and the vehicle. The vehicle was located and stopped. Investigation confirmed a retail theft had occurred and the suspect was arrested. A wanted check revealed the suspect also had an active warrant for retail theft through the Milwaukee County Sheriff's Office. The suspect was booked and transported out to the Waukesha County jail.

24-4232 02-20-2024 Carrying Concealed Weapon Town Hall Rd./Tours Dr.

An officer stopped a vehicle for expired registration. After requesting the driver's insurance card, the driver advised that it was in his center console where he also had a loaded handgun. The driver did not have a valid CCW permit and was arrested for carrying a concealed weapon. The driver was booked, posted bond and was released.

24-4375 02-22-2024 Vehicle Theft W146 N7000 Block Winter Hollow Dr.

An officer responded to a residence to investigate a theft of a truck. The victim advised that the truck had been parked in the driveway and had been stolen sometime during the overnight hours. The victim advised that they thought they had locked the vehicle, but there may have been a key fob in the vehicle at the time of the theft. A Flock search confirmed the stolen vehicle in Milwaukee at 3:28 a.m. the day it was stolen. The victim later determined they had credit cards in their vehicle that were used for fraudulent transactions. Several days later the stolen truck was recovered in Milwaukee without any license plates. This investigation is on-going.



24-4514 02-23-2024 Operating While Intoxicated 5th, Resisting/Obstructing Marcy Rd./Mill Rd.

Officers responded to a single vehicle accident at the intersection of Marcy Rd. and Mill Rd. The witness reported seeing a vehicle traveling too fast, left the roadway, struck a fence and was now stuck in a field. Officers contacted the driver who appeared to be impaired and smelled of intoxicants. The driver was asked to perform field sobriety tests numerous times and refused. The officers went to arrest the driver for OWI and he began to physically resist the officers. The driver was eventually handcuffed and transported to the hospital where a search warrant was obtained for a forced blood draw. The driver was found to have four prior convictions for OWI. The driver was booked and transported out to the Waukesha County jail.
