



## Menomonee Falls Police Department Notable Incidents for the Month of March 2024

### **24-005116 03-02-2024 Carrying a Concealed Weapon, Go armed while Intoxicated, Operating While Intoxicated 1st Good Hope Rd./Raw Amber Ct.**

Officers responded to a report of a possible intoxicated driver where the witness reported seeing the vehicle all over the roadway. The vehicle was located and stopped. The officers spoke with the driver who showed signs of intoxication. The driver was asked to perform field sobriety tests and based on those tests was arrested for OWI first offense. A search of the vehicle revealed a loaded handgun underneath the driver's seat as well as an open alcohol container. The driver did not have a valid CCW license and admitted ownership of the gun. The driver was booked on several charges, posted bond and was released to a responsible adult.

### **24-005161 03-02-2024 Carrying a Concealed Weapon, Possession of a Short-Barreled Rifle, Possession of Drugs and Paraphernalia Appleton Ave./University Dr.**

An officer stopped a vehicle for failing to yield the right-of-way and having suspended registration. As the officer stepped up to the driver's side window he observed a Glock handgun laying on the front seat with a stock attached to it. The officer advised the driver not to reach for the gun. The officer also noted the smell of marijuana coming from the vehicle. The driver was asked to step from the vehicle and admitted that he did not have a CCW permit. A search of the car revealed suspected marijuana along with a glass pipe with additional suspected marijuana inside it. The driver was arrested and booked on numerous charges and transported to the Waukesha County jail.

### **24-005317 03-05-2024 Disorderly Conduct, Criminal Damage to Property W164 N8700 Block Mill St.**

Officers responded to a neighbor dispute. There had been on-going issues between two subjects in the building. It was reported that the suspect intentionally damaged property, was intoxicated and causing a disturbance in the hallway. Upon arrival officers located the suspect in the hallway and noticed he was armed with a knife. The suspect complied with officers and dropped the knife. The suspect was arrested, booked on multiple charges and transported to the Waukesha County jail.

### **24-005450 03-06-2024 Fleeing/Eluding Pilgrim Rd./Longwood St.**

An officer clocked a vehicle traveling 58 mph in a 40-mph zone. The officer attempted to stop the vehicle which fled at a high rate of speed so the officer pursued the vehicle. Other officers assisted until the pursuit was terminated due to the reckless speed and actions of the fleeing vehicle. There was limited information in which to identify the suspects and no arrests have been made in this case.

### **24-005691 03-09-2024 Battery, Disorderly Conduct, Use of a Dangerous Weapon-Domestic, Bail Jumping N85 W14100 Block Fond Du Lac Ave.**

Officers met with Milwaukee Police Officers who were investigating a domestic battery incident that occurred in Milwaukee. Officers from both departments went to the Menomonee Falls address where the suspect and victim were located. It was determined the suspect had committed multiple offenses of domestic violence in Milwaukee and Menomonee Falls. The suspect was arrested and found to be out on bond on a previous domestic violence case. Suspect was booked, unable to post bond and was transported out to the Waukesha County jail.



**24-006057 03-15-2024 Vehicle Theft N65 W13700 Block Lilly Creek Dr.**

An officer responded to a residence where the victim advised their Nissan vehicle had been stolen. Investigation revealed the vehicle was left unlocked with the keys inside it and it was removed sometime during the overnight hours. The vehicle was entered as a stolen vehicle and neighbor contacts were made. At this time the vehicle has not yet been recovered and no arrests have been made.

**24-006282 03-16-2024 Resisting/Obstructing, Retail Theft, Fleeing/Eluding, Bail Jumping, Warrants N95 W18000 Appleton Ave.**

Officers responded to a retail theft in progress at Kohls Department store. Store loss prevention confirmed the suspects stole items and fled in a red Chevrolet. Officers located the suspect vehicle and attempted to stop the vehicle. Stop sticks were used to deflate the fleeing vehicle's tires. The vehicle eventually stopped and the suspects fled on foot. The driver was located, arrested and found to have valid warrants. The suspect driver was booked on several additional charges and transported out to the Waukesha County jail. The passenger was not located, but was later identified and had charges referred out to the Waukesha County District Attorney's office for his involvement.

**24-006439 03-18-2024 Possession of Drugs (Fentanyl & Cocaine) and Paraphernalia, Bail Jumping N85 W15900 Appleton Ave.**

Officers responded to the underground parking garage near Classic Lanes for an intoxicated subject laying on the ground near a car. Officers contacted the subject and during their contact the subject appeared to be intoxicated. A check revealed this subject had several open court cases with an absolute sobriety bail condition. A police canine was called and alerted on the subject's vehicle. A search revealed numerous drugs and drug paraphernalia in the car. The subject was arrested, booked and transported to the Waukesha County jail.

**24-006599 03-20-2024 Operating While Intoxicated 7<sup>th</sup> Fond Du Lac Ave./Main St.**

An officer stopped a vehicle for traveling 56 mph in a 30-mph zone. The officer contacted the driver who appeared to show signs of intoxication. A driver's record check revealed the driver had six prior convictions for OWI. The suspect was asked to perform field sobriety test after which they were arrested for OWI. The suspect was taken for a blood draw and eventually brought to the police department to be booked. The suspect was transported to the Waukesha County jail.

**24-006740 03-23-2024 Operating While Intoxicated 7<sup>th</sup>, Possession of Fentanyl & Unauthorized Prescription Medication, Felony Bail Jumping Pilgrim Rd./Main St.**

Officers responded to a subject slumped over the steering wheel in the intersection. A citizen witness woke the driver who then pulled into the Kwik Trip. Officers contacted the suspect driver who appeared to be under the influence of drugs. The suspect was asked to perform field sobriety tests. Based on those tests the suspect was arrested and taken for a blood draw. A records check revealed the suspect had six prior OWI convictions. A search of the suspect and vehicle revealed the suspect was in possession of Fentanyl and prescription drugs that he did not have a valid prescription for. The suspect was also found to have open felony drug cases requiring absolute sobriety and to not possess drugs. The suspect was booked on several charges and transported to the Waukesha County jail.



**24-006914 03-25-2024 Fleeing/Eluding Appleton Ave./North Hills Dr.**

An officer attempted to stop a black Nissan for having no license plates displayed. The officer initiated a traffic stop and the vehicle initially pulled over, but fled as the officer approached on foot. The officer initiated a pursuit and attempted to stop the vehicle. Based on the reckless speed and actions of the fleeing vehicle the officer terminated the pursuit. Due to a lack of information to follow-up on, no suspects have been identified or arrested in this case.

**24-007010 03-26-2024 Fleeing/Eluding Good Hope Rd.**

An officer attempted to stop a grey BMW for traveling 62 mph in a 40-mph zone. As the officer attempted to stop the vehicle it sped away at a high rate of speed. Due to the fleeing vehicle's speed and recklessness the officer terminated the pursuit. This case is actively being investigated as the vehicle was displaying a plate.

**24-007166 03-28-2024 Fleeing/Eluding Silver Spring Dr./One Mile Rd.**

An officer attempted to stop a maroon Honda for traveling 61 mph in a 45-mph zone. The suspect vehicle slowed down onto the shoulder and came to a stop, but then fled at a high rate of speed. At one point the vehicle was traveling in the opposite lane of traffic as it fled eastbound on Silver Spring Dr. Due to the speed and reckless driving of the fleeing vehicle, the officer terminated the pursuit. As the officer conducted his investigation it was learned the vehicle had just been stolen out of Sussex, but had not been entered stolen into the system. There was no suspect information to follow-up on and no arrests have been made in this case.

**24-007382 03-30-2024 Fleeing/Eluding Appleton Ave./Good Hope Rd.**

An officer attempted to stop a black Toyota for failing to yield for an emergency vehicle. The suspect vehicle fled at a high rate of speed and the officer initiated a pursuit. Due to the fleeing vehicles gaining distance from the pursuing officer, the officer terminated the pursuit. The officer was unable to obtain the plate number or identify any occupants. No suspects have been identified in this case.
