



## Menomonee Falls Police Department Notable Incidents for the Month of April 2024

### **24-007642 04-03-2024 Possession of Drugs, Operating while Intoxicated 1<sup>st</sup> Hwy 41/Pilgrim Rd.**

Officers were dispatched to a single vehicle crash on the highway. The vehicle was located and the driver was found to be unresponsive. Based on their observations, the officers determined the driver was experiencing an opiate overdose. Narcan was administered and the driver regained consciousness. As officers removed the driver from the vehicle suspected drugs fell out of his sweatshirt and other suspected drugs were located in the vehicle. The drugs were determined to be cocaine and fentanyl. The driver was asked to perform field sobriety tests and was eventually arrested for possession of drugs and operating while intoxicated. The driver received medical treatment and was eventually booked, issued citations and transported out to the Waukesha County jail.

### **24-007662 04-04-2024 Possession of Drug Paraphernalia, Bail Jumping, Warrants W156 N8327 Pilgrim Rd.**

Officers were dispatched to Walgreens to investigate a retail theft. Upon arrival two suspects were stopped in a vehicle and the third suspect was somewhere on foot in the area. The suspects in the vehicle were identified and Walgreens advised if all stolen products were returned they would not prosecute. The two suspects returned the stolen property, were identified and trespassed from the store. The third suspect was located near the business in possession of stolen items. A wanted check revealed the suspect had five valid felony warrants. The suspect also had two open circuit cases and was in violation of his bail conditions. The suspect was arrested, booked and transported out to the Waukesha County jail.

### **24-007694 04-03-2024 Retail Theft N95 W18351 County Line Rd.**

Germantown Police Department stopped a suspect responsible for several retail thefts in their jurisdiction. During their on-scene investigation other stolen items were located which were stolen from the Menomonee Falls Metro Market. Our officers responded and contacted Metro Market who reviewed video surveillance confirming the suspect had stolen approximately \$300 in liquor. Once the suspect was processed through Germantown PD, our officers took custody of the suspect who was then booked and transported out to the Waukesha County jail.

### **24-007725 04-04-2024 Fleeing/Eluding Westwood Dr./Good Hope Rd.**

Officers responded to a Flock alert regarding a grey BMW that had previously fled from our officers during a different traffic stop. The vehicle was located and officers attempted to stop it. The vehicle fled at a high rate of speed. The officers initiated a pursuit in an attempt to stop the vehicle. Based on the suspect vehicle's speed and recklessness the officers terminated the pursuit. This case is on-going in an attempt to identify the suspect driver.

### **24-007924 04-07-2024 Battery (Domestic Violence), Possession of Cocaine W169 N8900 Block Hoyt Dr.**

Officers responded to a domestic violence call where the victim reported her boyfriend struck her in the face causing pain. The suspect was uncooperative with the police and probable cause was established to arrest him for battery. A search incident to arrest revealed the suspect was in possession of cocaine. The suspect was booked, posted bond and was released.



**24-008060 04-08-2024 Strangulation, False Imprisonment (Domestic Violence), Child Neglect N83 W15600 Block Apple Valley Dr.**

Officers responded to a domestic violence incident where the victim reported being assaulted by her suspect boyfriend. Prior to the officer's arrival the suspect fled from the residence. Officers interviewed the victim who stated her boyfriend had been drinking and started to argue with her and at one point it became physical where the suspect choked the victim, took her cell phone away from her and prevented her from leaving. This occurred while she was holding her young daughter. The victim has visible injuries noted by the officers. Other officers located and arrested the suspect who was located at McDonalds down the road. The suspect was booked and transported out to the Waukesha County jail.

**24-008065 04-08-2024 Aggravated Battery, 2<sup>nd</sup> Degree Recklessly Endangering Safety Silver Spring Dr./Town Line Rd.**

Officers responded to assist the Waukesha County Sheriff's Deputies who had two vehicles stopped with several occupants inside who had been identified as suspects from a battery investigation that occurred in the Town of Lisbon. During their investigation they determined that one of the victims had also been assaulted in Menomonee Falls. The victim, who was being treated at the hospital, was interviewed. The victim advised that after the battery incident in the Town of Lisbon she attempted to keep the suspects on scene by jumping in their car. They then drove her into Menomonee Falls where they punched and dragged her from the car. The suspects then drove over her ankle as they fled. The suspects involved were booked on felony charges and transported out to the Waukesha County jail.

**24-008155 04-10-2024 Resisting/Obstructing, Possession of Drugs & Paraphernalia, Bail Jumping, Warrants**

An officer observed a vehicle parked with its lights on in the Walgreens parking lot for approximately 30 minutes around 1:30 a.m. The officer contacted the driver who appeared to be sleeping. The officer also observed a glass bong (drug paraphernalia) in plain view inside the vehicle. The officer was able to finally wake the driver who appeared disoriented. The driver became uncooperative, refused the exit the car and tried to hide the glass bong. After the driver finally exited the vehicle a crack cocaine pipe was observed on the driver's seat. During that contact the driver fled on foot and was quickly stopped and arrested. A search of the vehicle revealed drug paraphernalia, cocaine, marijuana and illegal prescription drugs. The driver was also found to have valid warrants and open court cases adding felony bail jumping to her charges. The driver was booked on several charges, including resisting/obstructing and transported out to the Waukesha County jail.

**24-008494 04-13-2024 Criminal Damage to Property, Possession of Marijuana, disorderly Conduct, Resisting/Obstructing, Bail Jumping Pilgrim Rd./US Hwy 41.**

Officers responded to the area around Mr. Brew's Taphouse for a suspect who was chasing people and kicking vehicles around 8:00 p.m. The suspect was located walking on the on-ramp to the highway. The suspect was acting erratic and refused to cooperate with the officer's commands. Officers utilized a conducted electronic weapon (taser) to take the suspect into custody. The suspect had six open misdemeanor cases. He was medically cleared, booked on several charges and transported out to the Waukesha County jail.



**24-008622 04-15-2024 Carrying Concealed Weapon, Possession of Drugs and Paraphernalia W168 N9100 Block Garden Ave.**

Officers were dispatched to check on the welfare of a suspect who was reportedly in possession of a firearm. While enroute to the residence the caller advised the suspect was now leaving in a vehicle. The vehicle was located and a high-risk stop was initiated. Officers on scene negotiated with the suspect to ensure the safety of all involved. The suspect eventually surrendered without incident. The suspect was found to be in possession of marijuana and drug paraphernalia as well as a loaded AR-15 style rifle that was found hidden inside the front passenger area of the vehicle. The suspect was booked on numerous charges and transported out to the Waukesha County jail.

**24-008652 04-15-2024 Carrying Concealed Weapon, Possession of Marijuana Pilgrim Rd./Main St.**

An officer stopped a vehicle for having suspended registration. The officer contacted the suspect driver who admitted to having marijuana in his vehicle. The officer eventually conducted a search of the vehicle and located a loaded 9mm handgun. The suspect did not have a valid CCW permit for the handgun. The suspect was arrested, booked, posted bond and was released.

**24-008850 04-18-2024 Fleeing/Eluding Appleton Ave./Northpoint Dr.**

Officers responded to a Flock alert on a stolen Infiniti vehicle reported out of Blue Island, Illinois. The vehicle was located and the officers attempted to stop the vehicle. The vehicle fled at a high rate of speed and a pursuit was initiated. Due to the suspect vehicle's speed and recklessness the pursuit was terminated. No suspects or arrests have been made in this case and it is inactive.

**24-009378 04-24-2024 Eluding/Fleeing Appleton Ave./Good hope Rd.**

Officers responded to the area for a Flock alert on a stolen Kia reported out of Milwaukee. The vehicle was located and the officers attempted to stop the vehicle. The vehicle fled at a high rate of speed and a pursuit was initiated. Due to the suspect's high rate of speed and recklessness the pursuit was terminated. No suspects or arrests have been made in this case and it is inactive.

**24-009633 04-27-2024 Operate Auto Without Owner's Consent, Possession of Drugs County Line Rd./Bancroft Dr.**

Officers responded to the location for a Flock alert on a stolen Honda reported out of Milwaukee. The vehicle was located in the drive-thru at Chick-Fil-A. The officer contacted the suspect and also noted the smell of marijuana coming from the vehicle. The suspect exited the vehicle while officers confirmed the stolen status. The suspect was arrested for operating auto without owner's consent. A search of the vehicle revealed marijuana and hallucinogenic drugs. The suspect was booked and transported out to the Waukesha County jail.
