Notable Incidents for the Month of May 2024

24-010481 05-08-2024 Fleeing/Eluding Silver Spring Dr./Creekwood Crossing

An officer observed a dark colored Hyundai traveling at a high rate of speed. The officer clocked the vehicle's speed at 64 mph in a 45 mph-zone. The officer attempted to stop the vehicle which increased its speed in an attempt to elude the officer. The officer continued to pursue the suspect vehicle until its speed was increased to where the officer could no longer see it, at which time the officer terminated the pursuit. The vehicle was last seen eastbound into Milwaukee. No suspects have been identified in this incident.

24-010604 05-09-2024 Operate Vehicle without Owner's Consent, Carrying a Concealed Weapon, Fleeing/Eluding, Possession with Intent to Deliver (Marijuana & Fentanyl) Appleton Ave./River Crest Dr.

Officers were alerted to a stolen white Cadillac that was taken from Onalaska, WI. The vehicle had been reportedly involved in other crimes as well. Officers located the vehicle and attempted to stop it. The vehicle fled and officers pursued it. The vehicle fled eastbound and other involved officers were able to utilize tire deflation devices greatly slowing the fleeing vehicle. The vehicle eventually stopped on US Hwy 41 and a high-risk stop was initiated. Two suspects were located and arrested. The suspect driver and passenger were both booked on several charges and transported out to the Waukesha County jail. Onalaska PD was notified of the recovered stolen vehicle and the suspect's information for follow-up.

24-010717 05-10-2024 Go Armed w/Firearm While Intoxicated, Operating While Intoxicated 1st Offense W151 N5400 Block Badger Dr.

Officers responded to the area to check for a possible intoxicated driver. The vehicle was located and stopped. The officer contacted the driver who showed signs of impairment. The driver was asked to step out of the vehicle and was placed through field sobriety tests. Based on those tests the driver was arrested for OWI 1st offense. A search incident to arrest revealed the intoxicated driver had a loaded handgun in the vehicle which was seized as evidence. The driver consented and provided a breath sample that was .37. The driver was booked, posted bond and released to a responsible adult.

24-011826 05-22-2024 Operating While Intoxicated 1st, Possession of Prescription Drugs and Paraphernalia Mill Rd./Aspen Dr.

Officers were dispatched to the area of a single vehicle crash. Upon arrival a vehicle was located in the ditch and the driver was sitting near the vehicle. Officers contacted the driver who advised she swerved to miss striking an animal. Witnesses on scene advised the driver appeared intoxicated and had crossed the center line more than once. The officer noted the driver appeared to be impaired and asked her to perform field sobriety tests. Based on those tests the driver was arrested for OWI 1st offense. During the booking process the suspect was found to be in possession of a suspected crack cocaine pipe along with prescription drugs that she was not prescribed. The suspect was eventually transported out to the Waukesha County jail.



24-012253 05-28-2024 Operated Vehicle Without Owner's Consent Mill Rd./Lilly Rd.

Officers were dispatched to the area for a FLOCK alert on a stolen U-Haul van reported out of Milwaukee. The vehicle was located and stopped and the driver was contacted. The vehicle was confirmed as stolen and the driver was arrested for operating vehicle without owner's consent. The passenger was found to have a valid Probation & Parole warrant and was also arrested. Both the suspect and driver were booked and transported out to the Waukesha County jail. The vehicle owner was notified and it was towed from the scene.
