



## **Menomonee Falls Police Department Notable Incidents for the Month of June 2024**

### **24-012797 06-03-2024 Carrying Concealed Weapon, Possession of a Short-Barreled Rifle, Receiving Stolen Property Main St./Elder Ln.**

Officers stopped a vehicle for a speed violation. The officer noted the smell of marijuana when speaking with the driver. A search of the vehicle revealed a loaded handgun that was reported stolen from an address in Milwaukee. A further search revealed a short-barreled rifle was located under the driver's seat. All occupants from the vehicle were interviewed. The driver, who did not have a CCW license, was eventually arrested and booked on several charges related to the firearms, issued traffic citations and was transported out to the Waukesha County jail.

### **24-013451 06-10-2024 Carrying a Concealed Weapon, Possession of Marijuana and Drug Paraphernalia Main St./Pilgrim Rd.**

An officer stopped a vehicle for a speed violation. The officer noted the smell of marijuana when speaking with the driver. A search of the vehicle revealed marijuana, a scale and a loaded handgun. The driver did not have a valid CCW licenses. The driver was arrested, booked, posted bond and was released.

### **24-013765 06-13-2024 Operating While Intoxicated with a Passenger under 16 years of age Hwy 41/Main St.**

Officers were dispatched to a disabled vehicle on the freeway and the caller reported observing a shirtless male running along side the road. The driver advised he ran off the roadway and struck a sign. During the interview the officer noticed signs of impairment that appeared to be drug related. Inside the vehicle an uninjured 11-year old passenger was located and interviewed. The driver was placed through field sobriety tests and was eventually arrested for operating while intoxicated. The driver refused to provide a blood sample so a warrant was obtained and a forced blood draw was conducted. The driver was eventually booked and released to a responsible adult. The juvenile was turned over to their parent.

### **24-013827 06-14-2024 Operate Vehicle Without Owner's Consent, Possession of a Firearm by a Felon, Possession of a Machine Gun, Possession of Drugs & Paraphernalia, Resisting/Obstructing N88 W14275 Main St.**

Officers responded to the area for a FLOCK alert on a stolen Land Rover reported out of Milwaukee. The vehicle was located in the Ascension Hospital parking unoccupied. Officers proceeded into the hospital to determine who was operating the vehicle. Officers contacted the driver who tried to run past the officers and was handcuffed and detained after struggling with the officers. The passenger was also detained. Surveillance was reviewed and confirmed the male suspect drove the stolen vehicle into the hospital parking lot and was also in possession of the key fob. A wanted check revealed the suspect driver was also a convicted felon. A search of the vehicle revealed a loaded hand gun, marijuana, fentanyl and other drug paraphernalia. The suspect driver was arrested, booked on several felony charges and was eventually transported out to the Waukesha County jail. Due to the serious felony charges involving drugs and a firearm, Federal charges are being sought in this case.



**24-014235    06-19-2024    Carrying Concealed Weapon, Possession with Intent to Deliver Marijuana, Possession of Drug Paraphernalia    Appleton Ave./Homestead Dr.**

An officer stopped a vehicle for traveling 49 mph on a 30-mph zone. The officer contacted the driver who advised he had a handgun and marijuana in the car. The driver went on to state the marijuana was in a back-pack and the handgun was under the seat. Back-up officers arrived and the handgun and marijuana were recovered. The suspect was also found to be in possession of a large amount of cash. The driver did not have a valid CCW permit. The driver was arrested, booked, issued traffic citations and transported out to the Waukesha County jail.

**24-014350    06-20-2024    Disorderly Conduct, Warrant Arrest    N72 W13333 Jacob Ln.**

Officers responded to Kinder Care for the report of a disorderly employee that was throwing objects around the daycare. The business requested to have the employee removed. Prior to the officer's arrival the employee had left. However, a wanted check revealed the employee had a valid warrant arrest for disorderly conduct from the Oak Creek Police Department. The employee was located driving in her vehicle, stopped and arrested on the warrant. The employee posted bond and was released.

**24-014436    06-22-2024    Disorderly Conduct/Strangulation (domestic abuse), Possession of Drugs, Warrant Arrest    W148 N8800 Block Jefferson Ave.**

Officers responded to a domestic violence call. Investigation revealed the suspect was involved in a physical confrontation with the victim and at one point the suspect choked the victim. The police located the suspect a short distance away. The suspect was found to have a valid traffic warrant and was in possession of marijuana. The suspect refused to provide a statement and was booked on several charges. The suspect was transported out to the Waukesha County jail. While the suspect was being processed into the jail, the deputies advised the suspect had concealed an unknown substance inside his rectum. The substance was retrieved and later tested positive for fentanyl. An additional charge was added for this new offense.

**24-014671    06-24-2024    Robbery, Damage to Property    W168 N9100 Block Garden Ave.**

Officers responded to a robbery complaint. The victim advised that a known suspect forced their way into the apartment armed with a hammer and demanded the victim's phone. The victim gave the phone to the suspect who then left the residence. The phone was located damaged near the residence. The suspected was located a few days later on foot in the area and tried running from the police. The suspect was arrested, booked and transported out to the Waukesha County jail.
