



Menomonee Falls Police Department Notable Incidents for the Month of August 2024

24-018524 08-04-2024 Operate Vehicle Without Owner's Consent, Possession of Drugs, Probation Violation N56 W15500 Block Silver Spring Dr.

Officers responded to the area for a FLOCK alert on a stolen Buick reported out of Milwaukee. The vehicle was located, stopped and three suspects were detained and interviewed that were inside the vehicle. All provided conflicting stories. One of the suspects was found to be on probation. Another suspect was found to have a large amount of fentanyl, methamphetamine and cocaine hidden in his pants. All three suspects were arrested on multiple charges, booked and transported out to the Waukesha County jail.

24-018715 08-07-2024 Carrying Concealed Weapon, Possession of Drugs N89 W16300 Block Main St.

A subject called police to report that unknown suspects tried to break into his work van. The officers checked the area and no suspects were located. During the investigation the caller appeared to be under the influence. A consent search of the caller's vehicle revealed a loaded handgun, THC and THC gummies. The caller had no CCW permit and was eventually arrested, booked, posted bond and was released.

24-019115 08-11-2024 Stolen/Recovered Motorcycle N70 W14675 Terrace Dr.

Officers responded to a FLOCK alert on a stolen motorcycle reported out of Milwaukee. The motorcycle was located at Oakwood Park and the driver was located in the park. The driver was advised of the stolen status. He advised he had permission from the owner. The officer confirmed the stolen status with the Milwaukee Police Department. The owner was contacted who explained that he had recovered his stolen motorcycle, but never contacted Milwaukee Police Department to have the stolen status changed. No arrests were made and the motorcycle was removed from the stolen vehicle list.

24-019358 08-14-2024 Possession of THC, Resisting/Obstructing, Fleeing/Eluding, Loitering One Mile Rd./Lisbon Rd.

Officers attempted to stop a black Hyundai for suspended vehicle registration. The vehicle fled at a high rate of speed and a pursuit was initiated. The fleeing vehicle crashed and two occupants fled on foot. With the assistance of multiple police agencies, a perimeter was set-up. Brookfield PD located the juvenile passenger suspect who was turned over to us. The juvenile driver was located by MFPD. Both suspect juveniles were arrested, booked and released to their parents.

24-019773 08-19-2024 Indecent Exposure (lewd and lascivious) Colony Rd./ Pilgrim Rd.

Officers responded to the report of a male suspect who was exposing himself to the victim near Colony Rd. and Pilgrim Rd. While on-scene investigating a second indecent exposure was reported at Tamarack Trl./Sherwood Dr. and appeared to be related. The victim reported that the vehicle was a gold Nissan with a known plate. The vehicle was later located and the suspect identified and arrested. A search of his vehicle revealed suspected marijuana. The suspect was booked on the two indecent exposure charges along with a misdemeanor charge of possession of marijuana. The suspect posted bond and was released.



24-019693 08-18-2024 Burglary while Armed, Attempted 1st Degree Intentional Homicide

On Sunday, August 18, 2024 at 2:42 a.m. the Menomonee Falls Police Department along with the Menomonee Falls Fire Department responded to the W136 N6000 Block of Weyer Farm Dr. for the report of a resident who was suffering from a gunshot wound. Upon the officer's arrival the victim was located and first aid was immediately rendered. The victim was treated on scene by the Menomonee Falls Fire Department and conveyed to the hospital with serious, but non-life-threatening injuries. The investigation revealed that at least two suspects had entered the victim's residence. While in the residence, the victim confronted the suspects and one of the suspects fired a gun, striking the victim. Numerous squads responded with the assistance of other law enforcement agencies to check the immediate and surrounding areas for the suspects. After the area was searched and cleared the scene was turned over to the Detectives who are leading the investigation. This is an active and on-going investigation. A News Release was sent regarding this incident.

24-019830 08-20-2024 Carrying Concealed Weapon, Operating after Revocation Main St./Christman Rd.

An officer stopped a driver for operating an unregistered vehicle. The officer contacted the driver who appeared nervous. During the interaction the driver advised there was a loaded handgun on the passenger seat. The driver further stated that he had another loaded handgun in his pocket of his shorts. When asked, the driver stated the handguns belong to him, but he does not have a CCW permit. A check confirmed his CCW permit had expired and his driver's license was revoked. The driver was arrested and the guns were taken as evidence. The driver was booked, issued traffic citations, posted bond and released.

24-019837 08-20-2024 Possession of Drugs and Paraphernalia, Operating While Intoxicated 3rd Offense N87 W17245 Main St.

Officers were dispatched to a possible drunk driver at the Speedway. Upon arrival they contacted the driver who showed signs of impairment related to drug use. The driver was placed through field sobriety tests and was eventually arrested for OWI 3rd offense. A search incident to arrest revealed the suspect was in possession of drug paraphernalia and suspected fentanyl. The driver consented to a blood draw, was later booked and transported out to the Waukesha County jail.
