



## Menomonee Falls Police Department Notable Incidents for the Month of September 2024

### **24-021098 09-02-2024 Operate Vehicle Without Owners Consent, Possession of Drugs N91W15848 Falls Pkwy.**

Officers responded to the area for a FLOCK alert on a stolen Nissan reported out of Milwaukee. The vehicle was located and stopped. Contact was made with the driver and two passengers. The vehicle was confirmed as being stolen with the Milwaukee Police Department. The driver was arrested for operating the stolen vehicle and also for marijuana that was found inside the vehicle. The two passengers were interviewed and released from the scene. The suspect was booked and transported out to the Waukesha County jail.

### **24-021322 09-04-2024 Operating While Intoxicated 4<sup>th</sup> Offenses, Hit and Run N88 W15476 Main St.**

Officers responded to a hit and run accident where the victim advised their vehicle was struck in the Kwik Trip parking lot. The victim and suspect exchanged information and the suspect provided the victim his driver's license. The suspect was located a short distance away at their residence. The officers located the suspect's vehicle in the lower garage and then proceeded to the listed apartment on the vehicle registration. The suspect answered the door, appeared to be under the influence, but denied being in an accident. The suspect eventually admitted to being involved in a crash, but refused to perform standard field sobriety tests when asked. The suspect was arrested for operating under the influence and submitted to a blood sample. After the blood draw the suspect was booked, issued citations and transported out the Waukesha County jail.

### **24-021759 09-10-2024 Operating Vehicle Without Owner's Consent, Felon in Possession of a Firearm W124 N 8145 Hwy 145**

Officers responded to Woodman's for a FLOCK alert on a stolen Cadillac reported out of Milwaukee. The vehicle was located and the driver was detained. The vehicle was confirmed stolen with the Milwaukee Police Department and the driver is a convicted felon. A search of the vehicle revealed a loaded handgun. The suspect driver was arrested for driving a stolen vehicle and for being a felon in possession of a firearm. The suspect was booked and transported out to the Waukesha County jail.

### **24-021785 09-09-2024 Fleeing/Eluding Appleton Ave./Jacob Ln.**

An officer observed a motorcycle with expired registration and initiated a traffic stop. The driver fled at a high rate of speed and a pursuit was initiated. Due to the fleeing motorcycle's speed and recklessness the high speed, the officer terminated the pursuit. No suspect has been identified in this case.

### **24-021967 09-11-2024 Operating While Intoxicated 1<sup>st</sup> Offenses W195 N9550 Rolling Meadow Cir.**

Officers responded to Grace Commons for a report of a battery complaint. Information provided by a witness was that a male suspect and a female victim were involved in a physical altercation in a vehicle that then struck a tree. Additionally, the witness reported the suspect was armed with a handgun. Officers spoke with the witness and the female victim who denied any physical altercation and the male suspect could not be located on scene. Further investigation revealed that the female driver was intoxicated and showed signs of impairment. She was eventually arrested for OWI 1<sup>st</sup>, booked and release to a responsible adult.



**24-021990 09-12-2024 Operating While Intoxicated 1<sup>st</sup> Offense, Probation Violation  
N88 W16683 Main St.**

Officers responded to Shepard Arms for a disorderly suspect who was upset after being denied a firearms purchase. The employees advised the customer also smelled of intoxicants. The suspect's description and vehicle were provided and the vehicle was located a short distance away at a gas station. Contact was made with the suspect who initially provided a false name. Further investigation revealed the suspect showed signs of impairment and was asked to perform field sobriety tests. Based on these tests the suspect was arrested for OWI 1<sup>st</sup> offense. He was found to have open intoxicants in his vehicle and was also on probation for fraud. The suspect was booked on multiple charges, issued citations and transported out to the Waukesha County jail.

**24-022542 09-13-2024 Robbery, Resisting/Obstructing, Probation Violation  
N84 W15690 Appleton Ave.**

Officers responded to Dollar Tree where their investigation revealed two female suspects stole merchandise and threatened the manager with pepper spray when they were confronted. The suspects had fled the scene by the time the officers arrived. The officers were able to obtain video, picture, a vehicle plate and description. On September 18 officers were dispatched to Woodman's in Menomonee Falls where the suspect vehicle from the robbery was observed. Officers responded, located the vehicle and contacted the driver. The suspect driver was identified as one of the suspects involved in the robbery at Dollar Tree and was arrested. She provided a false name and was arrested for the robbery, providing a false name, probation violation and an outstanding warrant. The suspect was booked and transported out to the Waukesha County jail. This investigation is on-going to identify the second suspect.

**24-022753 09-21-2023 Fleeing/Eluding Appleton Ave./Elm Ln.**

An officer stopped a white Jeep with Minnesota plates for a speed violation. As the officer approached the driver's side window, the driver sped off at a high rate of speed. The officer initiated a pursuit in an attempt to stop the vehicle. Due to the reckless speed of the fleeing vehicle, the officer terminated the pursuit. No suspects have been identified in this case.
