



Menomonee Falls Police Department Notable Incidents for the Month of October 2024

24-023760 10-02-2024 Carrying Concealed Weapon, Possession of Drugs and Paraphernalia N93 W14600 Block Whittaker Way

At 3:30 a.m. an officer stopped a pick-up truck that matched an extra patrol request for possible scrap metal thefts while it was parked in a closed business. The officer contacted the driver and passenger who were in the process of securing scrap in the bed of the pick-up. During this contact suspected marijuana was observed on the front seat of the truck. A probable cause search revealed a loaded handgun between the seats and additional drugs and drug paraphernalia. The suspect claiming ownership of the handgun did not have a valid CCW license. No thefts could be substantiated from area businesses. The vehicle was towed from the scene as there was no valid driver. One suspect was arrested, booked on multiple charges, posted bond and released. The other subject was released from the scene.

24-023771 10-02-2024 Fleeing/Eluding Appleton Ave./Good Hope Rd.

An officer attempted to stop a vehicle for speeding and activated the squad's emergency lights. The vehicle continued on driving at normal speeds. The officer activated the siren and the vehicle continued driving and failed to stop or pull-over. The officer pursued the vehicle into Milwaukee where it was eventually terminated. The officer conducted follow-up and was able to identify the vehicle, listed owner and eventually the driver. The officer went to the listed owner's address and interviewed the driver who was newly in this country and did not have a valid license or aware of the requirement to stop. The driver was issued citations on scene and released.

24-023921 10-03-2024 Carrying Concealed Weapon, Felon in Possession of a Firearm, Operate with a Restricted Controlled Substance Roosevelt Dr./Grand Ave.

Officers responded to a two-vehicle crash with injuries and that one of the drivers may be under the influence. Upon arrival one of the drivers showed signs of impairment and had admitted to recently ingesting several prescription drugs. While the officer was interviewing this suspect, he noticed a handgun on the passenger side floorboard of the vehicle. The officer determined the suspect was a convicted felon. The suspect was eventually arrested, medically cleared, booked on several charges and transported out the Waukesha County jail.

24-024160 10-06-2024 Possession of Marijuana & Prescription Drugs, Possession with Intent to Deliver Cocaine, Maintain Drug Trafficking Place W156 N8390 Pilgrim Rd.

Officers responded to Oil Changers business for a possible drug overdose. The suspect was located and treated on-scene by police and fire personnel. The following investigation revealed this subject was in possession of several different drugs and paraphernalia as well as other items indicative of a mobile drug lab in his van. The suspect was medically cleared, booked on multiple drug charges and transported out to the Waukesha County jail.



24-024598 10-11-2024 Operate Vehicle Without Owner's Consent Leon Rd./Hwy 145

Officers responded to a FLOCK alert on a stolen GMC truck reported out of Milwaukee. Officers in the area located it in the Arandell parking lot. Officers contacted the suspect driver and passenger. The driver stated that he was renting the car, but could not provide any details. A records check revealed the driver was on probation for Fleeing/Eluding. The passenger was being dropped off at work and it was determined that they were uninvolved and were released from the scene. Officers contacted the listed owner who confirmed their vehicle was stolen from the residence. The suspect driver was arrested for violation of probation and operating a vehicle without owner's consent. The vehicle was towed from the scene.

24-240607 10-11-2024 Fleeing/Eluding Good Hope Rd./Appleton Ave.

An officer attempted to stop a vehicle for having a broken headlamp. The officer initiated a traffic stop and the vehicle failed to stop. The suspect vehicle then increased its speed and attempted to flee. The officer pursued the vehicle until the fleeing vehicle's speed and actions became reckless at which time the officer terminated the pursuit. No plate was visible to the officer and no suspects have been identified in this case.

24-025221 10-19-2024 Operating While Intoxicated, OWI Causing Injury, Hit and Run Causing Injury, Second Degree-Recklessly Endangering Safety, Resisting/Obstructing, Disorderly Conduct (domestic violence) Main St./Fond Du Lac Ave.

Officers responded to a vehicle crash on Main St. west of I41. Upon arrival the investigation revealed that the suspect and victim were related and had been involved in an argument in Milwaukee. Upon leaving the suspect pursued the victim and intentionally crashed into the victim causing them to leave the roadway and suffer injuries. Afterwards, the suspect fled the scene. The suspect was found to be intoxicated and was placed through field sobriety tests. The suspect was eventually arrested on numerous charges for the OWI and crash related offenses. The suspect refused to consent to a blood draw so a search warrant was obtained. The suspect later physically resisted officer/staff efforts to draw the blood at the hospital. Due to the suspect's resistive actions, they were transported directly out to the Waukesha County jail.

24-025398 10-21-2024 Battery to a Police Officer, Battery, Disorderly Conduct, Resisting/Obstructing, Child Neglect N89 W16899 Appleton Ave.

Officers responded to a call at Planet Fitness for a disorderly subject. The caller reported a woman with her two small children, who was not a member was asked to leave. This suspect then began to yell and throw weights around striking an employee and breaking mirrors. The suspect had also done this around her infant child who she placed on the floor during this time. Officers arrived and took the suspect into custody. Once the suspect was brought back to be booked she became uncooperative and began spitting at officers. As officers attempted to place the spit hood on the suspect, she bit an officer in the leg causing pain. The suspect was eventually transported out to the Waukesha County jail on numerous charges.
