



Menomonee Falls Police Department Notable Incidents for the Month of November 2024

24-026334 11-02-2024 Operating Vehicle Without Owner's Consent, Possession of Cocaine Main St./Hoyt St.

Officers responded to the area for a FLOCK alert of a stolen vehicle reported out of Milwaukee. One of the officers located the vehicle and determined the description did not match the stolen vehicle plate information. Other officers responded and conducted a high-risk traffic stop and detained two suspects. It was determined the vehicle had stolen license plates from Milwaukee and the vehicle was reported stolen out of Greenfield. A search of the stolen vehicle revealed stolen identification cards and suspected cocaine. The suspect driver was eventually booked on charges involving the stolen vehicle and drug charges and transported out the Waukesha County jail. The passenger was eventually released with no charges. The vehicle was towed from the scene.

24-026947 11-07-2024 Theft by Fraud W172 N9100 Block Shady Ln.

Officers responded to investigate a theft by fraud incident. The victim stated she was contacted by a suspect purporting to be with the Glendale Police Department and asking the victim to pay for an outstanding fine they owed amounting to a few thousand dollars. The victim was convinced to transfer cryptocurrency to an unknown account where the suspect was able to use a CoinMe machine to complete the transaction. The victim had no suspect information and there was little in the way of investigative leads due to the nature of the transaction. This case is currently inactive.

24-027620 11-14-24 Theft N94 W18375 Thunder Ridge Dr.

An employee of Home Depot called the police to report a theft of Milwaukee brand tools. The employee advised that a contracted delivery driver for Roadie Delivery was supposed to deliver three sets of Milwaukee tools to a customer. The customer advised they never received the tools. The investigating officer confirmed from the customer via surveillance video that the delivery driver stopped, but never dropped off the tools. The police contacted the suspect driver who eventually admitted to the theft and was still in possession of the tools which were returned to the arresting officers. The suspect was arrested, booked on misdemeanor theft charges and released.

24-027649 11-14-2024 Carrying Concealed Weapon, Possession of Drugs and Paraphernalia Main St./124th St.

An officer stopped a vehicle for having suspended vehicle registration. The officer noted the odor of marijuana coming from the vehicle and conducted a probable cause search. The suspect driver admitted to having marijuana in the vehicle along with a loaded handgun in the center console. The suspect driver advised that he did not have a concealed carry permit. During the investigation the suspect passenger was found to have marijuana in his pants pocket along with the loaded handgun and other drug paraphernalia in the vehicle. Both the driver and passenger were arrested and transported back to the police department. The suspect driver was booked on multiple charges, interviewed, posted bond and was released. The suspect passenger was booked, interviewed, issued a municipal citation and released.



24-027758 11-19-2024 Felony Bail Jumping, Probation Violation, Operating After Revocation, Failure to Install Ignition Interlock Device Silver Spring Dr./Technology Dr.

An officer stopped a vehicle because there was no rear plate displayed. The officer obtained the driver's information and conducted a license and record check. It was learned that the driver was revoked due to a previous OWI conviction, the required ignition interlock device had not been installed, there was an open criminal case for felony fleeing and he was on probation with a restriction of no driving without proper licensing. Due to the numerous violations the suspect driver was arrested, booked, a probation hold was placed and he was transported out to the Waukesha County jail.

24-028235 11-20-2024 Operating While Intoxicated 2nd Appleton Ave./Lilly Rd.

At approximately 4:00 p.m. officers responded to the report of an impaired driver that was stopped in traffic in a turn lane. The reporting person advised they saw a vehicle with the driver slumped over the wheel. The reporting person placed the vehicle in park, removed the keys and called the police. Officers contacted the driver who showed signs of impairment. The driver was not wearing any shoes and was brought to a place out of the weather to perform sobriety tests. The driver was eventually arrested for OWI 2nd as there had been a prior conviction. The driver's alcohol level was over three times the legal limit. The driver was booked, issued several citations and released to a responsible adult.

24-028262 11-20-2024 Fleeing/Eluding W124 N8145 Hwy 145

An officer observed a Volkswagen with no registration plates displayed and also a defective brake light. The officer initiated a traffic stop by turning on their emergency lights. The suspect drove into the Woodman's parking lot slowly as if it was going to pull into a parking stall. The officer then initiated their siren in attempt to get the vehicle to stop. The vehicle then sped up and fled the parking lot onto Leon Rd. The officer pursued the vehicle east into Milwaukee. Based on the fleeing vehicle's speed and recklessness, the officer terminated the pursuit. Due to a lack of identifying information no arrest has been made in this incident.

24-028676 11-26-2024 Possession with Intent to Deliver (Marijuana), Resisting/Obstructing Leon Rd./124th St.

An officer stopped a vehicle for having no license plate displayed. The officer contacted the lone driver who appeared very nervous. During their conversation, the officer noted the smell of marijuana coming from the vehicle. The driver admitted that his girlfriend had smoked marijuana in the car earlier in the day. The driver then admitted he had marijuana and handed the officer a small bag containing suspected marijuana. The suspect was asked to step from the vehicle and was escorted to the front and was advised his vehicle was going to be searched. The driver then ran back to the driver's side of the vehicle in an attempt to flee. The driver grabbed ahold of the steering wheel and had to be physically pulled out of the car and was eventually handcuffed. Once the suspect was under control the officer conducted a search and located approximately two pounds of marijuana inside the vehicle. The suspect was booked and transported out to the Waukesha County jail.



**24-028770 11-26-2024 Carrying Concealed Weapon, Possession of Marijuana
Lilly Rd./Silver Spring Dr.**

An officer stopped a vehicle for having no registration plate displayed. Upon contacting the driver, the officer noted the smell of marijuana. The officer advised the driver and the other occupants to exit the vehicle so he could conduct a probable cause search. The officer located suspected marijuana inside the driver's purse along with a handgun and a full magazine in the glove compartment. The suspect driver was arrested, booked, posted bond and released. The gun and suspected marijuana were seized and inventoried.

24-028951 11-29-2024 Fleeing/Eluding 12400 Block Main St.

An officer observed a vehicle displaying no registration plates. The officer initiated a traffic stop to investigate. The vehicle, which was a white Infiniti, fled at a high rate of speed. The officer pursued the vehicle while activating the lights and sirens. The vehicle continued to make quick U-turns and driving at high speeds in an attempt to flee from the officer. The officer eventually lost sight of the vehicle near Brown Deer Rd. and 107th St. in Milwaukee and terminated the pursuit. Due to a lack of identifying information no arrest has been made in this incident.
