



Menomonee Falls Police Department Notable Incidents for the Month of December 2024

24-029278 12-03-2024 Resisting/Obstructing, Fleeing/Eluding, Bail Jumping Main St./Fountain Blvd.

An officer stopped a vehicle for having suspended registration. The officer contacted the driver who provided a false name. Once the driver's true identity was determined, the officer discovered a valid warrant. Upon approaching the vehicle, the suspect fled and a pursuit was initiated. Due to the suspect's speed and because of their known identity the pursuit was terminated. Attempts were made to locate and arrest the subject. The suspect was not located, but several charges were referred to the Waukesha County District Attorney's office for charging.

24-029596 12-06-2024 Carry Concealed Weapon, Resisting/Obstructing, Possession of Marijuana, Bail Jumping

An officer stopped a vehicle for not having the headlamps illuminated during hours of darkness. The officer contacted the driver who provided a false name. The officer noted the smell of marijuana and asked the driver who admitted to having marijuana in the car. The officer conducted a search and located a bag of marijuana between the front seats along with a loaded semi-automatic handgun under the driver's seat. A check of the handgun's serial number revealed it was reported stolen out of Milwaukee and the driver did not have a CCW permit. The suspect driver was also found to have a valid warrant for carrying concealed weapon. The driver was arrested, booked on numerous charges and transported out to the Waukesha County jail.

24-030374 12-13-2024 Lewd & Lascivious Behavior N85 W14205 Fond Du Lac Ave.

An officer responded to Rotary Park where two victims reported that a suspect was engaged in a lewd act while in a vehicle parked next to their vehicle. The victims were able to obtain the plate of the suspect's vehicle as it fled the parking lot. Officers followed-up with the listed owner and contacted the suspect who admitted to masturbating while in the vehicle next to the victims. The suspect was arrested, booked, posted bond and was released.

24-030623 12-16-2024 Endangering Safety by Use of a Dangerous Weapon, Possession of Marijuana, Operating Under the Influence

An officer stopped a vehicle for a speeding violation. Upon contacting the driver, the officer noted the smell of marijuana. The driver admitted to recently smoking marijuana while driving. The officer had the driver perform field sobriety tests. Based on those tests the driver was arrested. A search incident to arrest revealed the driver had a concealed handgun in his waist band. The driver did not have a CCW permit. He was transported to the hospital for a consensual blood draw and eventually booked, issued citations and released.

24-030904 12-18-2024 Operating While Intoxicated (1st) N91 W15720 Falls Pkwy.

An employee called to report an intoxicated patron at Mr. Brew's Taphouse. The intoxicated patron left and entered a vehicle and drove off. The witness provided a description and officers were able to locate and stop the vehicle. Contact was made with the driver who showed signs of impairment. The driver was asked to perform field sobriety tests and was eventually arrested for OWI first offense. The driver was booked, issued citations and released to a responsible adult.



**24-031441 12-24-2024 Operating While Intoxicated (2nd), Possession of Marijuana
Oxford St./University Dr.**

Officers responded to a crash where a single vehicle struck a light pole. Upon arrival the officers located the vehicle and a caller advised the driver had fled from the vehicle. The officer on scene noted the smell of marijuana coming from the vehicle and conducted a search. The officer located suspected marijuana while another officer located the fleeing driver just down the street. The driver showed signs of impairment and was asked to perform field sobriety tests. The driver was eventually arrested for OWI and possession of marijuana. He was booked, posted bond and was released to a responsible adult.

24-031673 12-28-2024 Carry Concealed Weapon, Possession of Drugs and Paraphernalia N90 W16939 Appleton Ave.

Officers were dispatched to a suspicious vehicle that had been parking behind Great Lakes Laundry very night for a week. The initial officer observed the vehicle and approached to speak with the driver. The officer noted a suspected marijuana pipe on the dashboard as he spoke with the driver who also admitted it was used for that purpose. During a search of the vehicle the officer located a loaded handgun in the glove compartment and more suspected marijuana. The driver was arrested, booked and transported out to the Waukesha County jail after being unable to post bond.

24-031714 12-28-2024 Discharge of a Firearm, Possession of Drugs and Paraphernalia W172 N9100 Block Shady Ln.

Officers responded to a report of gunshots inside an apartment. The caller reported a bullet had traveled through their wall from a neighboring apartment. It was determined the bullet had traveled through at least two different apartments. Officers checked the remaining apartments to ensure no one had been struck by the bullet. During the investigation the suspect's apartment was identified and officers attempted contact. Officers were able to finally contacted the suspect who admitted to panicking and fleeing the scene after he admitted that he accidentally discharged his gun while cleaning it. The suspect returned and gave officers consent to search his apartment. During the search suspected marijuana and paraphernalia was located. The firearm was eventually recovered from a vehicle and seized as evidence. The suspect was arrested, booked, posted bond and was released.

24-031782 12-29-2024 Carrying Concealed Knife, Possession of Drugs and Paraphernalia N81 W15094 Appleton Ave.

Officers were called to DJ's Goalpost for a subject passed out. Both police and fire responded. Witnesses observed the subject become unresponsive and advised the subject was a known drug user. A bag of suspect THC gummies was located hanging out of the subject's pocket. A bag the subject had was searched and additional marijuana was located along with drug paraphernalia. The subject was eventually treated and released where she was then booked and searched. During the search a concealed knife was located in her waistband. Due to the subject being a convicted felon she was not to possess or conceal any weapons including knives. She was eventually booked and transported out to the Waukesha County jail.
