



Menomonee Falls Police Department Notable Incidents for the Month of February 2025

25-002895 02-02-2025 Possession of Cocaine and Marijuana (2nd Offense), Possession of Illegally Obtained Prescription Medication, Drug Paraphernalia

Main St/Appleton Ave

An officer conducted a traffic stop for defective vehicle lighting during the hours of darkness. The officer detected the odor of marijuana emanating from the vehicle, and a probable cause search revealed the presence of marijuana, cocaine, and drug paraphernalia. Officers also located liquid Promethazine, a controlled substance commonly referred to as "Lean". The driver was arrested, booked and transported to Waukesha County Jail.

25-002987 02-03-2025 Retail Theft – Felony N94W16855 Falls Parkway

Best Buy reported that two suspects stole \$6,276.95 worth of Samsung cell phones and Apple products from Best Buy and fled in a gray Infiniti with unreadable registration plates. The officer who responded obtained video surveillance footage and shared the images of the suspects with the Wisconsin Crime Alert Network in hopes of learning their identities from the community. The investigation is ongoing.

25-003201 02-05-2025 Possession of Narcotic Drugs/Probation Violation MFPD

An individual arrived at the Menomonee Falls Police Department to turn himself in for an active arrest warrant. An officer responded and contacted the person to confirm their identity. The warrant status was confirmed and the individual was arrested. The individual was transported to the Waukesha County Jail where a search of their person revealed a concealed prescription narcotic drug. The individual was turned over to jail staff and a charge for the drug violation will be referred to the Waukesha County District Attorney's Office for charging consideration.

25-003203 02-05-2025 Operating While Intoxicated (1st) Causing Injury, Hit & Run

Main St/Lilly Rd

Officers responded to a hit-and-run crash causing injury near Main St/Lilly Rd. The responding officers located the striking vehicle parked a short distance from the crash scene behind a business. Officers contacted the driver, who displayed signs of impairment during the field sobriety testing, and was arrested. The driver submitted to a chemical test of his blood; test results are pending. He was booked and the Menomonee Falls Police Department and transported to the Waukesha County Jail.

25-003496 02-09-2025 Battery to Health Care Provider/Staff, Resisting/Obstructing

Froedtert Menomonee Falls Hospital W180 N8085 Town Hall Rd

MFPD Officers were dispatched to Froedtert Menomonee Falls Hospital (FMFH) for the report of a female visitor assaulting hospital staff. Officers arrived and determined the female visitor, who was upset with hospital staff, assaulted three FMFH staff members before attempting to leave. Officers located the female suspect in a vehicle in the parking lot. She refused to identify herself or to exit the vehicle. The female was removed from the vehicle by officers and taken into custody. She was booked at the Menomonee Falls Police Department and transported to the Waukesha County Jail.

25-003484 02-09-2025 Threat to a Law Enforcement Officer, Discharge Bodily Fluid on Public Safety Worker, Physical Abuse of an Elderly Person-Domestic Violence Related, Disorderly Conduct-Domestic Violence Related, Resisting an Officer, Bail Jumping

N5100 block of Grey Log Ln

Officers were dispatched to a residence for the report of a person actively battering his elderly father and breaking items in the home. The suspect made comments that he was going to commit homicide to responding officers. Officers arrived and confronted the suspect, who refused to obey commands. Officers deployed a conducted electronic weapon (CEW) to gain control of the suspect and take him into custody. Once in custody, the suspect discharged bodily fluids onto the officers. The suspect was transported to the Waukesha Memorial Hospital for medical clearance before being turned over to the Waukesha County Jail.

25-003480 02-09-2025 Operating While Intoxicated – 3rd Offense Main St/Pilgrim Rd

An officer conducted a traffic stop of a vehicle after he observed the driver make an improper turn. The driver displayed signs of impairment and submitted to field sobriety tests. The officer observed several clues consistent with impairment. The driver provided a preliminary breath test on the scene that registered at .118. The driver was arrested for Operating While Intoxicated – 3rd offense. The driver gave consent for an evidentiary chemical test of their blood; test results are pending. The driver was booked at the Menomonee Falls Police Department, posted bond, and was released to a sober adult.

25-003945 02-14-2025 Swatting/Suspicious Circumstances Pocahontas Dr/Wampum Dr

An unknown actor contacted the Waukesha County Communications (WCC) dispatch center stating they were going to shoot someone at a residence on Pocahontas Dr. The WCC dispatchers were able to hear crying in the background of the phone call and several gunshots. Officers responded to the area and established a perimeter. Officers were able to contact the occupants inside the residence and quickly determined the circumstances to be falsified. Officers checked the welfare of the residents as well as several of their neighbors and determined nobody was harmed. The Menomonee Falls Special Investigations Bureau is investigating the circumstances and the origin of the call.

25-004196 02-17-2025 Pursuit Silver Spring Dr/Lilly Rd

An officer observed a gray or silver BMW SUV with a defective headlamp traveling on Silver Spring Dr near Lilly Rd at a high rate of speed. The officer attempted to stop the vehicle, however, the vehicle accelerated and fled. The vehicle was pursued for approximately 1 mile to the area of Interstate 41 where the officer lost sight of vehicle and terminated the pursuit.

25-004286 02-18-2025 Personal Injury Motor Vehicle Crash I-41/Pilgrim Rd

Officers were dispatched to US Highway 41 at Pilgrim Rd for the report of a motor vehicle crash with injuries. Upon their arrival, officers learned that a vehicle traveling northbound on I-41 became disabled in the center lane of traffic. The driver of the disabled vehicle contacted 911 requesting assistance, however, his vehicle was struck from behind by a pickup truck. The driver of the disabled vehicle was transported to Froedtert Hospital with non-life-threatening injuries. The driver of the pickup truck was transported to Froedtert Hospital with life-threatening injuries. The Menomonee Falls Patrol Support Unit is investigating the crash.

25-004871 02-26-2025 Battery to a Healthcare Worker/Resisting/Obstructing an Officer W128N6900 Northfield Dr

An individual entered a senior living facility, approached a healthcare staff member, and struck her in the face. The suspect fled the facility to a nearby, adjacent facility where MFPD officers encountered him. The suspect provided officers with false identification and was in a vehicle listing to one of the victim's co-workers. The suspect was arrested, booked, and transported to the Waukesha County Jail. Further investigation revealed a disgruntled co-worker conspired with the suspect to commit the assault. Both suspects have been charged with felonies through the Waukesha County District Attorney's Office. The Special Investigations Bureau continuing their investigation of this incident.
