



## Menomonee Falls Police Department Notable Incidents for the Month of January 2025

**25-000007 1-1-2025 Operating While Intoxicated 2<sup>nd</sup>, Possession of Marijuana**

**US Hwy 41/124<sup>th</sup> Street**

Officers responded to the report of a car vs. sign Property Damage Only crash. Upon arrival, the driver showed signs of impairment and was arrested for OWI – 2<sup>nd</sup>. Officers conducted a search of the driver's vehicle following the arrest and found 2.64 grams of marijuana. The driver was booked and provided a consensual breath sample which returned at .18 grams/210L (Over double the legal limit). The driver was unable to post bond and was transported to the Waukesha County jail.

**25-000158 1-3-2025 Vehicle Pursuit, Operating While Intoxicated 1<sup>st</sup>**

**Greenvie Ave/Lisbon Rd.**

At approximately 2:48 am, an Officer on patrol observed a vehicle deviating from their lane and abruptly left the roadway. The Officer attempted to conduct a traffic stop by activating their emergency lights and siren. However, the vehicle quickly accelerated in an attempt to flee. A short pursuit was initiated before the vehicle came to a stop. The driver displayed signs of impairment and admitted to consuming alcohol. The driver was arrested for OWI 1<sup>st</sup> and fleeing/eluding. He provided a consensual breath test during the booking process which returned at .20 grams/210L (About 2 ½ times the legal limit). The driver was transported to Waukesha County Jail.

**25-000388 1-6-2025 Endangering Safety by Use of a Dangerous Weapon**

**N81W15100 block Appleton Ave**

An Officer received an anonymous report that someone discharged a firearm in an apartment complex on 1-4-2025. Several Officers responded to the apartment complex to investigate and contacted a resident in one of the apartments where the incident allegedly happened. Officers spoke with the resident, who admitted they accidentally discharged a firearm while trying to clear a malfunction. The occupant told Officers he didn't report the incident to police because nobody was injured. The occupant was arrested, booked, posted bond, and released from custody.

### 25-000507 1-7-2025 Carrying a Concealed Weapon, Operating w/o a Valid Drivers License 2<sup>nd</sup> Appleton Ave/University Dr

An Officer conducted a traffic stop and discovered the driver to have several warrants through the Milwaukee County Sheriff's Department. The driver was arrested and searched. Officers located a firearm concealed in his waistband. The driver did not have a CCW permit to possess the firearm. The driver was booked and transported to the Waukesha County Jail.

### 25-000612 1-7-2025 Strong Armed Robbery, Possession of Marijuana

#### Metro Market – N95W18351 County Line Rd

Officers were dispatched to Metro Market for the report of two suspects attempting to steal groceries by using reduced-price stickers/barcodes and not self-scanning all of the items. The suspects were confronted by a store employee, and a physical altercation ensued. The suspects fled the store and were later located by responding Officers and stopped. Both suspects were arrested, and a search of one of the suspect's purses revealed 2 grams of marijuana. Both suspects were transported to the PD for booking procedures. One suspect was released with a municipal citation, and the other was conveyed to Waukesha County Jail.

### 25-000985 1-11-2025 Possession with Intent to Deliver – THC, Drug Paraphernalia, Maintaining a Drug Trafficking Place Pilgrim Rd/Main St

An Officer conducted a traffic stop for an equipment violation and detected the odor of marijuana emanating from the vehicle. Officers searched the vehicle and located 22 grams of marijuana, a digital scale, and plastic bags consistent with marijuana packaging. The driver had a criminal history of drug law violations and was arrested, booked, and transported to the Waukesha County Jail.

### 25-001427 1-16-2025 Felony Bail Jumping, Felony Warrant Arrest

#### Shepard Arms – N88W16683 Main St

Officers were called to Shepard Arms for the report of an individual attempting to purchase a firearm who had an active Felony warrant and was prohibited from purchasing a firearm. Officers arrived and contacted the individual. Officers arrested the individual for the warrant and Felony bail jumping due to an open criminal case. The suspect was booked and transported to the Waukesha County Jail. The ATF was notified of the federal firearm violations for follow-up and additional charging considerations.

**25-001573 1/18/2025 Possession of Firearm by a Felon, Possess with Intent to Deliver – THC & Cocaine, Possess Illegally Obtained Prescription Medications**

**Beacon St/Lilly Rd**

Officers were dispatched to a single-vehicle crash. Upon contacting the driver, the Officer asked the driver to provide a driver's license. As the driver reached for his license, the Officer observed a firearm concealed in the driver's waistband. The investigation revealed the driver was a convicted felon prohibited from possessing a firearm. A search of the vehicle and the driver revealed approximately \$3,300.00 in US currency, 1.77 grams of cocaine, 6.3 grams of marijuana, several MDMA pills, and 27 Oxycodone pills. The driver was arrested, booked, and transported to the Waukesha County Jail.

**25-002335 1-27-2025 Operate Motor Vehicle w/o Owner's Consent, Possession of Marijuana, Drug Paraphernalia Main St/Fond Du Lac Ave**

Officers conducted a traffic stop of a vehicle that did not have any registration plates displayed. The Officer checked the VIN and learned the vehicle was reported stolen through the City of Milwaukee. During the investigation, the driver told Officers he was in possession of marijuana. Officers located an (approximate) ounce of marijuana in the center console of the vehicle and drug paraphernalia. The driver was arrested, booked, and transported to Waukesha County Jail.

**25-002714 1-31-2025 Possession with Intent – Cocaine, Maintain a Drug Trafficking Place Appleton Ave/Ruby Rd**

An Officer conducted a traffic stop for a speeding violation and detected an odor of marijuana emanating from the vehicle. A probable cause search of the vehicle revealed approximately 9 ounces of cocaine and approximately \$46,200.00 in US currency. The driver was arrested, booked, and transported to the Waukesha County Jail.
