



Menomonee Falls Police Department Notable Incidents for the Month of July 2025

25-016308 7-2-2025 Carrying a Concealed Knife, Possession of a Controlled Substance – 2nd Offense, Failure to Install an Ignition Interlock Device, Probation Violation

Appleton Ave/Fleet Ave

An officer conducted a traffic stop for a speeding violation and a red-light violation. The officer discovered the driver did not have a license and was required to have an ignition interlock device (IID) installed in the vehicle; however, the officer did not observe one. The officer also discovered the driver was on active probation and had an active arrest warrant. The officer received consent to search the vehicle and found a concealed knife, marijuana, and open intoxicants. The driver is a felon and prohibited from possessing concealed weapons. The driver was arrested, booked at the Menomonee Falls Police Department, and transported to the Waukesha County Jail.

25-016571 7-4-2025 OWI – 1st Offense, Hit & Run – Property Damage Crash

15200 Block/Appleton Ave

Officers were dispatched to the area for the report of a hit-and-run crash. A witness reported that a vehicle struck a post and left before officers arrived. The officers searched the area and located an individual matching the description of the driver of the striking vehicle. An officer contacted this individual, who admitted that they were the driver of the vehicle that struck the post. The officer also learned that the driver was on active probation. The officer detected signs of impairment, and the driver performed standardized field sobriety tests. The officer observed additional signs of impairment, and the driver was arrested for operating while intoxicated – 1st offense. The driver provided an evidentiary chemical breath test that returned at 0.24g/210L. The driver was booked at the Menomonee Falls Police Department and transported to the Waukesha County Jail for a probation hold.

25-016665 7-5-2025 OWI – 1st Offense, Motor Vehicle Crash Causing Injury

Pilgrim Rd/Interstate 41

Officers were dispatched to Highway I-41 and Pilgrim Rd for the report of a vehicle crash. Upon the officers' arrival, they discovered that a motorist traveling southbound on I-41 had crashed after driving into a ditch and striking a concrete median. Officers contacted the driver, who admitted to consuming alcohol and believed he may have had too much to be able to drive safely. The driver was transported to Froedtert Hospital for treatment. The officer administered a standardized field sobriety test and observed signs of impairment. The driver provided an evidentiary chemical test of his blood and was issued several municipal citations. The driver remained at the hospital for medical treatment.

**25-016748 7-6-2025 Carrying a Concealed Weapon, Pointing and Aiming a Firearm
W156N8480 Pilgrim Rd**

Officers were dispatched to the Village Hall parking lot for the report of a property dispute. One of the individuals allegedly pointed a firearm at the other person during the dispute. Officers located the suspect's vehicle nearby, and the suspect was detained. Officers discovered a semi-automatic handgun in the suspect's vehicle, and the suspect did not possess a CCW permit. The suspect was arrested, booked at the Menomonee Falls Police Department, and released after posting bond. Charges were referred to the Waukesha County District Attorney's Office for review and charging consideration.

**25-016809 7-7-2025 Felony Retail Theft
N77W14400 block of Appleton Ave**

Officers were dispatched to a grocery store for the report of a retail theft. Officers learned that before their arrival, a customer attempted to leave the business with a shopping cart full of unpaid merchandise. The suspect was confronted by an employee who asked to see a receipt. The suspect removed two vacuum cleaners from the cart and fled the store without rendering payment. As the suspect fled the store, he yelled, "You can't touch me because I'm outside". Officers arrived to search the area and located the suspect at a nearby gas station. While conducting the investigation, the officers located two vacuum cleaners concealed under a tree behind the gas station. An officer reviewed the video surveillance footage from Pick-N-Save and identified the suspect as the same individual at the gas station. The suspect was arrested and transported to the Menomonee Falls Police Department for booking. The suspect was conveyed to the Waukesha County Jail and turned over to jail staff. The vacuum cleaners were retrieved and returned to the business.

**25-016957 7-8-2025 Possession of Marijuana, Warrant Arrest
Appleton Ave/St. Francis Dr**

An officer conducted a traffic stop for a vehicle registration violation. The driver was found to be operating without a license and had an arrest warrant for possession of marijuana and operating with a suspended driver's license through a local municipality. The officer took the driver into custody for the warrant and searched their person following the arrest. The officer discovered a marijuana vape pen in a pants pocket. The officer searched the vehicle for more evidence of the drug offense and found more marijuana. The driver was transported back to the Menomonee Falls Police Department for booking. The driver posted bond and was released from custody.

25-017377 7-13-2025 Obstructing Police, Bail Jumping, Operating After Revocation, Failure to Install an Ignition Interlock Device, Warrant Arrest

Fountain Blvd/Patrita Dr

An officer conducted a traffic stop of a vehicle that was not displaying registration plates properly. The officer contacted the driver, who told the officer they did not have any form of identification with them. The driver identified themselves verbally to the officer. The officer also detected an odor of marijuana emanating from within the vehicle, which the driver stated was a result of just smoking marijuana. During the investigation, the officer discovered that the driver provided fictitious identification information. The officer conducted a search of the vehicle for evidence of a drug law violation. During the search of the vehicle, the officer found a Wisconsin identification card of the driver and was able to positively identify the driver's correct name. The driver admitted to lying about the identification to avoid being arrested for an outstanding warrant. The driver was discovered to have several arrest warrants from surrounding jurisdictions. The officer also discovered the driver's operating status was revoked and required to have an ignition interlock device installed in the vehicle. The driver was arrested and transported back to the Menomonee Falls Police Department for booking. During booking, the officer learned that the driver had an open court case with bail conditions, which they had violated. The driver was transported to the Waukesha County Jail and turned over to jail staff.

25-018033 7-19-2025 Possession of Marijuana, OWI - Causing Injury

County Line Rd/Maple Rd

Officers were dispatched to the scene of a three-vehicle crash. Upon arrival, officers contacted one of the drivers who displayed signs of impairment. This driver admitted to consuming alcohol before the crash. The driver submitted to standardized field sobriety tests, and additional signs of impairment were observed. Officers observed open intoxicants within the driver's vehicle and also recovered a suspected THC vape pen on the vehicle's floorboard. An officer tested the contents of the vape pen, and the substance tested positive for the presence of THC. The driver was arrested and transported to the Menomonee Falls Police Department for booking procedures. The driver was issued numerous state and municipal citations and turned over to the care of a sober adult.

25-018724 7-26-2025 Burglary

N56W14100 Silver Spring Dr

Officers were dispatched to a business on Silver Spring Drive for the report of a burglary in progress. Officers arrived and contacted employees, who indicated that an unknown masked suspect had kicked in the front glass door and began climbing through the broken glass. The employees began yelling at the suspect, who fled from the business. Officers began to establish a perimeter and requested the assistance of the Butler Police Department and the Waukesha County Sheriff's Department (WSD). As the assisting agencies arrived in the area, a WSD deputy observed an individual matching the suspect's clothing description leaving the area on a bicycle. Officers stopped and questioned the individual. The officers observed the cyclist to have fresh cuts on one leg, consistent with kicking through a glass door. The suspect was arrested and transported to the Menomonee Falls Police Department. A detective interviewed the suspect, and he admitted to the burglary. The suspect was conveyed to the Waukesha County Jail and turned over to jail staff.

**25-018865 7-28-2025 Operating a Motor Vehicle Without the Owner's Consent,
Obstructing Police, Possession of Drug Paraphernalia, Warrant Arrest**

W124N8145 Highway 145

Officers were alerted to a FLOCK alert for a stolen vehicle traveling in the area of 124th Street and Leon Rd. Officers responded to the area and located the stolen vehicle parked in the Woodman's Food Market parking lot, with one occupant seated in the passenger seat. Officers cautiously approached and contacted the occupant, who displayed signs of drug use and a possible opioid overdose. Officers identified the passenger and discovered that the passenger had an arrest warrant. Officers requested the fire department respond to transport the individual to the hospital for treatment. Officers searched the stolen vehicle and located drug paraphernalia. The investigation revealed that the driver of the vehicle entered the store and had exited shortly after the officers' arrival. The driver was located in the lot, seemingly trying to conceal himself from officers. When officers contacted the driver, he provided a fake name. The officers were able to review surveillance footage and confirmed this individual was driving the stolen vehicle and subsequently took the driver into custody. Upon further questioning, the driver provided a different fake name to the officers. Once the driver arrived at the Menomonee Falls Police Department, officers utilized a fingerprint scanner to identify the driver and discovered that the driver had an arrest warrant for a probation violation. The driver was booked and transported to the Waukesha County Jail, with charges being referred to the Waukesha County District Attorney's Office.
