



Menomonee Falls Police Department Notable Incidents for the Month of August 2025

25-019396 8-3-2025 Possession of Marijuana

Pilgrim Rd/Cleveland Ave

An officer conducted a traffic stop on a vehicle after discovering that the registered owner's driver's license status was suspended. The officer contacted the driver and detected an odor of marijuana emanating from the vehicle. The driver exited the vehicle and admitted to the officer that there was a marijuana blunt in the ashtray and marijuana underneath the passenger seat. The driver was arrested, transported back to the Menomonee Falls Police Department for booking, and released from custody with a municipal citation.

25-019501 8-4-2025 Possession of Marijuana and Drug Paraphernalia

Lilly Rd/Main St

Officers were dispatched to the report of an unresponsive motorist stopped in traffic. Officers arrived and assisted the Menomonee Falls Fire Department by removing the driver from the vehicle. The driver was conveyed to the hospital for treatment, and it was determined that the driver was likely experiencing withdrawal symptoms. An officer observed a suspected THC vape pen on the floorboard of the vehicle. The officer retrieved the vape pen, which later tested positive for the presence of THC. The driver was discharged from the hospital, booked at the Menomonee Falls Police Department, and released from custody with charges being referred to the Waukesha County District Attorney's Office.

25-019674 8-6-2025 Theft of Motor Vehicle, Criminal Damage to Property

W159N7400 blk Pinewood Circle

Officers responded to Pinewood Circle for the report of a stolen motor vehicle. The vehicle owner discovered his vehicle was stolen without keys sometime during the overnight hours. As the suspect(s) were stealing the vehicle, they struck the victim's other vehicle that was parked in the driveway, causing damage to both vehicles. A detective responded to the scene to investigate.

On 8/11/2025, an officer from the City of Brookfield Police Department was dispatched to investigate a suspicious, unattended automobile in the City of Brookfield. The officer ran the vehicle registration and discovered it to be the stolen vehicle from Menomonee Falls. A Menomonee Falls Field Evidence Technician responded to process the scene, collect evidence, and coordinate the vehicle's return to the owner. The investigation remains ongoing.

25-019751 8-7-2025 Operating While Intoxicated – 6th Offense

Bella Vista Dr/Main St

An officer conducted a traffic stop for a vehicle registration violation. While speaking with the driver, the officer detected the odor of intoxicants emanating from within the vehicle and observed signs of possible impairment from the driver. The driver submitted to standardized field sobriety tests, and additional clues of impairment were observed. The driver was arrested for OWI–6th and transported to Froedtert Menomonee Falls Hospital for a consensual blood draw. The driver was then taken to the Menomonee Falls Police Department for booking procedures before being transferred to the custody of the Waukesha County Jail.

25-019972 8-9-2025 Battery to a Law Enforcement Officer, Possession of Narcotic Drugs and Marijuana, Resisting an Officer

Hwy 145/Main St

An officer was conducting stationary traffic enforcement during the overnight hours along Highway 145 and Main St. The officer observed a speeding violation and conducted a traffic stop of the speeding vehicle. As the officer contacted the driver, the officer detected the odor of marijuana emanating from the vehicle. Additional officers arrived on scene to assist with the investigation. The officer conducted a probable cause search of the vehicle based on his detection of the marijuana odor and located a bag in the trunk of the vehicle containing suspected marijuana. As the officer began taking the driver into custody, the driver suddenly began resisting arrest. The suspect fled across all lanes of traffic before losing his balance and falling to the ground. The officer was able to stabilize and handcuff the suspect on the ground. During the struggle, the officer sustained an injury to his hand. A Field Evidence Technician recovered the bag of suspected marijuana to test for the presence of THC. During the test, the officer located several prescription pills within the bag, which were determined to be controlled substances. The driver was conveyed directly to the Waukesha County Jail, with charges being referred to the Waukesha County District Attorney's office.

25-021151 8-18-2025 Armed Robbery

N87W17245 Main St

An unidentified suspect entered the Speedway gas station, displayed a handgun, and demanded money from the clerk. The suspect fled the business on foot. A detective responded to the scene to assist with the investigation. The detective learned that the suspect had also committed robberies in neighboring jurisdictions. The suspect was subsequently identified and arrested, and is pending a federal indictment.

25-020338 8-11-2025 Assist Person/Water Rescue

16400 Block/Main St

Officers were dispatched to the Menomonee River near the 16400 block of Main St for the report of two people who fell into the river and were in distress. Officers and Fire Department personnel arrived and learned that the two individuals had gone into the river in an attempt to rescue their dog; however, they found themselves in distress due to the river's strong current. Rescue personnel were able to quickly pull one of the individuals from the river, but the second person was swept downstream, over the falls, and under the bridge near Arthur Avenue. This information was relayed to other officers who were able to position themselves downstream. An officer observed this person moving downstream and entered the river to intercept them. The officer was able to grab hold of the person and keep him afloat. More officers responded, entered the river, and worked together to remove the person from the river. The patient was quickly tended to by Fire Department personnel, and both patients were transported to Froedtert Menomonee Falls Hospital for treatment. The family dog was also located and is safe.

25-020720 8-14-2025 Endangering Safety by Use of a Dangerous Weapon, Resisting/Obstructing an Officer, Warrant Arrest

N91W16121 Falls Parkway

Officers were dispatched to the business district on Falls Parkway for the report of a naked female in the parking lot, holding a firearm to her head. Officers arrived and began giving verbal commands to the individual to drop the weapon; however, she refused to comply. An officer subsequently deployed a less-lethal shotgun and discharged a total of two bean bag projectiles, striking the individual in the arm and abdomen. The individual then dropped the firearm, and officers were able to take the individual into custody. The individual was treated on scene for non-life-threatening injuries and was conveyed by the Menomonee Falls Fire Department to Froedtert Hospital for continued treatment. Charges were referred to the Waukesha County District Attorney's Office.

25-021749 8-24-2025 Fatal Motor Vehicle Crash

Town Hall Rd/Mineral Dr

Menomonee Falls Police and Fire Department personnel responded to the report of a single-vehicle rollover crash, in which the driver was ejected from the motor vehicle. An officer arrived on scene and provided CPR to the driver. The driver was transported to Froedtert Menomonee Falls Hospital, where he was pronounced deceased. The Menomonee Falls Traffic Unit and Special Investigations Bureau are investigating the circumstances of the crash.

25-021677 8-24-2025 Theft of Mail, Carrying a Concealed Weapon

W134N5500 Campbell Dr

Officers responded to the area after receiving a report of a subject opening business mailboxes during the early morning hours. The suspect was located riding a bicycle in the area and was unable to provide a legitimate reason for being there. The suspect was arrested for loitering, and a search incident to arrest revealed a concealed knife. The suspect, a convicted felon, was prohibited from possessing a weapon. Officers also located mail from various businesses in the area. Officers conducted interviews with representatives of the businesses, who confirmed the suspect did not have consent to possess the business mail. The suspect was transported to the Menomonee Falls Police Department for booking procedures and then transported to the Waukesha County Jail. Charges were referred to the Waukesha County District Attorney's Office for review.

25-021817 8-25-2025 Operating While Intoxicated – 3rd Offense

Main St/Rozanne Dr

A motorist reported a reckless driver, and an officer located and stopped the vehicle after observing lane deviation. The officer observed signs of impairment and requested the driver to perform standardized field sobriety tests. The officer observed additional signs of impairment, and the driver was arrested for operating a motor vehicle while intoxicated – 3rd offense. The officer conveyed the driver to Froedtert Menomonee Falls Hospital for a consensual blood draw. The driver was booked at the Menomonee Falls Police Department and released to a sober adult.
