



Menomonee Falls Police Department Notable Incidents for the Month of September 2025

25-022570 9-3-2025 Carrying a Concealed Weapon

Main St/Pilgrim Rd

An officer conducted a traffic stop for an expired vehicle registration violation. The officer contacted the driver and detected an odor of marijuana emanating from within the vehicle. The officer conducted a probable cause search of the vehicle and located a firearm concealed under the passenger seat. The driver told the officer he did not possess a CCW permit for the firearm. The driver was taken into custody, booked at the Menomonee Falls Police Department, and released. The case was referred to the Waukesha County District Attorney's Office for review and charging consideration.

25-022628 9-3-2025 Felon in Possession of a Firearm, Carrying a Concealed Weapon, Possession of a Controlled Substance

Main St/I-41

An officer conducted a traffic stop on a vehicle with excessive window tint. During the contact with the driver, the officer detected the odor of marijuana emanating from within the vehicle. The driver admitted to the officer that she had marijuana and that there were two firearms in the vehicle. The officers requested the driver and passenger to exit the vehicle to conduct a probable cause search. During the search, the officer located marijuana and two semi-automatic handguns under the driver's and passenger's seats. The officer discovered that one of the firearms was stolen from Milwaukee. The passenger was found to be a convicted felon and prohibited from possessing a firearm. The driver was arrested for possession of a controlled substance – marijuana, and carrying a concealed weapon. The passenger was arrested for being a felon in possession of a firearm. Both occupants were transported to the Menomonee Falls Police Department for booking procedures. The driver was released after booking procedures, and the passenger was transported to the Waukesha County Jail. Criminal charges are being referred to the Waukesha County District Attorney's Office for review and charging consideration for both individuals.

25-023285 9-10-2025 Possession of a Controlled Substance & Bail Jumping

W156N9000 Pilgrim Rd

An officer conducted a traffic stop for a registration violation. As the officer contacted the driver, he detected the odor of marijuana emanating from within the vehicle. The officer conducted a probable cause search of the vehicle and located marijuana and drug paraphernalia. The officer learned that the driver possessed a revoked driver's license, stemming from a previous OWI offense. The driver had an open circuit court case and was found to have violated her bail restrictions. The driver was arrested, transported to the Menomonee Falls Police Department for booking procedures, and released after posting bond.

25-023603 9-13-2025 Felony Stalking

N91W15700 Falls Pkwy

Officers were dispatched to a residence in Menomonee Falls for the report of a potential domestic violence incident. During the investigation, officers learned that the suspect had threatened to kill his former spouse and arrived at the spouse's residence intoxicated and armed with a handgun. Menomonee Falls detectives and officers obtained a search warrant for the suspect's residence in West Allis, WI. Officers arrived at the residence along with officers from West Allis Police Department, and the suspect armed himself with a firearm and barricaded himself in the residence. West Allis Police Department used less lethal force to take the suspect into custody. The suspect was medically cleared and transported to the Waukesha County Jail. Detectives executed the search and seized firearms as evidence. The investigation remains ongoing.

25-024236 9-19-2025 Personal Injury Motor Vehicle Crash

Lannon Rd/Menomonee Ave

Officers responded to the report of a motor vehicle crash involving three motorcycles with injuries. As the officers arrived, it was learned that the motorcycles were traveling northbound on Lannon Road from Menomonee Ave when they encountered multiple deer running across the roadway. The three motorcyclists crashed while attempting to avoid a collision with the deer. Two of the three motorcyclists were transported to Froedtert Hospital in Milwaukee for severe injuries. The Wisconsin State Patrol responded to assist with the crash investigation.

25-024441 9-22-2025 Carrying a Concealed Weapon, Bail Jumping

124th St/Hwy 145

An officer conducted a traffic stop on a vehicle for having a suspended registration. While speaking with the driver, the officer detected the odor of marijuana emanating from within the vehicle. The officer conducted a probable cause search of the vehicle and located a loaded semi-automatic handgun in the glove compartment. The officer determined the driver did not have a valid CCW permit and had an open felony case through Milwaukee County Circuit Court. The driver was arrested, booked at the Menomonee Falls Police Department, and transported to the Waukesha County Jail.

25-024574 9-24-2025 Possession of Marijuana & Possession of Drug Paraphernalia

124th St/Fond Du Lac Ave

An officer conducted a traffic stop of a vehicle for an equipment violation. The officer detected the odor of marijuana emanating from within the vehicle and conducted a probable cause search of the vehicle. The passenger of the vehicle was found to have marijuana and drug paraphernalia. The passenger was arrested, booked at the Menomonee Falls Police Department, issued municipal citations, and released from custody.

25-024802 9-25-2025 Operating While Intoxicated – 4th Offense

Thornapple Ct/Greenview Ave

An officer conducted a traffic stop for an expired registration violation. The officer contacted the driver and detected an odor of intoxicants emanating from within the vehicle. The officer determined the driver had been convicted of three prior operating while intoxicated violations and had a .02 restriction. The driver performed standardized field sobriety tests, and the officer observed several clues consistent with an impaired motorist. The driver was arrested for operating while intoxicated – 4th offense. The driver refused to provide an evidentiary chemical test of her blood, and the officer applied for a search warrant to obtain the evidentiary blood test. Once the officer received a signed search warrant from the on-duty judge, the driver was transported to Froedtert Menomonee Falls Hospital, where the blood draw was completed without incident. The driver was conveyed to the Menomonee Falls Police Department for booking procedures before being transported to the Waukesha County Jail.

25-025068 9-29-2025 Assist Other Agency

W180N8085 Town Hall Rd

A patient arrived at Froedtert Menomonee Falls Hospital with a gunshot wound to the neck. The patient told emergency room staff he sustained the injury during a carjacking attempt by two masked individuals in the area of Mill Rd/Fond Du Lac Ave in the City of Milwaukee. Menomonee Falls officers responded and notified the City of Milwaukee Police Department. Officers from the Milwaukee Police Department District 4 arrived at the hospital and took over the investigation.

**25-025071 9-29-2025 Possession of Cocaine, Possession of Heroin, Obstructing Police,
Warrant Arrest**

Appleton Ave/Main St

An officer conducted a traffic stop of a vehicle operating without any headlights or taillights illuminated during the hours of darkness. As the officer contacted the occupants, he observed that the passenger was not wearing a safety belt. The officer requested the passenger's identification, and she provided a Wisconsin driver's license. As the officer observed the driver's license and physical descriptors, he noted that the driver's license photograph and descriptors did not match the passenger. The officer questioned the driver separately about the passenger's identity, and the driver admitted that the passenger provided a fake identification. The driver provided the passenger's name, and the officer was able to confirm the passenger's identity. The officer took the passenger into custody for obstructing police. The passenger was found to have a valid warrant for her arrest through Wisconsin Community Corrections. Another officer conducted a search of the passenger following the arrest and located two plastic bags containing a white powder substance and a yellow/brown substance. The substances will be sent to the Crime Lab for testing. The passenger was transported to Froedtert Menomonee Falls Hospital for drug withdrawal symptoms. Upon being medically cleared, the passenger was booked and turned over to the Waukesha County Jail.
