



Menomonee Falls Police Department Notable Incidents for the Month of October 2025

25-025568 10-4-2025 Warrant, Possession of a Controlled Substance – Marijuana

Appleton Ave/Parkway Dr

An officer conducted a traffic stop for a vehicle registration violation. The driver of the vehicle was found to have two warrants for his arrest. While speaking with the driver, the officer detected the odor of marijuana emanating from the vehicle and conducted a probable cause search. The officer located marijuana inside the vehicle, although the driver claimed it did not belong to him. The officer also learned that the driver was operating a motor vehicle without a valid driver's license and was cited for the same offense within the past three years, which resulted in the driver being issued a state misdemeanor traffic citation for this violation. The driver was arrested, booked, and transported to the Waukesha County Jail.

25-025608 10-4-2025 Burglary

Officers were dispatched to a residence for the report of a burglary. The victim reported that they observed forced entry into their residence and discovered items missing. A Field Evidence Technician and Detective responded to the scene to investigate. The investigation is ongoing.

25-025706 10-5-2025 Assist Other Agency, Suspicious Gunshot Wound

Ascension Hospital

Officers were dispatched to Ascension Hospital for the report of a walk-in patient with a gunshot wound. As officers arrived, they observed a vehicle parked in the lot with several bullet holes. Officers interviewed the patient and determined the shooting occurred in the City of Milwaukee. The City of Milwaukee Police Department was contacted and responded to take over the investigation.

25-025723 10-6-2025 Resisting/Obstructing Police – Causing Injury to an Officer, Warrant Arrest

On Saturday, October 4, 2025, the Washington County Sheriff's Department was involved in a vehicle pursuit that traveled through Menomonee Falls. The operator, believed to be the registered owner and having a warrant for drug trafficking, was not apprehended at that time. A Menomonee Falls officer checked various FLOCK cameras for the suspect vehicle and discovered that the vehicle travels into Menomonee Falls regularly. On Monday, October 6, 2025, officers returned to the area where the suspect vehicle was captured on the FLOCK camera

and after checking nearby businesses, located the suspect vehicle parked in a business parking lot, unoccupied. Officers entered the business and learned the wanted suspect was an employee of the business. As officers approached the suspect, he fled on foot. Officers pursued the suspect through the business and into the parking lot, where the suspect attempted to return to his vehicle. Another officer intercepted the suspect at his vehicle and deployed a conducted electronic weapon (CEW), as the suspect produced a box cutter knife and resisted officers. Officers were able to take the suspect into custody; however, one of the arresting officers was injured during the altercation. The suspect was transported to Ascension Hospital for medical clearance before being turned over to the Waukesha County Jail.

25-025817 10-6-2025 Operating While Intoxicated – 6th Offense

N84W15900 Menomonee Ave

Officers were dispatched to check the welfare of a possible intoxicated woman who told the reporting person that someone was chasing her. The reporting person observed that the woman's vehicle appeared to be disabled in the grass of an apartment complex courtyard. As officers arrived in the area, they located the woman seated in the driver's seat of the vehicle. Officers identified the driver and detected the odor of intoxicants emanating from her person. The driver exited the vehicle and performed standardized field sobriety tests, and several more clues were observed. The driver provided a preliminary breath test (PBT), which returned at .136. The driver was arrested for operating while intoxicated – 6th offense. The driver was conveyed to Froedtert Menomonee Falls Hospital for a consensual blood draw. After the blood draw, the driver was booked at the Menomonee Falls Police Department and conveyed to the Waukesha County Jail.

25-026060 10-9-2025 Theft – Business Setting

W124N8100 HWY 145

Officers were dispatched to a gas station for the report of possible theft by an employee. Officers learned that a clerk employed at the gas station was observed on video surveillance pocketing money during numerous transactions. Officers confronted the clerk, who admitted to the thefts. The clerk also stated that some of the stolen money was in his vehicle, which officers were able to recover. The clerk was arrested, booked at the Menomonee Falls Police Department, and transported to the Waukesha County Jail.

25-026846 10-19-2025 Operating While Intoxicated – 2nd Offense

Pilgrim Rd/Belleview Blvd

An officer came upon a vehicle stopped in the lane of traffic. The officer observed the vehicle's brake lights were illuminated, and the vehicle was stopped in front of a sign indicating "No Parking". The officer attempted contact with the driver and discovered the motorist appeared to be sleeping. The officer knocked on the window, and the driver woke up. As the driver rolled down the window and began speaking with the officer, the officer detected the odor of intoxicants emanating from within the vehicle, and the driver displayed signs of possible impairment. The driver admitted to drinking alcohol recently, however refused to perform any standardized field sobriety tests. The driver was arrested for operating while intoxicated – 2nd offense and transported to the Menomonee Falls Police Department for booking. The driver refused to provide an evidentiary chemical test of his breath, and the officer drafted a search warrant for the collection of his blood. The warrant was reviewed by a Waukesha County Judge, who signed the warrant and returned it to the officer to execute. The driver was transported to Froedtert Menomonee Falls Hospital, where a Froedtert staff member collected two vials of the driver's blood without incident. The driver was returned to the Menomonee Falls Police Department to complete the booking process. The driver was issued a state citation for operating while intoxicated – 2nd offense, and released to a sober adult.

25-027223 10-22-2025 Operating While Intoxicated – 5th Offense

Main St/Executive Parkway

An officer conducted a traffic stop of a vehicle driving without any headlights or taillights illuminated during the hours of darkness, and violated a red traffic signal. As the officer contacted the driver, the officer detected signs of possible impairment. The driver performed standardized field sobriety tests, where more signs of impairment were observed. The officer took the driver into custody for operating while intoxicated -5th offense. During a search of the driver's person, the officer located a concealed knife, which the driver was prohibited from possessing due to being a convicted felon. The driver was transported to Froedtert Menomonee Falls Hospital, where the driver refused to provide an evidentiary test of their blood. The officer submitted and received a signed search warrant from a Waukesha County Judge, and a Froedtert staff member conducted the blood draw. The driver was transported to the Menomonee Falls Police Department for booking. After the booking procedures, the driver was turned over to the Waukesha County Jail.

25-027512 10-25-2025 Warrant Arrest, Carrying a Concealed Weapon, Possession of Fentanyl, Marijuana, and Drug Paraphernalia, and Possession of Stolen Property

Interstate 41/County Line Rd

An officer conducted a traffic stop for a window tint violation. Upon contacting the occupants of the vehicle, the officer detected the odor of marijuana emanating from the vehicle, and the officer requested backup to assist with the investigation. The officer learned that the driver had a valid arrest warrant through the Las Vegas Metropolitan Police Department. The officers had the driver exit the vehicle and arrested the driver for the active warrant. The officers searched the driver and located a bag of marijuana, fentanyl, and drug paraphernalia on his person. As officers continued the investigation, the passenger was discovered to have a stolen firearm. The firearm was reported stolen by the City of Milwaukee Police Department. The passenger admitted ownership of the firearm and that they did not possess a CCW permit to possess. Both occupants were arrested; however, the driver began displaying signs of a possible drug overdose and was transported to Ascension Hospital for treatment. The passenger was booked at the Menomonee Falls Police Department and released from custody. The driver was booked and transported to the Waukesha County Jail. Charges are being referred to the Waukesha County District Attorney's Office for charging consideration.

25-027516 10-26-2025 Possession of Psilocybin

W160N6000 Edgemont Dr

Officers were dispatched to a residence for the report of an adult experiencing a hallucinogenic episode after consuming psychedelic mushrooms. Officers discovered psilocybin present in the residence, and the individual was transported to Froedtert Menomonee Falls Hospital for treatment. The individual was medically cleared, booked, and released from custody. Charges will be referred to the Waukesha County District Attorney's Office for a charging determination.

25-027670 10-27-2025 Possession of Marijuana, Cocaine, Fentanyl, and Drug Paraphernalia, Resisting Arrest, Bail Jumping

Officers were dispatched to the parking lot of Planet Fitness for the report of a person possibly overdosing in a vehicle. Officers arrived and observed a person unresponsive in a vehicle with a THC vape pen in plain view. An officer opened the door to render aid, and the occupant regained consciousness. The occupant refused to answer questions and physically resisted officers during the arrest for the drug law violation. A search of the vehicle revealed cocaine and fentanyl. The occupant was booked at the Menomonee Falls Police Department and transported to the Waukesha County Jail.
