Purpose

This annual report complies with the New Housing Fee Report requirements outlined in Section 66.10014 of the Wisconsin Statutes – which reads:

- (1) In this section, “municipality” means a city or village with a population of 10,000 or more.*
- (2) Not later than January 1, 2020, a municipality shall prepare a report of the municipality’s residential development fees. The report shall contain all of the following:*
 - (a) Whether the municipality imposes any of the following fees or other requirements for purposes related to residential construction, remodeling, or development and, if so, the amount of each fee:*
 - 1. Building permit fee.*
 - 2. Impact fee.*
 - 3. Park fee.*
 - 4. Land dedication or fee in lieu of land dedication requirement.*
 - 5. Plat approval fee.*
 - 6. Storm water management fee.*
 - 7. Water or sewer hook-up fee.*
 - (b) The total amount of fees under par. (a) that the municipality imposed for purposes related to residential construction, remodeling, or development in the prior year and an amount calculated by dividing the total amount of fees under this paragraph by the number of new residential dwelling units approved in the municipality in the prior year.*
- (3)*
 - (a) A municipality shall post the report under sub. (2) on the municipality’s Internet site on a web page dedicated solely to the report and titled “New Housing Fee Report.” If a municipality does not have an Internet site, the county in which the municipality is located shall post the information under this paragraph on its Internet site on a web page dedicated solely to development fee information for the municipality.*
 - (b) A municipality shall provide a copy of the report under sub. (2) to each member of the governing body of the municipality.*
- (4) If a fee or the amount of a fee under sub. (2) (a) is not properly posted as required under sub. (3) (a), the municipality may not charge the fee.*

Process and Data Sources

This report was prepared by Village staff for the 2024 calendar year (January 1 – December 31) using the Village of Menomonee Falls Fee Schedule, and permit records. This report has been posted on the Village website (www.menomonee-falls.org), and it is shared annually with the Village of Menomonee Falls Plan Commission and Village Board.

Total Amount of Residential Fees Collected and New Residential Dwelling Units Permitted in 2024

The total amount of fees collected in 2024 relating to residential construction, remodeling, and development was **\$5,493,960.87**.

In 2024, the Village approved 143 single family homes, 80 two-family residences, and 223 multi-family dwelling units – for a total of **446 new residential dwelling units**.

Thus, in 2024 the fees related to residential construction, remodeling and development averaged **\$12,318.30 per dwelling unit**. However, since this figure includes money received for residential remodeling, additions and other property improvements such as decks, sheds and swimming pools, it does not represent the average amount of fees collected for a new dwelling unit in the Village of Menomonee Falls. The average amount of fees collected for each new dwelling in 2024 is a substantially smaller figure.

Notes:

1. Electric, HVAC and Plumbing permit fees are charged, but are based upon the number of fixtures/items. Therefore, the specific design of a new dwelling determines the permit fee to be charged. Wis. Stat. 66.10014 does not require reporting of Electrical, HVAC or Plumbing permit fees.
2. Permits for new dwellings are typically issued for lots in subdivisions that were approved and constructed in prior years.
