



## Menomonee Falls Police Department Notable Incidents for the Month of December 2025

**Case(s): 25-030734      Date: 12/02/2025**

**Description: Felony Retail Theft, Possession of Marijuana and Posses. Drug Paraphernalia**

**Address(es): N95W18000 Appleton Ave**

Officers were dispatched to a retail theft in progress at Kohl's Department Store. The suspect fled eastbound on County Line Rd., where a traffic stop was conducted. During the traffic stop, the stolen merchandise was observed in the back seat in plain view. The subject subsequently admitted to the theft and was taken into custody. During the arrest, officers located a THC vape pen on the subject's person. The subject also had a valid warrant for their arrest for Operating Without a License - 2<sup>nd</sup> Offense with the Washington County Sheriff's Office. The subject was booked at the Menomonee Falls Police Department, provided a written statement, and transported to Waukesha County Jail. Charges were referred for felony Retail Theft, misdemeanor Possession of Drug Paraphernalia, and misdemeanor Possession of THC to the Waukesha County District Attorney's Office for review. The subject also received a state citation for Operating Without a License - 2nd Offense.

**Description: Felony Burglary from a Room within a Building**

Between 12/01/2025 and 12/11/2025, unknown actor(s) used a key to enter five (5) victim rooms at Grace Commons Senior Living Facility without consent and stole property totaling over \$10,000 USD. Management identified two (2) possible suspects. These burglaries remain under investigation by the Menomonee Falls Special Investigations Bureau.

**Description: Felony Retail Theft**

The Wauwatosa Home Depot Loss Prevention contacted the Menomonee Falls Police Department and reported a retail theft from the Menomonee Falls Home Depot store. This report was prompted by a retail theft at the Wauwatosa location, where the Wauwatosa Police Department responded. At the Wauwatosa Home Depot, the Wauwatosa Police Department arrested a subject for retail theft. During the subject's arrest, the Wauwatosa Police Department found over \$1,000 of unpaid merchandise stolen from the Menomonee Falls Home Depot in the subject's possession. The subject was arrested by the Wauwatosa Police Department, refused a statement, and was transported to the Milwaukee County Sheriff's Office Jail. A felony charge of Retail Theft for the incident in Menomonee Falls has been referred to the Waukesha County District Attorney's Office for review.

**Case(s): 25-031425**

**Date: 12/10/2025**

**Description: Hit and Run, OWI, Possession of Crack-Cocaine, Possession of THC, and Possession of Drug Paraphernalia**

**Address(es): 41 Hwy/Main St**

Officers responded to a crash on northbound I-41 involving the subject. The subject fled the scene before officers arrived and was later located by officers at Ascension Hospital. At the hospital, the subject showed indicators of impairment and denied consuming any alcohol or drugs. During identification confirmation, the subject was found to have a revoked driver's license and two prior Operating While Intoxicated charges. While at the hospital, an officer was approached by hospital staff regarding suspected crack cocaine, THC, and drug paraphernalia found in a bathroom recently used by the subject. The subject admitted the items were theirs and they had disposed of them in the hospital bathroom. The subject was arrested for Operating While Intoxicated - 3<sup>rd</sup> Offense. The subject was booked, and bond was posted at the Menomonee Falls Police Department. Charges have been referred to the Waukesha County District Attorney's Office for review.

**Description: Industrial Non-fatal Accident**

Officers responded to a report of an industrial accident where the injured party's hand was caught in a machine. Both the Menomonee Falls Police and Menomonee Falls Fire Departments responded to the scene. The injured party's hand was eventually freed, and he was transported to Froedtert Hospital for medical care by the Menomonee Falls Fire Department.

**Description: Possession of THC and OWI**

**Address(es): 41 Hwy/Pilgrim Rd**

The Menomonee Falls Fire Department (MFFD) and Menomonee Falls Police Department (MFPD) responded to a rollover crash on I-41 SB. The vehicle was located and operated by the subject. The subject was checked for injuries by MFFD and only suffered a small cut on their hand. The subject was transported back to MFPD for sobriety tests, where signs of impairment were observed. They were arrested for Operating While Intoxicated - 1<sup>st</sup> offense. Upon arrest, a green leafy substance was found in their coat pocket and later confirmed to be marijuana. They were booked, issued citations, and transported to the Waukesha County Jail on a 12-hour hold due to being unable to find a sober adult.

**Case(s): 25-032253**      **Date: 12/19/2025**

**Description: OWI and Bail Jumping**

**Address(es): Mill Rd/Lilly Rd**

Officers responded to a vehicle that drove onto a snowbank on Mill Rd. east of Lilly Rd. The driver admitted to consuming intoxicating beverages before operating his motor vehicle. Standard Field Sobriety Tests were conducted, and signs of impairment were observed. The subject was arrested for Operating While Intoxicated - 2<sup>nd</sup> Offense. They consented to a legal blood draw. They were booked at the Menomonee Falls Police Department, cited, and released.

**Description: Felony Bail Jumping and Disorderly Conduct**

Officers were called to Froedtert Menomonee Falls Hospital for a disorderly patient who refused to leave after receiving treatment. The subject continued to be disorderly with officers and threatened to fight and spit on officers. Additionally, the subject had an open felony case in Milwaukee County. The subject was arrested and transported to the Waukesha County Jail without incident.

**Description: Possession of Narcotic Drugs - Heroin & Fentanyl**

Officers dispatched to assist with an EMS call, where it was revealed the subject ingested heroin and was feeling ill. They produced a small bag containing a substance that later tested positive for heroin. The subject was transported to Froedtert Menomonee Falls Hospital and was medically cleared. The Waukesha County Crisis team was contacted and declined to respond. The subject was arrested for Possession of Narcotic Drugs and transported to Waukesha County Jail.

**Case(s): 25-032520 & 25-032533**

**Date: 12/23/2025**

**Description: Felony Theft - Movable Property (>\$10,000), Misdemeanor Battery, Possession of a Firearm by a Felon, Strangulation and Suffocation, Domestic Abuse, and Use of a Dangerous Weapon**

**Address(es): N55W17800 High Bluff Dr**

Officers responded to a domestic dispute where the subject and their cohabitant got into an argument at their shared residence. During the argument, their cohabitant alleged that the subject pulled out a black firearm and hit them on the back of the head without permission, causing pain and discomfort. Resultingly, their cohabitant fled to a friend's residence and later returned to find the shared residence ransacked. Their cohabitant reported \$7,500 in cash, and a custom \$10,000 watch was missing. They advised that they have since been in contact with the subject, who refused to return the items. A CCAP check revealed the subject has several prior felony conviction cases. The whereabouts of the subject are unknown at this time. Charges will be referred to the Waukesha County District Attorney's Office.

**Description: Hit and Run Resulting in Injury**

**Address(es): Main St/41 Hwy**

Officers were dispatched to a hit-and-run crash on Main Street at the on-ramp to southbound I-41. A vehicle driven by the subject struck a vehicle driven by the victim, who was injured in the crash. The subject drove away from the scene without checking on the other driver or notifying the police. The subject was located by police in the area where the crash occurred. The subject was arrested, transported to the Menomonee Falls Police Department, where he was booked, and transported to Waukesha County Jail.

**Description: Weapon Violation, Disorderly Conduct, Strangulation – Domestic Violence**

Officers were dispatched to a domestic violence incident in progress. Upon arrival, officers responded and searched the subject. The subject and victim were in a verbal altercation when the subject grabbed the victim by the throat & used a handgun to rack the slide and hold it against the victim's head. The subject threatened that they would kill the victim and her children if police were called. Later, the victim claimed the subject strangled her, causing her breathing to be restricted. The subject was arrested, refused a statement, and was transported to the Waukesha County Jail. A 72-Hour Contact Prohibition Period was enforced.
