**Accreditation Assessment Team Invites Public Comment**

A team of assessors from the Wisconsin Law Enforcement Accreditation Group (WILEAG), will arrive on February 3, 2026 to examine all aspects of the Menomonee Falls Police Department's policy and procedures, management, operation, and support service. Verification by the team that the Menomonee Falls Police Department meets WILEAG's state-of-the-art standards is part of a voluntary process to gain accreditation. Accreditation status is granted for three years, during which time the agency must submit annual reports attesting continued compliance with those standards under which it was initially accredited.

The assessment team is composed of law enforcement practitioners from other accredited agencies. The assessors will review written material, witness the operations of the department, interview department members, and review procedures. The assessors are: Senior Administrative Specialist Angela Rygielski from the Waukesha County Sheriff's Office; Administrative Assistant Katie Kujawa from the Waukesha Police Department and Background Investigator Kirsten James from the Dodge County Sheriff's Department.

The Menomonee Falls Police Department will seek to comply with the applicable standards specified by WILEAG. The assessors will review written material, interview individuals, and visit offices and the places where compliance can be witnessed. Once the WILEAG assessors complete their review of the agency, they report back to the WILEAG Governing Board, which will then decide if the agency is to be granted accredited status.

As part of the on-site assessment, agency employees and the public are invited to offer comments by calling 262-532-8719 on February 4, 2026 between the hours of 1:00 p.m. and 3:00 p.m. Comments will be taken by the WILEAG Assessment Team assigned to conduct this assessment. Comments are limited to 10 minutes and must address the agency's ability to comply with WILEAG's standards. A copy of the standards is available in the lobby of the Police Department.
