AGREEMENT TO TERMS

The owner, developer, builder, and/or land user shall be in compliance with this permit if he follows an approved erosion control plan and all conditions in accordance with the Erosion Control Ordinance and the WDNR Best Management Practice. The plan must be accepted and inspected by the Village before commencement of any land disturbing activities. The Village reserves the right to require additional measures as necessary during construction. In the case of the builder being the applicant, the owner is also responsible for all conditions of this permit and any damages of noncompliance.

In addition to the conditions of approval, the conditions of this permit are transferred to the new owner and the site must be protected at times and at the time of any inspection and the final inspection. No occupancy will be granted until the site is protected by adequate erosion control measures. Wetlands and any other protect environmental feature will remain protected and not altered. Final landscaping must be completed within the time limits stated in the ordinance and there must be sufficient and permanent grass growth and cover. I acknowledge that failure to comply with any of Sec. 38 of the Municipal Code may result in the issuance of a Municipal Citation and Stop Work Order.

I hereby certify that I fully understand and shall follow all the provisions of the Village of Menomonee Falls Erosion Control Ordinance Sec. 38 and that I accept responsibility for carrying out the erosion control and grading plan for the referenced project, as approved by the Engineering Department. I acknowledge that other permits (Local, State or Federal) may be needed for this project and it is my responsibility as the contractor and/or owner to obtain those permits and approvals. I also acknowledge that the issuance of this Erosion Control Permit does not constitute approvals for other permits.
